- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Forest Tax Relief
- 5 Act".

4	(a) TERMINATION.—On and after the effective date
5	of this section, the Secretary of Agriculture may not im-
6	pose or collect any fee under the authority of the Rec-
7	reational Fee Demonstration Program authorized by sec-
8	tion 315 of the Department of the Interior and Related
9	Agencies Appropriations Act, 1996 (section 101(c) of Pub-
10	lic Law 104–134; 16 U.S.C. 460l–6a note). Amounts col-
11	lected before that date shall continue to be used by the
12	Secretary in the manner provided in that section.
13	(b) Conforming Amendments.—(1) Section 315 of
14	the Department of the Interior and Related Agencies Ap-
15	propriations Act, 1996 (section 101(c) of Public Law 104–
16	134; 16 U.S.C. 460l–6a note), is amended—
