A BILL

To amend chapter 3 of title 28, United States Code, to divide the Ninth Judicial Circuit of the United States into two circuits, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Ninth Circuit Court
- 5 of Appeals Reorganization Act of 2001".
- 6 SEC. 2. NUMBER AND COMPOSITION OF CIRCUITS.
- 7 Section 41 of title 28, United States Code, is
- 8 amended—
- 9 (1) in the matter before the table, by striking
- "thirteen" and inserting "fourteen"; and

15	SEC. 4. PLACES OF CIRCUIT COURT.
16	The table in section 48(a) of title 28, United States
17	Code, is amended—

3	SEC. 5. ASSIGNMENT OF CIRCUIT JUDGES.
4	Each circuit judge in regular active service of the
5	former ninth circuit whose official station on the day be-
6	fore the effective date of this Act—
7	(1) is in Arizona, California, or Nevada is as-
8	signed as a circuit judge of the new ninth circuit;
9	and
10	(2) is in Alaska, Guam, Hawaii, Idaho, Mon-
11	tana, Northern Mariana Islands, Oregon, or Wash-
12	ington is assigned as a circuit judge of the twelfth
13	circuit.
14	SEC. 6. ELECTION OF ASSIGNMENT BY SENIOR JUDGES.
15	Each judge who is a senior judge of the former ninth
16	circuit on the day before the effective date of this Act may
17	elect to be assigned to the new ninth circuit or to the
18	twelfth circuit and shall notify the Director of the Admin-
19	istrative Office of the United States Courts of such elec-
20	tion.
21	SEC. 7. SENIORITY OF JUDGES.
22	The seniority of each judge—
23	(1) who is assigned under section 5 of this Act;
24	or

- 1 (2) who elects to be assigned under section 6 of
- 2 this Act;
- 3 shall run from the date of commission of such judge as
- 4 a judge of the former ninth circuit.

5 SEC. 8. APPLICATION TO CASES.

- 6 The provisions of the following paragraphs of this
- 7 section apply to any case in which, on the day before the
- 8 effective date of this Act, an appeal or other proceeding
- 9 has been filed with the former ninth circuit:
- 10 (1) If the matter has been submitted for deci-11 sion, further proceedings in respect of the matter 12 shall be had in the same manner and with the same
- effect as if this Act had not been enacted.
- 14 (2) If the matter has not been submitted for de-15 cision, the appeal or proceeding, together with the 16 original papers, printed records, and record entries 17 duly certified, shall, by appropriate orders, be trans-18 ferred to the court to which the matter would have 19 been submitted had this Act been in full force and 20 effect at the time such appeal was taken or other 21 proceeding commenced, and further proceedings in 22 respect of the case shall be had in the same manner

1 (3) A petition for rehearing or a petition for re-2 hearing en banc in a matter decided before the effec-3 tive date of this Act, or submitted before the effective date of this Act and decided on or after the effective date as provided in paragraph (1), shall be 6 treated in the same manner and with the same effect 7 as though this Act had not been enacted. If a peti-8 tion for rehearing en banc is granted, the matter 9 shall be reheard by a court comprised as though this 10 Act had not been enacted.

11 SEC. 9. DEFINITIONS.

- In this Act, the term—
- 13 (1) "former ninth circuit" means the ninth ju-14 dicial circuit of the United States as in existence on 15 the day before the effective date of this Act;
- 16 (2) "new ninth circuit" means the ninth judicial 17 circuit of the United States established by the 18 amendment made by section 2(2)(A); and
- 19 (3) "twelfth circuit" means the twelfth judicial 20 circuit of the United States established by the 21 amendment made by section 2(2)(B).

22 SEC. 10. ADMINISTRATION.

The court of appeals for the ninth circuit as con-24 stituted on the day before the effective date of this Act 25 may take such administrative action as may be required

- 1 to carry out this Act and the amendments made by this
- 2 Act. Such court shall cease to exist for administrative pur-
- 3 poses on July 1, 2003.
- 4 SEC. 11. EFFECTIVE DATE.
- 5 This Act and the amendments made by this Act shall
- 6 become effective on October 1, 2001.
