## A BILL

To expand the boundary of the Booker T. Washington  
National Monument, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Booker T. Washington  
5 National Monument Boundary Adjustment Act of 2001”.

1 **SEC. 2. BOUNDARY OF BOOKER T. WASHINGTON NATIONAL**  
2 **MONUMENT EXPANDED.**

3 The Act entitled “An Act to provide for the establish-  
4 ment of the Booker T. Washington National Monument”,  
5 approved April 2, 1956 (16 U.S.C. 450*ll* et seq.), is  
6 amended by adding at the end the following new section:

7 **“SEC. 5. ADDITIONAL LANDS.**

8 “(a) LANDS ADDED TO MONUMENT.—The boundary  
9 of the Booker T. Washington National Monument is modi-  
10 fied to include the approximately 15 acres, as generally  
11 depicted on the map entitled “Boundary Map, Booker T.  
12 Washington National Monument, Franklin County, Vir-  
13 ginia”, numbered BOWA 404/80,024, and dated February  
14 2001. The map shall be on file and available for inspection  
15 in the appropriate offices of the National Park Service,  
16 Department of the Interior.

17 “(b) ACQUISITION OF ADDITIONAL LANDS.—The  
18 Secretary of the Interior is authorized to acquire from  
19 willing owners the land or interests in land described in  
20 subsection (a) by donation, purchase with donated or ap-  
21 propriated funds, or exchange.

22 “(c) ADMINISTRATION OF ADDITIONAL LANDS.—  
23 Lands added to the Booker T. Washington National  
24 Monument by subsection (a) shall be administered by the  
25 Secretary of the Interior as part of the monument in ac-  
26 cordance with applicable laws and regulations.”.
