A BILL

To amend title 38, United States Code, to provide for grants to repair veterans memorials.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. GRANTS TO REPAIR VETERANS MEMORIALS.
- 4 (a) Establishment of Grant Program.—Chapter
- 5 24 of title 38, United States Code, is amended by adding
- 6 at the end the following new section:
- 7 "\$ 2412 Grants to repair memorials
- 8 "(a) Establishment of Grant Program.—Sub-
- 9 ject to the succeeding provisions of this section, the Sec-
- 10 retary may make grants to a State or a qualified organiza-

- 1 tion for the purpose of repairing or restoring a covered
- 2 memorial.
- 3 "(b) APPLICATION.—A grant under this section may
- 4 be made only upon submission of an application to the
- 5 Secretary in such form and manner, and containing such
- 6 information, as the Secretary may require.
- 7 "(c) Amount of Grant.—(1) The amount of a
- 8 grant under this section may not exceed 50 percent of the
- 9 cost of the repair or restoration of the covered memorial,
- 10 as determined by the Secretary.
- 11 "(2) The recipient of the grant shall contribute the
- 12 excess of the aggregate costs of the repair of the covered
- 13 memorial over the grant.
- 14 "(3) If a recipient of a grant under this section uses
- 15 any part of the funds provided through such grant for a
- 16 purpose other than that for which the grant was made,
- 17 the United States shall be entitled to recover from such
- 18 recipient the total of all grants made under this section
- 19 to such recipient in connection with the repair or restora-
- 20 tion of the covered memorial.
- 21 "(d) Use of Grant Funds.—Sums received pursu-
- 22 ant to a grant in this section shall be used for the sole
- 23 purpose of repairing or restoring a covered memorial.
- 24 "(e) Standards.—A repair or restoration of a cov-
- 25 ered memorial under a grant under this section shall con-

- 1 form to such standards and guidelines as the Secretary
- 2 may by regulation prescribe.
- 3 "(f) Additional Terms and Conditions.—The
- 4 Secretary may by regulation prescribe such additional
- 5 terms and conditions for grants under this section as the
- 6 Secretary considers appropriate.
- 7 "(g) Definitions.—In this section:
- 8 "(1) The term 'qualified organization' means
- 9 any organization described in section 5902(a) of this
- title.
- 11 "(2) The term 'covered memorial' means a me-
- morial or monument that the Secretary determines
- commemorates the service in the Armed Forces of
- an individual, or group of individuals, or a particular
- military event, but does not include any memorial or
- 16 monument under the administrative jurisdiction of
- 17 the Secretary of the Interior.
- 18 "(h) Authorization of Appropriations.—(1)
- 19 There is authorized to be appropriated such sums as may
- 20 be necessary for fiscal year 2002 and for each succeeding
- 21 fiscal year through fiscal year 2006 for the purpose of
- 22 making grants under subsection (a).
- 23 "(2) Sums appropriated under paragraph (1) of this
- 24 section shall remain available until expended. If all funds
- 25 from a grant under this section have not been utilized by

- 1 a recipient for the purpose for which the grant was made
- 2 within three years after such grant is made, the United
- 3 States shall be entitled to recover any such unused grant

4 funds from such recipient.".
