A BILL

To amend title 38, United States Code, to provide the Secretary of Veterans Affairs authority to furnish certain benefits for certain diseases occurring in children of Vietnam-era veterans upon a determination that such diseases have a positive association with parental exposure to a herbicide agent.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Vietnam Veterans
- 5 Children's Disability Act".

1	SEC. 2. AUTHORITY TO PROVIDE BENEFITS FOR CHILDREN
2	OF VIETNAM VETERANS WITH CERTAIN DIS-
3	EASES ASSOCIATED WITH PARENTAL EXPO-
4	SURE TO HERBICIDE AGENTS.
5	(a) Amendments to New Chapter 18.—The
6	amendments made by this section are made to chapter 18
7	of title 38, United States Code, as amended by section
8	401 of the Veterans Benefits and Health Care Improve-
9	ment Act of 2000 (Public Law 106–419; 114 Stat. 1857),
10	and take effect on—
11	(1) December 1, 2001 (the effective date of
12	those amendments); or
13	(2) if later, the date of the enactment of this
14	Act.
15	(b) Benefits for Certain Children.—(1) Chap-
16	ter 18 of title 38, United States Code, is amended by add-
17	ing at the end the following new subchapter:
18	"SUBCHAPTER IV—CHILDREN OF VIETNAM
19	VETERANS WITH DISEASES ASSOCIATED
20	WITH PARENTAL EXPOSURE TO HERBICIDE
21	AGENTS
22	"§ 1831. Definitions
23	In this subchapter:
24	"(1) The term 'eligible child' means an indi-
25	vidual, regardless of age or marital status, who—
26	"(A) is the natural child of—

1	"(i) a Vietnam veteran; or
2	"(ii) a veteran other than a Vietnam
3	veteran who, as determined under regula-
4	tions prescribed by the Secretary, was ex-
5	posed before the child was conceived to
6	herbicides during active military, naval, or
7	air service; and
8	"(B) has one or more covered diseases.
9	"(2) The term 'covered disease' means a disease
10	identified by the Secretary under section 1832 of
11	this title.
12	"§ 1832. Covered diseases
13	"(a) IDENTIFICATION.—The Secretary shall by regu-
14	lation identify diseases occurring in children that have a
15	positive association with parental exposure to an herbicide
16	agent before the date on which the child was conceived.
17	"(b) DISEASES TO BE INCLUDED.—The Secretary
18	shall include acute myelogenous leukemia in the diseases
19	identified under subsection (a).
20	"§ 1833. Health care
21	"(a) Needed Care.—The Secretary shall provide an
22	eligible child such health care as the Secretary determines
23	is needed by the child for that child's covered diseases or
24	any disability that is associated with those diseases.

- 1 "(b) Authority for Care To Be Provided Di-
- 2 RECTLY OR BY CONTRACT.—The Secretary may provide
- 3 health care under this section directly or by contract or
- 4 other arrangement with a health care provider.
- 5 "(c) Definitions.—For purposes of this section, the
- 6 definitions in section 1803(c) of this title shall apply with
- 7 respect to the provision of health care under this section,
- 8 except that for such purposes—
- 9 "(1) the reference to 'specialized spina bifida
- clinic' in paragraph (2) of that section shall be treat-
- ed as a reference to a specialized clinic treating the
- disease concerned under this section; and
- 13 "(2) the reference to 'vocational training under
- section 1804 of this title' in paragraph (8) of that
- section shall be treated as a reference to vocational
- training under section 1834 of this title.

17 "§ 1834. Vocational training

- 18 "(a) AUTHORITY.—The Secretary may provide a pro-
- 19 gram of vocational training to an eligible child if the Sec-
- 20 retary determines that the achievement of a vocational
- 21 goal by the child is reasonably feasible.
- 22 "(b) Applicable Provisions.—Subsections (b)
- 23 through (e) of section 1804 of this title shall apply with
- 24 respect to any program of vocational training provided
- 25 under subsection (a).

l "§ 1835. Monetary allowance

- 2 "(a) Monetary Allowance.—The Secretary shall
- 3 pay a monthly allowance to an eligible child for any dis-
- 4 ability resulting from a covered disease.
- 5 "(b) Schedule for Rating Disabilities.—(1)
- 6 The amount of the monthly allowance paid under this sec-
- 7 tion shall be based on the degree of disability suffered by
- 8 the child concerned, as determined in accordance with a
- 9 schedule for rating disabilities resulting from covered dis-
- 10 eases that is prescribed by the Secretary.
- 11 "(2) In prescribing a schedule for rating disabilities
- 12 for the purposes of this section, the Secretary shall estab-
- 13 lish the levels of disability upon which the amount of the
- 14 allowance provided by this section shall be based. The lev-
- 15 els of disability established may take into account func-
- 16 tional limitations, including limitations on cognition, com-
- 17 munication, motor abilities, activities of daily living, and
- 18 employability.
- 19 "(c) Amount of Monthly Allowance.—(1) The
- 20 Secretary shall prescribe the amount of the monthly allow-
- 21 ance paid under this section for each level of disability
- 22 established in the schedule of rating disabilities prescribed
- 23 under subsection (b), except that an allowance under this
- 24 section—
- 25 "(A) may not be less than the amount in effect
- under section 1815(c)(1) of this title; and

- 1 "(B) may not be greater than the amount in ef-
- 2 fect under section 1815(c)(4) of this title.
- 3 "(2)(A) Benefits under this subchapter may be dis-
- 4 continued six months after the child has recovered fully
- 5 from the disability.
- 6 "(B) For purposes of this paragraph, the term
- 7 'fully recovered from the disability' means that no
- 8 signs or symptoms of disability are present and no
- 9 treatment for the disability is warranted.
- 10 "(3) Benefits under this subchapter may be
- paid for any secondary disability which results from
- any disability associated with exposure to a herbicide
- or any disability resulting from treatment for such
- 14 disability.
- 15 "(d) Indexing to Social Security Benefit In-
- 16 CREASES.—Amounts paid under subsection (c) shall be
- 17 subject to adjustment from time to time under section
- 18 5312 of this title.".
- 19 (2) The table of sections at the beginning of such
- 20 chapter is amended by adding at the end the following:
