## A BILL

To amend section 507 of the Omnibus Parks and Public Lands Management Act of 1996 to authorize additional appropriations for historically black colleges and universities, to decrease the matching requirement related to such appropriations, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DECREASED MATCHING REQUIREMENT; AU-**  
 4 **THORIZATION OF APPROPRIATIONS.**

5        *(a) DECREASED MATCHING REQUIREMENT.—Section*  
 6 *507(c) of the Omnibus Parks and Public Lands Manage-*  
 7 *ment Act of 1996 (16 U.S.C. 470a note) is amended—*

8            *(1) by striking “(1) Except” and inserting the*  
 9 *following:*

10            *“(1) IN GENERAL.—Except”;*

11            *(2) by striking “paragraph (2)” and inserting*  
 12 *“paragraphs (2) and (3)”;*

13            *(3) by striking “(2) The Secretary” and insert-*  
 14 *ing the following:*

15            *“(2) WAIVER.—The Secretary”;*

16            *(4) by striking “paragraph (1)” and inserting*  
 17 *“paragraphs (1) and (3)”;* and

1           (5) *by adding at the end the following new para-*  
2 *graph:*

3           “(3) *EXCEPTION.—The Secretary may obligate*  
4 *funds made available under subsection (d)(2) for a*  
5 *grant with respect to a building or structure listed on,*  
6 *or eligible for listing on, the National Register of His-*  
7 *toric Places only if the grantee agrees to provide, from*  
8 *funds derived from non-Federal sources, an amount*  
9 *that is equal to 30 percent of the total cost of the*  
10 *project for which the grant is provided.”.*

11          (b) *AUTHORIZATION OF APPROPRIATION.—Section*  
12 *507(d) of the Omnibus Parks and Public Lands Manage-*  
13 *ment Act of 1996 (16 U.S.C. 470a note) is amended—*

14           (1) *by striking “Pursuant to” and inserting the*  
15 *following:*

16           “(1) *1996 AUTHORIZATION.—Pursuant to*”;

17           (2) *by adding at the end the following new para-*  
18 *graph:*

19           “(2) *ADDITIONAL AUTHORIZATION.—In addition*  
20 *to amounts made available under paragraph (1), pur-*  
21 *suant to section 108 of the National Historic Preser-*  
22 *vation Act, there is authorized to be appropriated*  
23 *such sums as may be necessary to carry out the pur-*  
24 *poses of this section.”.*
