Mr. PETRI (for himself, Mr. MCHUGH, Mr. HORN, and Mr. SMITH of Texas) introduced the following bill; which was referred to the Committee on Ways and Means

A BILL

To establish a commission to study and make recommendations on marginal tax rates for the working poor.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Poverty Trap Study

5 Act of 2001".

6 SEC. 2. FINDINGS.

- 7 Congress finds the following:
- 8 (1) Low income people are subject to many
 9 taxes, including the Federal income tax, payroll
 10 taxes, and State income taxes. In addition, eligibility

1 for many Federal and State programs for assistance 2 to the working poor, such as the earned income tax 3 credit, food stamps, housing assistance programs, 4 medicaid, child care assistance, and the women, in-5 fants, and children (WIC) nutrition program is 6 based in part on income levels. The rates at which 7 the benefits from such programs are phased out have the same effect as additional taxes imposed on 8 the beneficiaries. 9

10 (2) The total effective marginal rate of tax for 11 additional income earned by low income people can 12 exceed 100 percent and can be a disincentive to 13 working more hours, getting a raise, learning a more 14 lucrative trade, getting married, or engaging in 15 other economic or social activities.

16 SEC. 3. NATIONAL COMMISSION ON MARGINAL TAX RATES

- FOR THE WORKING POOR.

(a) ESTABLISHMENT.—There is established a commission to be known as the National Commission on Marginal Tax Rates for the Working Poor (in this section referred to as the "Commission").

(b) DUTIES OF THE COMMISSION.—The Commission23 shall—

(1) determine the total effective marginal rateof tax from all taxes and benefit program phaseouts

| 12 | (2) recommendations for resolving any economic |
| 13 | and other disincentives found by the Commission |
| 14 | caused by the marginal tax rates to which the work- |
| 15 | ing poor are subject. |
| 16 | (g) TERMINATION.—The Commission shall terminate |
| 17 | 30 days after the date of submission of the report required |
| 18 | in subsection (f). Section $14(a)(2)(B)$ of the Federal Advi- |
| 19 | sory Committee Act shall not apply to the Commission. |
| 20 | (h) LIMITATIONS ON AUTHORIZATION OF APPRO- |
| 21 | PRIATIONS.—There are authorized to be appropriated not |
| 22 | more than \$900,000 to carry out this section. |
