## A BILL

To amend title 18, United States Code, to provide that certain sexual crimes against children are predicate crimes for the interception of communications, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Child Sex Crimes  
5 Wiretapping Act of 2001”.

6 **SEC. 2. AUTHORIZATION OF INTERCEPTION OF COMMU-**  
7 **NICATIONS IN THE INVESTIGATION OF SEX-**  
8 **UAL CRIMES AGAINST CHILDREN.**

9 (a) CHILD PORNOGRAPHY.—Section 2516(1)(c) of  
10 title 18, United States Code, is amended by inserting “sec-  
11 tion 2252A (relating to material constituting or containing  
12 child pornography),” after “2252 (sexual exploitation of  
13 children),”.

14 (b) TRANSPORTATION FOR ILLEGAL SEXUAL ACTIV-  
15 ITY.—Section 2516(1) of title 18, United States Code, as  
16 amended by section 3 of this Act, is amended—

17 (1) by striking “or” at the end of paragraph  
18 (o);

19 (2) by inserting after paragraph (o) the fol-  
20 lowing:

21 “(p) a violation of section 2422 (relating to  
22 coercion and enticement) or section 2423 (relat-  
23 ing to transportation of minors) of this title, if,  
24 in connection with that violation, the sexual ac-  
25 tivity for which a person may be charged with

1 a criminal offense would constitute a felony of-  
2 fense under chapter 109A or 110, if that activ-  
3 ity took place within the special maritime and  
4 territorial jurisdiction of the United States; or”;  
5 and

8 **SEC. 3. TECHNICAL AMENDMENT ELIMINATING DUPLICA-**  
9 **TIVE PROVISION.**

10 Section 2516(1) of title 18, United States Code, is  
11 amended—

12 (1) by striking the first paragraph ~~(p)~~; and

13 (2) by inserting “or” at the end of paragraph  
14 ~~(o)~~.

15 **SECTION 1. SHORT TITLE.**

16 *This Act may be cited as the “Child Sex Crimes Wire-*  
17 *tapping Act of 2002”.*

18 **SEC. 2. AUTHORIZATION OF INTERCEPTION OF COMMU-**

21 (a) *IN GENERAL.*—Section 2516(1)(c) of title 18,

23 (1) *by striking “2251 and 2252” and inserting*  
24 *“2251, 2251A, 2252, and 2252A”; and*

1           (2) by inserting “section 2423(b) (relating to  
2           travel with intent to engage in a sexual act with a  
3           juvenile),” after “motor vehicle parts),”.

4           (b) *TRANSPORTATION FOR ILLEGAL SEXUAL ACTIV-*  
5 *ITY.*—Section 2516(1) of title 18, United States Code, is  
6 amended—

7           (1) by striking “or” at the end of paragraph (q);

8           (2) by inserting after paragraph (q) the fol-  
9           lowing:

10           “(r) a violation of section 2422 (relating to coer-  
11           cion and enticement) and section 2423(a) (relating to  
12           transportation of minors) of this title, if, in connec-  
13           tion with that violation, the intended sexual activity  
14           would constitute a felony violation of chapter 109A or  
15           110, including a felony violation of chapter 109A or  
16           110 if the sexual activity occurred, or was intended  
17           to occur, within the special maritime and territorial  
18           jurisdiction of the United States, regardless of where  
19           it actually occurred or was intended to occur; or”;  
20           and

21           (3) by redesignating paragraph (r) as paragraph
