## A BILL

To make clerical and other technical amendments to title 18, United States Code, and other laws relating to crime and criminal procedure.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Criminal Law Tech-  
3 nical Amendments Act of 2001”.

4 **SEC. 2. TECHNICAL AMENDMENTS RELATING TO CRIMINAL**  
5 **LAW AND PROCEDURE.**

6 (a) MISSING AND INCORRECT WORDS.—

7 (1) CORRECTION OF GARBLED SENTENCE.—

8 Section 510(c) of title 18, United States Code, is  
9 amended by striking “fine of under this title” and  
10 inserting “fine under this title”.

11 (2) INSERTION OF MISSING WORDS.—Section

12 981(d) of title 18, United States Code, is amended  
13 by striking “proceeds from the sale of this section”  
14 and inserting “proceeds from the sale of such prop-  
15 erty under this section”.

16 (3) CORRECTION OF INCORRECT WORD.—Sec-

17 tions 1425 through 1427, 1541 through 1544 and  
18 1546(a) of title 18, United States Code, are each  
19 amended by striking “to facility” and inserting “to  
20 facilitate”.
