A BILL

To protect infants who are born alive.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Born-Alive Infants
- 5 Protection Act of 2001".
- 6 SEC. 2. DEFINITION OF BORN-ALIVE INFANT.
- 7 (a) In General.—Chapter 1 of title 1, United
- 8 States Code, is amended by adding at the end the fol-
- 9 lowing:
- 10 "§ 8. 'Person', 'human being', 'child', and 'individual'
- 11 as including born-alive infant
- 12 "(a) In determining the meaning of any Act of Con-
- 13 gress, or of any ruling, regulation, or interpretation of the
- 14 various administrative bureaus and agencies of the United
- 15 States, the words 'person', 'human being', 'child', and 'in-
- 16 dividual', shall include every infant member of the species
- 17 homo sapiens who is born alive at any stage of develop-
- 18 ment.

- 1 "(b) As used in this section, the term 'born alive',
- 2 with respect to a member of the species homo sapiens,
- 3 means the complete expulsion or extraction from his or
- 4 her mother of that member, at any stage of development,
- 5 who after such expulsion or extraction breathes or has a
- 6 beating heart, pulsation of the umbilical cord, or definite
- 7 movement of voluntary muscles, regardless of whether the
- 8 umbilical cord has been cut, and regardless of whether the
- 9 expulsion or extraction occurs as a result of natural or
- 10 induced labor, cesarean section, or induced abortion.
- 11 "(c) Nothing in this section shall be construed to af-
- 12 firm, deny, expand, or contract any legal status or legal
- 13 right applicable to any member of the species homo sapi-
- 14 ens at any point prior to being 'born alive' as defined in
- 15 this section.".
- 16 (b) CLERICAL AMENDMENT.—The table of sections
- 17 at the beginning of chapter 1 of title 1, United States
- 18 Code, is amended by adding at the end the following new
- 19 item:

[&]quot;8. 'Person', 'human being', 'child', and 'individual' as including born-alive infant.".
