Mr. BEREUTER (for himself, Mr. OXLEY, Mr. LAFALCE, Mr. SANDERS, Mr. LEACH, and Ms. LEE) introduced the following bill; which was referred to the Committee on Financial Services

A BILL

To increase the authorization for the multilateral World Bank AIDS Trust Fund, and expand the focus of the Trust Fund.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “World Bank AIDS
5 Trust Fund Amendments Act of 2001”.

**6 SEC. 2. INCREASE IN AUTHORIZATION OF APPROPRIA-
7 TIONS FOR FISCAL YEAR 2002.**

8 Section 141(a) of the Global AIDS and Tuberculosis
9 Relief Act of 2000 (22 U.S.C. 6841(a)) is amended by

1 striking “each of the fiscal years 2001 and 2002” and in-
2 serting “for fiscal year 2001 and \$200,000,000 for fiscal
3 year 2002”.

4 **SEC. 3. EXPANSION OF FOCUS.**

5 (a) PURPOSE.—Section 121(b) of the Global AIDS
6 and Tuberculosis Relief Act of 2000 (22 U.S.C. 6821(b))
7 is amended—

8 (1) by striking “and” at the end of paragraph
9 (1);

10 (2) by striking the period at the end of para-
11 graph (2); and

12 (3) by adding at the end the following:

13 “(3) address diseases related to HIV/AIDS,
14 such as tuberculosis, as well as malaria.”.

15 (b) PROGRAM OBJECTIVES.—Section 122(a)(1) of
16 such Act (22 U.S.C. 6822(a)(1)) is amended by adding
17 at the end the following: “In addition, the Trust Fund
18 should provide assistance for diseases related to HIV/
19 AIDS, such as tuberculosis, as well as malaria.”.

20 (c) ACTIVITIES SUPPORTED.—Section 122(a)(2)(G)
21 of such Act (22 U.S.C. 6822(a)(2)(G)) is amended to read
22 as follows:

23 “(G) measures to ensure affordable access
24 to treatments against AIDS and related infec-
25 tions such as tuberculosis, as well as malaria.”.

1 **SEC. 4. EXTENSION OF TIME FOR GAO REPORT ON TRUST**2 **FUND EFFECTIVENESS.**

3 Section 131(b) of the Global AIDS and Tuberculosis
4 Relief Act of 2000 (22 U.S.C. 6831(b)) is amended by
5 striking “of the enactment of this Act” and inserting “the
6 Trust Fund is established”.
