To revise the boundary of the Tumacacori National
Historical Park in the State of Arizona.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Tumacacori National
3 Historical Park Boundary Revision Act of 2002”.

4 **SEC. 2. FINDINGS AND PURPOSES.**

5 (a) FINDINGS.—The Congress finds the following:

6 (1) Tumacacori Mission in southern Arizona
7 was declared a National Monument in 1908 in rec-
8 ognition of its great historical significance as “one
9 of the oldest mission ruins in the southwest”.

10 (2) In establishing Tumacacori National Histor-
11 ical Park in 1990 to include the Tumacacori Mission
12 and the ruins of the mission of Los Santos Angeles
13 de Guevavi and the Kino visita and rancheria of
14 Calabazas, Congress recognized the importance of
15 these sites “to protect and interpret, for the edu-
16 cation and benefit of the public, sites in the State
17 of Arizona associated with the early Spanish mis-
18 sionaries and explorers of the 17th and 18th cen-
19 turies”.

20 (3) Tumacacori National Historical Park plays
21 a major role in interpreting the Spanish colonial her-
22 itage of the United States.

23 (b) PURPOSES.—The purposes of this Act are—

24 (1) to protect and interpret the resources asso-
25 ciated with the Tumacacori Mission by revising the
26 boundary of Tumacacori National Historical Park to

1 include approximately 310 acres of land adjacent to
2 the park; and

3 (2) to enhance the visitor experience at
4 Tumacacori by developing access to these associated
5 mission resources.

6 **SEC. 3. BOUNDARY REVISION, TUMACACORI NATIONAL HIS-**
7 **TORICAL PARK, ARIZONA.**

8 Section 1(b) of Public Law 101–344 (16 U.S.C.
9 410ss(b)) is amended—

10 (1) by inserting after the first sentence the fol-
11 lowing new sentence: “The park shall also consist of
12 approximately 310 acres of land adjacent to the
13 original Tumacacori unit of the park and generally
14 depicted on the map entitled ‘Tumacacori National
15 Historical Park, Arizona Proposed Boundary Revi-
16 sion 2001’, numbered 310/80,044, and dated July
17 2001.”; and

18 (2) in the last sentence—

19 (A) by striking “The map” and inserting
20 “The maps”; and

1 (B) by striking “the offices” and inserting
2 “the appropriate offices”.
