Mr. Rogers of Kentucky (for himself and Mr. Hilleary) introduced the following bill; which was referred to the Committee on Resources

## A BILL

- To authorize the Secretary of the Interior to acquire Fern Lake and the surrounding watershed in the States of Kentucky and Tennessee for addition to Cumberland Gap National Historical Park, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Fern Lake Conserva-
  - 5 tion and Recreation Act of 2001".
  - 6 SEC. 2. FINDINGS AND PURPOSES.
- 7 (a) FINDINGS.—The Congress finds the following:

- 1 (1) Fern Lake and its surrounding watershed 2 in Bell County, Kentucky, and Claiborne County, 3 Tennessee, is within the potential boundaries of 4 Cumberland Gap National Historical Park as origi-5 nally authorized by the Act of June 11, 1940 (54) 6 Stat. 262; 16 U.S.C. 261 et seq.).
  - (2) The acquisition of Fern Lake and its surrounding watershed and its inclusion in Cumberland Gap National Historical Park would protect the vista from Pinnacle Overlook, which is one of the park's most valuable scenic resources and most popular attractions, and enhance recreational opportunities at the park.
  - (3) Fern Lake is the water supply source for the City of Middlesboro, Kentucky, and environs.
  - (4) The 4,500-acre Fern Lake watershed is privately owned, and the 150-acre lake and part of the watershed are currently for sale, but the Secretary of the Interior is precluded by the first section of the Act of June 11, 1940 (16 U.S.C. 261), from using appropriated funds to acquire the lands.
  - (b) Purposes.—The purposes of the Act are—
    - (1) to authorize the Secretary of the Interior to use appropriated funds if necessary, in addition to other acquisition methods, to acquire from willing

2	order to protect scenic and natural resources and en-
3	hance recreational opportunities at Cumberland Gap
4	National Historical Park; and
5	(2) to allow the continued supply of safe, clean,
6	drinking water from Fern Lake to the City of
7	Middlesboro, Kentucky, and environs.
8	SEC. 3. LAND ACQUISITION, FERN LAKE, CUMBERLAND GAP
9	NATIONAL HISTORICAL PARK.
10	(a) DEFINITIONS.—In this section:
11	(1) Fern lake.—The term "Fern Lake"
12	means Fern Lake located in Bell County, Kentucky,
13	and Claiborne County, Tennessee.
14	(2) Land.—The term "land" means land,
15	water, interests in land, and any improvements on
16	the land.
17	(3) Park.—The term "park" means Cum-
18	berland Gap National Historical Park, as authorized
19	and established by the Act of June 11, 1940 (54
20	Stat. 262; 16 U.S.C. 261 et seq.).
21	(4) Secretary.—The term "Secretary" means
22	the Secretary of the Interior, acting through the Di-
23	rector of the National Park Service.
24	(b) Acquisition Authorized.—The Secretary may
25	acquire for addition to the park lands consisting of ap-

- 1 proximately 4,500 acres and containing Fern Lake and
- 2 its surrounding watershed, as generally depicted on the
- 3 map entitled "Fern Lake Watershed Boundary Addition,
- 4 Cumberland Gap National Historical Park", numbered
- 5 380/80,004, and dated May 2001. The map shall be on
- 6 file in the appropriate offices of the National Park Service.
- 7 (c) Authorized Acquisition Methods.—
- 8 (1) In general.—Notwithstanding the Act of
- 9 June 11, 1940 (16 U.S.C. 261 et seq.), the Sec-
- retary may acquire lands described in subsection (b)
- by donation, purchase with donated or appropriated
- funds, or exchange. However, the lands may be ac-
- quired only with the consent of the owner.
- 14 (2) EASEMENTS.—At the discretion of the Sec-
- 15 retary, the Secretary may acquire land described in
- subsection (b) that is subject to an easement for the
- 17 continued operation of providing the water supply
- for the City of Middlesboro, Kentucky, and environs.
- 19 (d) Boundary Adjustment and Administra-
- 20 TION.—Upon the acquisition of land under this section,
- 21 the Secretary shall revise the boundaries of the park to
- 22 include the land in the park. Subject to subsection (e),
- 23 the Secretary shall administer the acquired lands as part
- 24 of the park in accordance with the laws and regulations
- 25 applicable to the park.

(e) Special Issues Related to Fern Lake.—

- 2 (1) PROTECTION OF WATER QUALITY.—The
  3 Secretary shall manage public recreational use of
  4 Fern Lake, if acquired by the Secretary, in a man5 ner that is consistent with the protection of the lake
  6 as a source of safe, clean, drinking water.
  - (2) Sale of water.—In the event the Secretary's acquisition of land includes the water supply of Fern Lake, the Secretary may enter into contracts to facilitate the sale and distribution of water from the lake for the municipal water supply for the City of Middlesboro, Kentucky, and environs. The Secretary shall ensure that the terms and conditions of any such contract is consistent with National Park Service policies for the protection of park resources. Proceeds from the sale of the water shall be available for expenditure by the Secretary at the park without further appropriation.
  - (3) Consultation requirements.—In order to better manage Fern Lake and its surrounding watershed, if acquired by the Secretary, in a manner that will facilitate the provision of water for municipal needs as well as the establishment and promotion of new recreational opportunities made pos-

1	sible by the addition of Fern Lake to the park, the
2	Secretary shall consult with—
3	(A) appropriate officials in the States of
4	Kentucky, Tennessee, and Virginia and political
5	subdivisions of these States;
6	(B) organizations involved in promoting
7	tourism in these States; and
8	(C) other interested parties.
