1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Criminal Justice Co-
5 ordinating Council Restructuring Act of 2001”.

6 **SEC. 2. AUTHORIZING FEDERAL OFFICIALS ADMIN-**
7 **ISTERING CRIMINAL JUSTICE SYSTEM OF**
8 **DISTRICT OF COLUMBIA TO PARTICIPATE IN**
9 **CRIMINAL JUSTICE COORDINATING COUN-**
10 **CIL.**

11 (a) IN GENERAL.—Each of the individuals described
12 in subsection (b) is authorized to serve on the District of
13 Columbia Criminal Justice Coordinating Council, partici-
14 pate in the Council’s activities, and take such other actions
15 as may be necessary to carry out the individual’s duties
16 as a member of the Council.

17 (b) INDIVIDUALS DESCRIBED.—The individuals de-
18 scribed in this subsection are as follows:

19 (1) The Director of the Court Services and Of-
20 fender Supervision Agency for the District of Colum-
21 bia.

22 (2) The Director of the District of Columbia
23 Pretrial Services Agency.

24 (3) The United States Attorney for the District
25 of Columbia.

1 (4) The Director of the Bureau of Prisons.

2 (5) The chair of the United States Parole Com-
3 mission.

4 (6) The Director of the United States Marshals
5 Service.

6 **SEC. 3. ANNUAL REPORTING REQUIREMENT FOR CRIMINAL**
7 **JUSTICE COORDINATING COUNCIL.**

8 Not later than 60 days after the end of each calendar
9 year, the District of Columbia Criminal Justice Coordi-
10 nating Council shall prepare and submit to the President,
11 Congress, and each of the entities of the District of Co-
12 lumbia government and Federal government whose rep-
13 resentatives serve on the Council a report describing the
14 activities carried out by the Council during the year.

15 **SEC. 4. FEDERAL CONTRIBUTION FOR COORDINATING**
16 **COUNCIL.**

17 There are authorized to be appropriated for fiscal
18 year 2002 and each succeeding fiscal year such sums as
19 may be necessary for a Federal contribution to the Dis-
20 trict of Columbia to cover the costs incurred by the Dis-
21 trict of Columbia Criminal Justice Coordinating Council.

22 **SEC. 5. DISTRICT OF COLUMBIA CRIMINAL JUSTICE CO-**
23 **ORDINATING COUNCIL DEFINED.**

24 In this Act, the “District of Columbia Criminal Jus-
25 tice Coordinating Council” means the entity established

1 by the Council of the District of Columbia under the
2 Criminal Justice Coordinating Council for the District of
3 Columbia Establishment Act of 2001.
