AN ACT

To authorize certain Federal officials with responsibility for the administration of the criminal justice system of the District of Columbia to serve on and participate in the activities of the District of Columbia Criminal Justice Coordinating Council, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Criminal Justice Co-
5 ordinating Council Restructuring Act of 2001”.

1 **SEC. 2. AUTHORIZING FEDERAL OFFICIALS ADMIN-**
2 **ISTERING CRIMINAL JUSTICE SYSTEM OF**
3 **DISTRICT OF COLUMBIA TO PARTICIPATE IN**
4 **CRIMINAL JUSTICE COORDINATING COUN-**
5 **CIL.**

6 (a) IN GENERAL.—Each of the individuals described
7 in subsection (b) is authorized to serve on the District of
8 Columbia Criminal Justice Coordinating Council, partici-
9 pate in the Council’s activities, and take such other actions
10 as may be necessary to carry out the individual’s duties
11 as a member of the Council.

12 (b) INDIVIDUALS DESCRIBED.—The individuals de-
13 scribed in this subsection are as follows:

14 (1) The Director of the Court Services and Of-
15 fender Supervision Agency for the District of Colum-
16 bia.

17 (2) The Director of the District of Columbia
18 Pretrial Services Agency.

19 (3) The United States Attorney for the District
20 of Columbia.

21 (4) The Director of the Bureau of Prisons.

22 (5) The chair of the United States Parole Com-
23 mission.

24 (6) The Director of the United States Marshals
25 Service.

1 **SEC. 3. ANNUAL REPORTING REQUIREMENT FOR CRIMINAL**
2 **JUSTICE COORDINATING COUNCIL.**

3 Not later than 60 days after the end of each calendar
4 year, the District of Columbia Criminal Justice Coordi-
5 nating Council shall prepare and submit to the President,
6 Congress, and each of the entities of the District of Co-
7 lumbia government and Federal government whose rep-
8 resentatives serve on the Council a report describing the
9 activities carried out by the Council during the year.

10 **SEC. 4. FEDERAL CONTRIBUTION FOR COORDINATING**
11 **COUNCIL.**

12 There are authorized to be appropriated for fiscal
13 year 2002 and each succeeding fiscal year such sums as
14 may be necessary for a Federal contribution to the Dis-
15 trict of Columbia to cover the costs incurred by the Dis-
16 trict of Columbia Criminal Justice Coordinating Council.

17 **SEC. 5. DISTRICT OF COLUMBIA CRIMINAL JUSTICE CO-**
18 **ORDINATING COUNCIL DEFINED.**

19 In this Act, the “District of Columbia Criminal Jus-
20 tice Coordinating Council” means the entity established
21 by the Council of the District of Columbia under the
22 Criminal Justice Coordinating Council for the District of
23 Columbia Establishment Act of 2001.
