Mr. MURTHA introduced the following bill; which was referred to the Committee on Armed Services

## A BILL

To increase the rates of military basic pay for members of the uniformed services, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military Pay Equity  
5 Act of 2001”.

6 **SEC. 2. FISCAL YEAR 2002 INCREASE IN MILITARY BASIC**  
7 **PAY.**

8 (a) INCREASE IN BASIC PAY.—Effective on January  
9 1, 2002, the rates of monthly basic pay for members of  
10 the uniformed services shall be increased by 7.3 percent.

1 (b) WAIVER OF SECTION 1009 ADJUSTMENT.—The  
2 adjustment to become effective during fiscal year 2002 re-  
3 quired by section 1009 of title 37, United States Code,  
4 in the rates of monthly basic pay authorized members of  
5 the uniformed services shall not be made.

6 **SEC. 3. REPORT REGARDING FURTHER CHANGES TO MILI-**  
7 **TARY BASIC PAY RATES.**

8 (a) REPORT REQUIRED.—The Secretary of Defense  
9 shall prepare a report evaluating the need to further  
10 change the rates of monthly basic pay for members of the  
11 uniformed services in all or certain pay grades. The report  
12 shall include the Secretary's recommendations regarding  
13 each of the following proposals:

14 (1) Increasing basic pay rates for members  
15 serving in the pay grades E-5, E-6, and E-7 who  
16 have between 6 and 20 years of service as computed  
17 under section 205 of title 37, United States Code.

18 (2) Increasing the basic pay for senior enlisted  
19 members in positions of greater responsibility  
20 through the creation of a new pay grade to which  
21 members serving in the pay grade E-9 could be pro-  
22 moted.

23 (3) Addressing the adequacy of entry-level basic  
24 pay rates for members with dependents.

1           (b) SUBMISSION.—Not later than July 1, 2001, the  
2 Secretary of Defense shall submit the report to the Com-  
3 mittee on Armed Services and the Committee on Appro-  
4 priations of the House of Representatives and the Com-  
5 mittee on Armed Services and the Committee on Appro-  
6 priations of the Senate.
