Mr. TOM DAVIS of Virginia introduced the following bill; which was referred to the Committee on Resources

A BILL

To rename Wolf Trap Farm Park as “Wolf Trap National Park for the Performing Arts”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. RENAMING OF WOLF TRAP FARM PARK.**

4 The Wolf Trap Farm Park Act (Public Law 89–671;
5 16 U.S.C. 284 et seq.) is amended—

6 (1) by striking “Wolf Trap Farm Park” each
7 place it appears and inserting “Wolf Trap National
8 Park for the Performing Arts”;

9 (2) in section 2, by inserting before the final
10 period “, except that laws, rules, or regulations that

1 are applicable solely to units of the National Park
2 System that are designated as a ‘National Park’
3 shall not apply to the park”; and

4 (3) by adding at the end the following new sec-
5 tion:

6 **“SEC. 14. REFERENCES.**

7 “(a) BY FEDERAL EMPLOYEES.—The Secretary of
8 the Interior, any other Federal employee, and any em-
9 ployee of the Foundation, with respect to any reference
10 to the park in any map, publication, sign, notice, or other
11 official document or communication of the Federal Gov-
12 ernment or Foundation shall refer to the park as ‘Wolf
13 Trap National Park for the Performing Arts’.

14 “(b) OTHER SIGNS AND NOTICES.—Any directional
15 or official sign or notice pertaining to the park shall refer
16 to the park as ‘Wolf Trap National Park for the Per-
17 forming Arts’.”.

18 **SEC. 2. TECHNICAL CORRECTIONS.**

19 Section 4(c) of the Wolf Trap Farm Park Act (Public
20 Law 89–671; 16 U.S.C. 284(c)) is amended—

21 (1) by realigning the second sentence so as to
22 appear flush with the left margin; and

23 (2) by striking “Funds” and inserting “funds”.

1 **SEC. 3. APPLICABILITY OF OTHER LAWS TO NATIONAL**
2 **PARKS FOR THE PERFORMING ARTS.**

3 Any laws, rules, or regulations that are applicable
4 solely to units of the National Park System that are des-
5 ignated as a “National Park” shall not apply to any unit
6 designated as a “National Park for the Performing Arts”.
