## A BILL

To rename Wolf Trap Farm Park as “Wolf Trap National Park for the Performing Arts”, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. RENAMING OF WOLF TRAP FARM PARK.**

2 (a) *AMENDMENT.*—*The Wolf Trap Farm Park Act*  
 3 *(Public Law 89–671; 16 U.S.C. 284 et seq.) is amended—*

4 (1) *by striking “Wolf Trap Farm Park” each*  
 5 *place it appears and inserting “Wolf Trap National*  
 6 *Park for the Performing Arts”;*

7 (2) *in section 2, by inserting before the final pe-*  
 8 *riod “, except that laws, rules, or regulations that are*  
 9 *applicable solely to units of the National Park System*  
 10 *that are designated as a ‘National Park’ shall not*  
 11 *apply to Wolf Trap National Park for the Performing*  
 12 *Arts”;* *and*

13 (3) *by adding at the end the following new sec-*  
 14 *tion:*

15 **“SEC. 14. REFERENCES.**

16 “(a) *BY FEDERAL EMPLOYEES.*—*The Secretary of the*  
 17 *Interior, any other Federal employee, and any employee of*  
 18 *the Foundation, with respect to any reference to the park*  
 19 *in any map, publication, sign, notice, or other official docu-*  
 20 *ment or communication of the Federal Government or*  
 21 *Foundation shall refer to the park as ‘Wolf Trap National*  
 22 *Park for the Performing Arts’.*

23 “(b) *OTHER SIGNS AND NOTICES.*—*Any directional or*  
 24 *official sign or notice pertaining to the park shall refer to*  
 25 *the park as ‘Wolf Trap National Park for the Performing*  
 26 *Arts’.*

1       “(c) *FEDERAL LAWS AND DOCUMENTS*.—Any reference  
2 in any law (other than this Act), regulation, document,  
3 record, map, or other paper of the United States to ‘Wolf  
4 Trap Farm Park’ shall be considered to be a reference to  
5 ‘Wolf Trap National Park for the Performing Arts’.”.

6       (b) *APPLICABILITY*.—Section 14(c) of the Wolf Trap  
7 Farm Park Act (as added by subsection (a) of this section)  
8 shall not apply to this Act.

9       **SEC. 2. TECHNICAL CORRECTIONS.**

10       Section 4(c) of the Wolf Trap Farm Park Act (Public  
11 Law 89–671; 16 U.S.C. 284c(c)) is amended—

12               (1) by realigning the second sentence so as to ap-  
13 pear flush with the left margin; and

14               (2) by striking “Funds” and inserting “funds”.
