A BILL

To amend the provisions of title 39, United States Code, relating to the manner in which pay policies and sched-

ules and fringe benefit programs for postmasters are established.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Postmasters Fairness
- 5 and Rights Act of 2001".
- 6 SEC. 2. POSTMASTERS TO BE COVERED BY AGREEMENTS
- 7 RELATING TO PAY POLICIES AND SCHED-
- 8 ULES AND FRINGE BENEFIT PROGRAMS.
- 9 Section 1004 of title 39, United States Code, is
- 10 amended by redesignating subsections (g) and (h) as sub-
- 11 sections (i) and (j), respectively, and by inserting after
- 12 subsection (f) the following:
- 13 "(g)(1) The Postal Service shall, within 45 days of
- 14 each date on which an agreement is reached on a collective
- 15 bargaining agreement between the Postal Service and the
- 16 bargaining representative recognized under section 1203
- 17 which represents the largest number of employees, make
- 18 a proposal for any changes in pay policies and schedules
- 19 and fringe benefit programs for postmasters which are to
- 20 be in effect during the same period as covered by such
- 21 agreement.
- 22 "(2) The Postal Service and the postmasters' organi-
- 23 zation (or, if more than 1, all postmasters' organizations)

- 1 shall strive to resolve any differences concerning the pro-
- 2 posal described in paragraph (1).
- 3 "(3) If, within 60 days following the submission of
- 4 the proposal, the Postal Service and the postmasters' or-
- 5 ganization (or organizations) are unable to reach agree-
- 6 ment, either the Postal Service or the postmasters' organi-
- 7 zation (or organizations jointly) shall have the right to
- 8 refer the dispute to an arbitration board established under
- 9 paragraph (4).
- 10 "(4) An arbitration board shall be established to con-
- 11 sider and decide a dispute arising under paragraph (3)
- 12 and shall consist of 3 members, 1 of whom shall be se-
- 13 lected by the Postal Service, 1 by the postmasters' organi-
- 14 zation (or organizations jointly), and the third by the 2
- 15 thus selected. If either the Postal Service or the post-
- 16 masters' organization (or organizations) fail to select a
- 17 member within 30 days after the dispute is referred to
- 18 an arbitration board under this subsection, or if the mem-
- 19 bers chosen fail to agree on the third person within 5 days
- 20 after their first meeting, the selection shall be made by
- 21 the Director of the Federal Mediation and Conciliation
- 22 Service.
- "(5) The arbitration board shall give the parties a
- 24 full and fair hearing, including an opportunity for each
- 25 party to present evidence in support of its claims and an

- 1 opportunity to present its case in person, by counsel, or
- 2 by such other representative as such party may elect. De-
- 3 cisions by the arbitration board shall be conclusive and
- 4 binding upon the parties. The arbitration board shall
- 5 render its decision within 45 days after its appointment.
- 6 "(6) Costs of the arbitration board shall be shared
- 7 equally by the Postal Service and the postmasters' organi-
- 8 zation (or organizations), with the Postal Service to be re-
- 9 sponsible for one-half of those costs and the postmasters'
- 10 organization (or organizations) to be responsible for the
- 11 remainder.
- 12 "(7) Nothing in this subsection shall be considered
- 13 to affect the application of section 1005.".
- 14 SEC. 3. RIGHT OF POSTMASTERS' ORGANIZATIONS TO PAR-
- 15 TICIPATE IN PLANNING AND DEVELOPMENT
- 16 **OF PROGRAMS.**
- 17 The second sentence of section 1004(b) of title 39,
- 18 United States Code, is amended by striking "or that a
- 19 managerial organization (other than an organization rep-
- 20 resenting supervisors) represents a substantial percentage
- 21 of managerial employees," and inserting "or that a mana-
- 22 gerial organization (other than an organization rep-
- 23 resenting supervisors or postmasters) represents a sub-
- 24 stantial percentage of managerial employees, or that an
- 25 organization qualifies as a postmasters' organization,".

SEC. 4. POSTMASTERS AND POSTMASTERS' ORGANIZATION

- 2 **DEFINED.**
- 3 Subsection (i) of section 1004 of title 39, United
- 4 States Code, as so redesignated by section 2, is amended
- 5 by striking "and" at the end of paragraph (1), by striking
- 6 the period at the end of paragraph (2) and inserting a
- 7 semicolon, and by adding at the end the following:
- 8 "(3) 'postmaster' means an individual who
- 9 manages, with or without the assistance of subordi-
- nate managers or supervisors, the operations of a
- 11 post office; and
- 12 "(4) 'postmasters' organization' means, with re-
- spect to a year, any organization of postmasters
- whose membership as of June 30th of the preceding
- year included not less than 20 percent of all individ-
- uals employed as postmasters as of that date.".

17 SEC. 5. TECHNICAL AND CONFORMING AMENDMENTS.

- 18 (a) Section 1001(e) of title 39, United States Code,
- 19 is amended (in the matter before paragraph (1)) by insert-
- 20 ing "agreements under section 1004(g)," after "regula-
- 21 tions,".
- (b) Section 1003(a) of title 39, United States Code,
- 23 is amended in the first sentence by inserting "section
- 24 1004(g) of this title," before "section 8G".

1 SEC. 6. EFFECTIVE DATE.

- 2 The amendments made by this Act shall take effect
- 3 after the end of the 90-day period beginning on the date

4 of enactment of this Act.
