To authorize the Secretary of the Treasury to produce currency, postage stamps, and other security documents at the request of foreign governments on a reimbursable basis.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Bureau of Engraving
- 3 and Printing Security Printing Amendments Act of
- 4 2002".

### 5 SEC. 2. PRODUCTION OF DOCUMENTS.

- 6 Section 5114(a) of title 31, United States Code (re-
- 7 lating to engraving and printing currency and security
- 8 documents), is amended—
- 9 (1) by striking "(a) The Secretary of the Treas-
- 10 ury" and inserting:
- 11 "(a) AUTHORITY TO ENGRAVE AND PRINT.—
- 12 "(1) IN GENERAL.—The Secretary of the
- 13 Treasury"; and
- 14 (2) by adding at the end the following new
- paragraphs:
- 16 "(2) Engraving and printing for other
- 17 GOVERNMENTS.—The Secretary of the Treasury
- may, if the Secretary determines that it will not
- interfere with engraving and printing needs of the
- 20 United States, produce currency, postage stamps,
- and other security documents for foreign govern-
- 22 ments, subject to a determination by the Secretary
- of State that such production would be consistent
- with the foreign policy of the United States.
- 25 "(3) Procurement Guidelines.—Articles,
- 26 material, and supplies procured for use in the pro-

- duction of currency, postage stamps, and other secu-
- 2 rity documents for foreign governments pursuant to
- 3 paragraph (2) shall be treated in the same manner
- 4 as articles, material, and supplies procured for pub-
- 5 lie use within the United States for purposes of title
- 6 III of the Act of March 3, 1933 (41 U.S.C. 10a et
- 7 seq.; commonly referred to as the Buy American
- 8 Act).".

### 9 SEC. 3. REIMBURSEMENT.

- 10 Section 5143 of title 31, United States Code (relating
- 11 to payment for services of the Bureau of Engraving and
- 12 Printing), is amended—
- 13 (1) in the first sentence, by inserting "or for-
- eign government" after "agency";
- 15 (2) in the second sentence, by inserting "and
- other" after "administrative"; and
- 17 (3) in the last sentence, by inserting "or foreign
- government" after "agency".
