## A BILL

To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to direct the Director of the Federal Emergency Management Agency to establish a minority emergency preparedness demonstration program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

## 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Minority Emergency
- 3 Preparedness Act of 2001".
- 4 SEC. 2. ESTABLISHMENT OF PROGRAM.
- 5 Subtitle B of title VI of the Robert T. Stafford Dis-
- 6 aster Relief and Emergency Assistance Act (42 U.S.C.
- 7 5197–5197g) is amended by adding at the end the fol-
- 8 lowing:
- 9 "SEC. 629. MINORITY EMERGENCY PREPAREDNESS DEM-
- 10 ONSTRATION PROGRAM.
- 11 "(a) IN GENERAL.—The Director shall establish a
- 12 minority emergency preparedness demonstration program
- 13 to research and promote the capacity of minority commu-
- 14 nities to provide data, information, and awareness edu-
- 15 cation by providing grants to or executing contracts or co-
- 16 operative agreements with eligible nonprofit organizations
- 17 to establish and conduct such programs.
- 18 "(b) Activities Supported.—An eligible nonprofit
- 19 organization may use a grant, contract, or cooperative
- 20 agreement awarded under this section—
- 21 "(1) to conduct research into the status of
- 22 emergency preparedness and disaster response
- awareness in African American and Hispanic house-
- holds located in urban, suburban, and rural commu-
- 25 nities, particularly in those States and regions most

- 1 impacted by natural and manmade disasters and
- 2 emergencies; and
- 3 "(2) to develop and promote awareness of emer-
- 4 gency preparedness education programs within mi-
- 5 nority communities, including development and prep-
- 6 aration of culturally competent educational and
- 7 awareness materials that can be used to disseminate
- 8 information to minority organizations and institu-
- 9 tions.
- 10 "(c) Eligible Organizations.—A nonprofit orga-
- 11 nization is eligible to be awarded a grant, contract, or co-
- 12 operative agreement under this section with respect to a
- 13 program if the organization is a nonprofit organization
- 14 that is described in section 501(c)(3) of the Internal Rev-
- 15 enue Code of 1986 (26 U.S.C. 501(c)(3)) and exempt
- 16 from tax under section 501(a) of such Code, whose pri-
- 17 mary mission is to provide services to communities pre-
- 18 dominately populated by minority citizens, and that can
- 19 demonstrate a partnership with a minority-owned business
- 20 enterprise or minority business located in a HUBZone (as
- 21 defined in section 3(p) of the Small Business Act (15
- 22 U.S.C. 632(p))) with respect to the program.
- 23 "(d) Use of Funds.—A recipient of a grant, con-
- 24 tract, or cooperative agreement awarded under this section

1 may only use the proceeds of the grant, contract, or agree-

- 2 ment to—
- 3 "(1) acquire expert professional services nec-
- 4 essary to conduct research in communities predomi-
- 5 nately populated by minority citizens, with a primary
- 6 emphasis on African American and Hispanic com-
- 7 munities;
- 6 "(2) develop and prepare informational mate-9 rials to promote awareness among minority commu-10 nities about emergency preparedness and how to
- 11 protect their households and communities in advance
- of disasters;
- 13 "(3) establish consortia with minority national
- organizations, minority institutions of higher edu-
- 15 cation, and faith-based institutions to disseminate
- information about emergency preparedness to minor-
- ity communities; and
- 18 "(4) implement a joint project with a minority
- serving institution, including a part B institution (as
- defined in section 322(2) of the Higher Education
- 21 Act of 1965 (20 U.S.C. 1061(2))), an institution de-
- scribed in subparagraph (A), (B), or (C) of section
- 23 326 of that Act (20 U.S.C. 1063b(e)(1) (A), (B), or
- 24 (C)), and a Hispanic-serving institution (as defined

- in section 502(a)(5) of that Act (20 U.S.C.
- 2 1101a(a)(5)).
- 3 "(e) Application and Review Procedure.—To
- 4 be eligible to receive a grant, contract, or cooperative
- 5 agreement under this section, an organization must sub-
- 6 mit an application to the Director at such time, in such
- 7 manner, and accompanied by such information as the Di-
- 8 rector may reasonably require. The Director shall estab-
- 9 lish a procedure by which to accept such applications.
- 10 "(f) AUTHORIZATION OF APPROPRIATION.—There is
- 11 authorized to be appropriated to carry out this section
- 12 \$1,500,000 for fiscal year 2002 and such funds as may
- 13 be necessary for fiscal years 2003 through 2007. Such
- 14 sums shall remain available until expended.".
