A BILL

To amend title 49, United States Code, to provide that air carriers may not transport unaccompanied minors under the age of 18 without written certification of a custodial parent's, foster parent's, or legal guardian's permission, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Children's Air Travel
- 5 Protection Act".

SEC. 2. TRANSPORTATION OF MINORS.

- 2 (a) In General.—Chapter 417 of title 49, United
- 3 States Code, is amended by adding at the end of sub-
- 4 chapter 1 the following:

5 "§ 41722. Transportation of minors

- 6 "(a) Transportation of Unaccompanied Mi-
- 7 NORS.—No air carrier or foreign air carrier may provide
- 8 air transportation of an unaccompanied minor under the
- 9 age of 18 without a written certification of a custodial par-
- 10 ent's, foster parent's, or legal guardian's permission.
- 11 "(b) Transportation of Adults Accompanying
- 12 CERTAIN MINORS.—No air carrier or foreign air carrier
- 13 may provide air transportation of a minor under the age
- 14 of 18 that is accompanied by a person that is 18 years
- 15 of age or older unless such person certifies, in writing, that
- 16 the minor has the permission of the custodial parent, fos-
- 17 ter parent, or legal guardian to travel with such person.
- 18 "(c) Maintenance of Certification.—An air car-
- 19 rier or foreign air carrier that receives a certification
- 20 under this section shall maintain a copy of the certification
- 21 for at least 1 year after the date of receipt.".
- 22 (b) Conforming Amendment.—The analysis for
- 23 such subchapter is amended by adding at the end the fol-
- 24 lowing:

1 SEC. 3. FALSE CERTIFICATION.

- 2 (a) In General.—Chapter 463 of title 49, United
- 3 States Code, is amended by adding at the end the fol-
- 4 lowing:

5 "§ 46319. False certification of parental permission

- 6 "(a) IN GENERAL.—A person that knowingly pro-
- 7 vides to an air carrier or foreign air carrier under section
- 8 41722 false certification of parental or guardian permis-
- 9 sion with respect to a minor who is in fact a missing minor
- 10 shall be fined under title 18, imprisoned for not more than
- 11 2 years, or both.
- 12 "(b) Missing Minor Defined.—In this section the
- 13 term 'missing minor' means a minor under the age of 18
- 14 with respect to whom a custodial parent, foster parent,
- 15 or legal guardian has filed a missing person report with
- 16 appropriate law enforcement authorities.".
- 17 (b) Conforming Amendment.—The analysis for
- 18 such subchapter is amended by adding at the end the fol-
- 19 lowing:

"46319. False certification of parental permission.".

20 SEC. 4. LIMITATION ON STATUTORY CONSTRUCTION.

- Nothing in this Act, including any amendment made
- 22 by this Act, shall be construed as making an air carrier
- 23 or foreign air carrier liable to a parent, foster parent, or

- 1 legal guardian of a minor for providing air transportation
- 2 for the minor without parental or guardian permission.
