## **AN ACT**

- To amend the Small Business Act to direct the Administrator of the Small Business Administration to establish a vocational and technical entrepreneurship development program.

## 1 SECTION 1. SHORT TITLE.

"(5) STATE SMALL BUSINESS DEVELOPMENT 3 4 CENTER.—The term 'State small business development center' means a small business development 5 6 center from each State selected by the Adminis-7 trator, in consultation with the Association and giving substantial weight to the Association's rec-8 9 ommendations, to carry out the program on a state-10 wide basis in such State.

11 "(b) ESTABLISHMENT.—In accordance with this section, the Administrator shall establish a program under 12 13 which the Administrator shall make grants to State small business development centers to enable such centers to 14 15 provide, on a statewide basis, technical assistance to secondary schools, or to postsecondary vocational or technical 16 17 schools, for the development and implementation of curricula designed to promote vocational and technical entre-18 19 preneurship.

20 "(c) MINIMUM GRANT.—The Administrator may
21 make no grant under the program for an amount less than
22 \$200,000.

23 "(d) APPLICATION.—Each State small business de24 velopment center seeking a grant under the program shall
25 submit to the Administrator an application in such form

as the Administrator may require. The application shall
 include information regarding the applicant's goals and
 objectives for the educational programs to be assisted.

4 "(e) REPORT TO ADMINISTRATOR.—The Adminis-5 trator shall make a condition of each grant under the pro-6 gram that not later than 18 months after the receipt of 7 the grant the recipient shall transmit to the Administrator 8 a report describing how the grant funds were used.

9 "(f) COOPERATIVE AGREEMENTS CON-AND 10 TRACTS.—The Administrator may enter into a cooperative agreement or contract with any State small business devel-11 12 opment center receiving a grant under this section to pro-13 vide additional assistance that furthers the purposes of this section. 14

15 "(g) EVALUATION OF PROGRAM.—Not later than March 31, 2004, the Administrator shall transmit to Con-16 gress a report containing an evaluation of the program. 17 18 "(h) CLEARINGHOUSE.—The Association shall act as a clearinghouse of information and expertise regarding vo-19 cational and technical entrepreneurship education pro-20 21 grams. In each fiscal year in which grants are made under 22 the program, the Administrator shall provide additional 23 assistance to the Association to carry out the functions 24 described in this subsection.

"(i) AUTHORIZATION OF APPROPRIATIONS.—There is
 authorized to be appropriated to carry out this section
 \$7,000,000 for each of fiscal years 2002, 2003, and 2004.
 Such sums shall remain available until expended.".
