

In the Senate of the United States,

December 6, 2001.

Resolved, That the bill from the House of Representatives (H.R. 2716) entitled “An Act to amend title 38, United States Code, to revise, improve, and consolidate provisions of law providing benefits and services for homeless veterans.”, do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

4 *“Homeless Veterans Comprehensive Assistance Act of 2001”.*

3 (c) *REFERENCES TO TITLE 38, UNITED STATES*
 4 *CODE.*—*Except as otherwise expressly provided, whenever*
 5 *in this Act an amendment or repeal is expressed in terms*
 6 *of an amendment to, or repeal of, a section or other provi-*
 7 *sion, the reference shall be considered to be made to a section*
 8 *or other provision of title 38, United States Code.*

9 **SEC. 2. DEFINITIONS.**

10 *For purposes of this Act:*

11 (1) *The term “homeless veteran” has the mean-*
 12 *ing given such term in section 2002 of title 38,*
 13 *United States Code, as added by section 5(a)(1).*

14 (2) *The term “grant and per diem provider”*
 15 *means an entity in receipt of a grant under section*
 16 *2011 or 2012 of title 38, United States Code, as so*
 17 *added.*

1 **SEC. 3. NATIONAL GOAL TO END HOMELESSNESS AMONG**
2 **VETERANS.**

3 (a) *NATIONAL GOAL.*—Congress hereby declares it to
4 be a national goal to end chronic homelessness among vet-
5 erans within a decade of the enactment of this Act.

6 (b) *COOPERATIVE EFFORTS ENCOURAGED.*—Congress
7 hereby encourages all departments and agencies of Federal,
8 State, and local governments, quasi-governmental organiza-
9 tions, private and public sector entities, including commu-
10 nity-based organizations, faith-based organizations, and in-
11 dividuals to work cooperatively to end chronic homelessness
12 among veterans within a decade.

13 **SEC. 4. SENSE OF THE CONGRESS REGARDING THE NEEDS**
14 **OF HOMELESS VETERANS AND THE RESPON-**
15 **SIBILITY OF FEDERAL AGENCIES.**

16 *It is the sense of the Congress that—*

17 (1) *homelessness is a significant problem in the*
18 *veterans community and veterans are disproportion-*
19 *ately represented among homeless men;*

20 (2) *while many effective programs assist home-*
21 *less veterans to again become productive and self-suf-*
22 *ficient members of society, current resources provided*
23 *to such programs and other activities that assist*
24 *homeless veterans are inadequate to provide all needed*
25 *essential services, assistance, and support to homeless*
26 *veterans;*

1 “SUBCHAPTER I—PURPOSE; DEFINITIONS;

2 ADMINISTRATIVE MATTERS

3 “§ 2001. **Purpose**

4 “The purpose of this chapter is to provide for the spe-
 5 cial needs of homeless veterans.

6 “§ 2002. **Definitions**

7 “In this chapter:

8 “(1) The term ‘homeless veteran’ means a vet-
 9 eran who is homeless (as that term is defined in sec-

1 *tion 103(a) of the McKinney-Vento Homeless Assist-*
2 *ance Act (42 U.S.C. 11302(a)).*

3 “(2) *The term ‘grant and per diem provider’*
4 *means an entity in receipt of a grant under section*
5 *2011 or 2012 of this title.*

6 **“§ 2003. Staffing requirements**

7 “(a) *VBA STAFFING AT REGIONAL OFFICES.—The*
8 *Secretary shall ensure that there is at least one full-time*
9 *employee assigned to oversee and coordinate homeless vet-*
10 *erans programs at each of the 20 Veterans Benefits Admin-*
11 *istration regional offices that the Secretary determines have*
12 *the largest homeless veteran populations within the regions*
13 *of the Administration. The programs covered by such over-*
14 *sight and coordination include the following:*

15 “(1) *Housing programs administered by the Sec-*
16 *retary under this title or any other provision of law.*

17 “(2) *Compensation, pension, vocational rehabili-*
18 *tation, and education benefits programs administered*
19 *by the Secretary under this title or any other provi-*
20 *sion of law.*

21 “(3) *The housing program for veterans supported*
22 *by the Department of Housing and Urban Develop-*
23 *ment.*

1 “(A) *Outreach.*

2 “(B) *Rehabilitative services.*

3 “(C) *Vocational counseling and training*

4 “(D) *Transitional housing assistance.*

5 “(2) *The authority of the Secretary to make grants*
6 *under this section expires on September 30, 2005.*

7 “(b) *CRITERIA FOR GRANTS.—The Secretary shall es-*
8 *tablish criteria and requirements for grants under this sec-*
9 *tion, including criteria for entities eligible to receive grants,*
10 *and shall publish such criteria and requirements in the*
11 *Federal Register. The criteria established under this sub-*
12 *section shall include the following:*

13 “(1) *Specification as to the kinds of projects for*
14 *which grants are available, which shall include—*

15 “(A) *expansion, remodeling, or alteration of*
16 *existing buildings, or acquisition of facilities, for*
17 *use as service centers, transitional housing, or*
18 *other facilities to serve homeless veterans; and*

19 “(B) *procurement of vans for use in out-*
20 *reach to and transportation for homeless veterans*
21 *for purposes of a program referred to in sub-*
22 *section (a).*

23 “(2) *Specification as to the number of projects*
24 *for which grants are available.*

1 “(3) *Criteria for staffing for the provision of*
2 *services under a project for which grants are made.*

3 “(4) *Provisions to ensure that grants under this*
4 *section—*

5 “(A) *shall not result in duplication of ongo-*
6 *ing services; and*

7 “(B) *to the maximum extent practicable,*
8 *shall reflect appropriate geographic dispersion*
9 *and an appropriate balance between urban and*
10 *other locations.*

11 “(5) *Provisions to ensure that an entity receiv-*
12 *ing a grant shall meet fire and safety requirements*
13 *established by the Secretary, which shall include—*

14 “(A) *such State and local requirements that*
15 *may apply; and*

16 “(B) *fire and safety requirements applicable*
17 *under the Life Safety Code of the National Fire*
18 *Protection Association or such other comparable*
19 *fire and safety requirements as the Secretary*
20 *may specify.*

21 “(6) *Specification as to the means by which an*
22 *entity receiving a grant may contribute in-kind serv-*
23 *ices to the start-up costs of a project for which a*
24 *grant is sought and the methodology for assigning a*

1 *cost to that contribution for purposes of subsection*
2 *(c).*

3 “(c) *FUNDING LIMITATIONS.*—*A grant under this sec-*
4 *tion may not be used to support operational costs. The*
5 *amount of a grant under this section may not exceed 65*
6 *percent of the estimated cost of the project concerned.*

7 “(d) *ELIGIBLE ENTITIES.*—*The Secretary may make*
8 *a grant under this section to an entity applying for such*
9 *a grant only if the applicant for the grant—*

10 “(1) *is a public or nonprofit private entity with*
11 *the capacity (as determined by the Secretary) to effec-*
12 *tively administer a grant under this section;*

13 “(2) *demonstrates that adequate financial sup-*
14 *port will be available to carry out the project for*
15 *which the grant is sought consistent with the plans,*
16 *specifications, and schedule submitted by the appli-*
17 *cant; and*

18 “(3) *agrees to meet the applicable criteria and*
19 *requirements established under subsections (b) and (g)*
20 *and has, as determined by the Secretary, the capacity*
21 *to meet such criteria and requirements.*

22 “(e) *APPLICATION REQUIREMENT.*—*An entity seeking*
23 *a grant for a project under this section shall submit to the*
24 *Secretary an application for the grant. The application*
25 *shall set forth the following:*

1 “(1) *The amount of the grant sought for the*
2 *project.*

3 “(2) *A description of the site for the project.*

4 “(3) *Plans, specifications, and the schedule for*
5 *implementation of the project in accordance with cri-*
6 *teria and requirements prescribed by the Secretary*
7 *under subsection (b).*

8 “(4) *Reasonable assurance that upon completion*
9 *of the work for which the grant is sought, the project*
10 *will become operational and the facilities will be used*
11 *principally to provide to veterans the services for*
12 *which the project was designed, and that not more*
13 *than 25 percent of the services provided under the*
14 *project will be provided to individuals who are not*
15 *veterans.*

16 “(f) *PROGRAM REQUIREMENTS.—The Secretary may*
17 *not make a grant for a project to an applicant under this*
18 *section unless the applicant in the application for the grant*
19 *agrees to each of the following requirements:*

20 “(1) *To provide the services for which the grant*
21 *is made at locations accessible to homeless veterans.*

22 “(2) *To maintain referral networks for homeless*
23 *veterans for establishing eligibility for assistance and*
24 *obtaining services, under available entitlement and*

1 *assistance programs, and to aid such veterans in es-*
2 *tablishing eligibility for and obtaining such services.*

3 “(3) *To ensure the confidentiality of records*
4 *maintained on homeless veterans receiving services*
5 *through the project.*

6 “(4) *To establish such procedures for fiscal con-*
7 *trol and fund accounting as may be necessary to en-*
8 *sure proper disbursement and accounting with respect*
9 *to the grant and to such payments as may be made*
10 *under section 2012 of this title.*

11 “(5) *To seek to employ homeless veterans and*
12 *formerly homeless veterans in positions created for*
13 *purposes of the grant for which those veterans are*
14 *qualified.*

15 “(g) *SERVICE CENTER REQUIREMENTS.—In addition*
16 *to criteria and requirements established under subsection*
17 *(b), in the case of an application for a grant under this*
18 *section for a service center for homeless veterans, the Sec-*
19 *retary shall require each of the following:*

20 “(1) *That such center provide services to home-*
21 *less veterans during such hours as the Secretary may*
22 *specify and be open to such veterans on an as-needed,*
23 *unscheduled basis.*

24 “(2) *That space at such center be made avail-*
25 *able, as mutually agreeable, for use by staff of the De-*

1 *partment of Veterans Affairs, the Department of*
2 *Labor, and other appropriate agencies and organiza-*
3 *tions in assisting homeless veterans served by such*
4 *center.*

5 *“(3) That such center be equipped and staffed to*
6 *provide or to assist in providing health care, mental*
7 *health services, hygiene facilities, benefits and employ-*
8 *ment counseling, meals, transportation assistance,*
9 *and such other services as the Secretary determines*
10 *necessary.*

11 *“(4) That such center be equipped and staffed to*
12 *provide, or to assist in providing, job training, coun-*
13 *seling, and placement services (including job readi-*
14 *ness and literacy and skills training), as well as any*
15 *outreach and case management services that may be*
16 *necessary to carry out this paragraph.*

17 *“(h) RECOVERY OF UNUSED GRANT FUNDS.—(1) If a*
18 *grant recipient under this section does not establish a pro-*
19 *gram in accordance with this section or ceases to furnish*
20 *services under such a program for which the grant was*
21 *made, the United States shall be entitled to recover from*
22 *such recipient the total of all unused grant amounts made*
23 *under this section to such recipient in connection with such*
24 *program.*

1 “(2) *Any amount recovered by the United States under*
2 *paragraph (1) may be obligated by the Secretary without*
3 *fiscal year limitation to carry out provisions of this sub-*
4 *chapter.*

5 “(3) *An amount may not be recovered under para-*
6 *graph (1) as an unused grant amount before the end of the*
7 *three-year period beginning on the date on which the grant*
8 *is made.*

9 **“§2012. *Per diem payments***

10 “(a) *PER DIEM PAYMENTS FOR FURNISHING SERV-*
11 *ICES TO HOMELESS VETERANS.—(1) Subject to the avail-*
12 *ability of appropriations provided for such purpose, the*
13 *Secretary, pursuant to such criteria as the Secretary shall*
14 *prescribe, shall provide to a recipient of a grant under sec-*
15 *tion 2011 of this title (or an entity eligible to receive a*
16 *grant under that section which after November 10, 1992,*
17 *establishes a program that the Secretary determines carries*
18 *out the purposes described in that section) per diem pay-*
19 *ments for services furnished to any homeless veteran—*

20 “(A) *whom the Secretary has referred to the*
21 *grant recipient (or entity eligible for such a grant);*
22 *or*

23 “(B) *for whom the Secretary has authorized the*
24 *provision of services.*

1 “(2)(A) *The rate for such per diem payments shall be*
2 *the daily cost of care estimated by the grant recipient or*
3 *eligible entity adjusted by the Secretary under subpara-*
4 *graph (B). In no case may the rate determined under this*
5 *paragraph exceed the rate authorized for State homes for*
6 *domiciliary care under subsection (a)(1)(A) of section 1741*
7 *of this title, as the Secretary may increase from time to*
8 *time under subsection (c) of that section.*

9 “(B) *The Secretary shall adjust the rate estimated by*
10 *the grant recipient or eligible entity under subparagraph*
11 *(A) to exclude other sources of income described in subpara-*
12 *graph (D) that the grant recipient or eligible entity certifies*
13 *to be correct.*

14 “(C) *Each grant recipient or eligible entity shall pro-*
15 *vide to the Secretary such information with respect to other*
16 *sources of income as the Secretary may require to make the*
17 *adjustment under subparagraph (B).*

18 “(D) *The other sources of income referred to in sub-*
19 *paragraphs (B) and (C) are payments to the grant recipi-*
20 *ent or eligible entity for furnishing services to homeless vet-*
21 *erans under programs other than under this subchapter, in-*
22 *cluding payments and grants from other departments and*
23 *agencies of the United States, from departments or agencies*
24 *of State or local government, and from private entities or*
25 *organizations.*

1 “(3) *In a case in which the Secretary has authorized*
2 *the provision of services, per diem payments under para-*
3 *graph (1) may be paid retroactively for services provided*
4 *not more than three days before the authorization was pro-*
5 *vided.*

6 “(b) *INSPECTIONS.—The Secretary may inspect any*
7 *facility of a grant recipient or entity eligible for payments*
8 *under subsection (a) at such times as the Secretary con-*
9 *siders necessary. No per diem payment may be provided*
10 *to a grant recipient or eligible entity under this section un-*
11 *less the facilities of the grant recipient or eligible entity*
12 *meet such standards as the Secretary shall prescribe.*

13 “(c) *LIFE SAFETY CODE.—(1) Except as provided in*
14 *paragraph (2), a per diem payment may not be provided*
15 *under this section to a grant recipient or eligible entity un-*
16 *less the facilities of the grant recipient or eligible entity,*
17 *as the case may be, meet applicable fire and safety require-*
18 *ments under the Life Safety Code of the National Fire Pro-*
19 *tection Association or such other comparable fire and safety*
20 *requirements as the Secretary may specify.*

21 “(2) *During the five-year period beginning on the date*
22 *of the enactment of this section, paragraph (1) shall not*
23 *apply to an entity that received a grant under section 3*
24 *of the Homeless Veterans Comprehensive Service Programs*
25 *Act of 1992 (Public Law 102–590; 38 U.S.C. 7721 note)*

1 before that date if the entity meets fire and safety require-
2 ments established by the Secretary.

3 “(3) From amounts available for purposes of this sec-
4 tion, not less than \$5,000,000 shall be used only for grants
5 to assist entities covered by paragraph (2) in meeting the
6 Life Safety Code of the National Fire Protection Association
7 or such other comparable fire and safety requirements as
8 the Secretary may specify.

9 **“§ 2013. Authorization of appropriations**

10 “There are authorized to be appropriated to carry out
11 this subchapter amounts as follows:

12 “(1) \$60,000,000 for fiscal year 2002.

13 “(2) \$75,000,000 for fiscal year 2003.

14 “(3) \$75,000,000 for fiscal year 2004.

15 “(4) \$75,000,000 for fiscal year 2005.

16 “SUBCHAPTER III—TRAINING AND OUTREACH

17 **“§ 2021. Homeless veterans reintegration programs**

18 “(a) *IN GENERAL.*—Subject to the availability of ap-
19 propriations provided for such purpose, the Secretary of
20 Labor shall conduct, directly or through grant or contract,
21 such programs as the Secretary determines appropriate to
22 provide job training, counseling, and placement services
23 (including job readiness and literacy and skills training)
24 to expedite the reintegration of homeless veterans into the
25 labor force.

1 “(b) *REQUIREMENT TO MONITOR EXPENDITURES OF*
2 *FUNDS.*—(1) *The Secretary of Labor shall collect such in-*
3 *formation as that Secretary considers appropriate to mon-*
4 *itor and evaluate the distribution and expenditure of funds*
5 *appropriated to carry out this section. The information*
6 *shall include data with respect to the results or outcomes*
7 *of the services provided to each homeless veteran under this*
8 *section.*

9 “(2) *Information under paragraph (1) shall be fur-*
10 *nished in such form and manner as the Secretary of Labor*
11 *may specify.*

12 “(c) *ADMINISTRATION THROUGH THE ASSISTANT SEC-*
13 *RETARY OF LABOR FOR VETERANS’ EMPLOYMENT AND*
14 *TRAINING.*—*The Secretary of Labor shall carry out this sec-*
15 *tion through the Assistant Secretary of Labor for Veterans’*
16 *Employment and Training.*

17 “(d) *BIENNIAL REPORT TO CONGRESS.*—*Not less than*
18 *every two years, the Secretary of Labor shall submit to Con-*
19 *gress a report on the programs conducted under this section.*
20 *The Secretary of Labor shall include in the report an eval-*
21 *uation of services furnished to veterans under this section*
22 *and an analysis of the information collected under sub-*
23 *section (b).*

1 “(e) *AUTHORIZATION OF APPROPRIATIONS.*—(1) *There*
2 *are authorized to be appropriated to carry out this section*
3 *amounts as follows:*

4 “(A) *\$50,000,000 for fiscal year 2002.*

5 “(B) *\$50,000,000 for fiscal year 2003.*

6 “(C) *\$50,000,000 for fiscal year 2004.*

7 “(D) *\$50,000,000 for fiscal year 2005.*

8 “(E) *\$50,000,000 for fiscal year 2006.*

9 “(2) *Funds appropriated to carry out this section shall*
10 *remain available until expended. Funds obligated in any*
11 *fiscal year to carry out this section may be expended in*
12 *that fiscal year and the succeeding fiscal year.*

13 “**§2022. Coordination of outreach services for vet-**
14 **erans at risk of homelessness**

15 “(a) *OUTREACH PLAN.*—*The Secretary, acting through*
16 *the Under Secretary for Health, shall provide for appro-*
17 *priate officials of the Mental Health Service and the Read-*
18 *justment Counseling Service of the Veterans Health Admin-*
19 *istration to develop a coordinated plan for joint outreach*
20 *by the two Services to veterans at risk of homelessness, in-*
21 *cluding particularly veterans who are being discharged or*
22 *released from institutions after inpatient psychiatric care,*
23 *substance abuse treatment, or imprisonment.*

24 “(b) *MATTERS TO BE INCLUDED.*—*The outreach plan*
25 *under subsection (a) shall include the following:*

1 “(1) *Strategies to identify and collaborate with*
2 *non-Department entities used by veterans who have*
3 *not traditionally used Department services to further*
4 *outreach efforts.*

5 “(2) *Strategies to ensure that mentoring pro-*
6 *grams, recovery support groups, and other appro-*
7 *prate support networks are optimally available to*
8 *veterans.*

9 “(3) *Appropriate programs or referrals to family*
10 *support programs.*

11 “(4) *Means to increase access to case manage-*
12 *ment services.*

13 “(5) *Plans for making additional employment*
14 *services accessible to veterans.*

15 “(6) *Appropriate referral sources for mental*
16 *health and substance abuse services.*

17 “(c) *COOPERATIVE RELATIONSHIPS.—The outreach*
18 *plan under subsection (a) shall identify strategies for the*
19 *Department to enter into formal cooperative relationships*
20 *with entities outside the Department to facilitate making*
21 *services and resources optimally available to veterans.*

22 “(d) *REVIEW OF PLAN.—The Secretary shall submit*
23 *the outreach plan under subsection (a) to the Advisory Com-*
24 *mittee on Homeless Veterans for its review and consulta-*
25 *tion.*

1 “(e) *OUTREACH PROGRAM.*—(1) *The Secretary shall*
2 *carry out an outreach program to provide information to*
3 *homeless veterans and veterans at risk of homelessness. The*
4 *program shall include at a minimum—*

5 “(A) *provision of information about benefits*
6 *available to eligible veterans from the Department;*
7 *and*

8 “(B) *contact information for local Department*
9 *facilities, including medical facilities, regional offices,*
10 *and veterans centers.*

11 “(2) *In developing and carrying out the program*
12 *under paragraph (1), the Secretary shall, to the extent prac-*
13 *ticable, consult with appropriate public and private organi-*
14 *zations, including the Bureau of Prisons, State social serv-*
15 *ice agencies, the Department of Defense, and mental health,*
16 *veterans, and homeless advocates—*

17 “(A) *for assistance in identifying and contacting*
18 *veterans who are homeless or at risk of homelessness;*

19 “(B) *to coordinate appropriate outreach activi-*
20 *ties with those organizations; and*

21 “(C) *to coordinate services provided to veterans*
22 *with services provided by those organizations.*

23 “(f) *REPORTS.*—(1) *Not later than October 1, 2002,*
24 *the Secretary shall submit to the Committees on Veterans’*
25 *Affairs of the Senate and House of Representatives an ini-*

1 *tial report that contains an evaluation of outreach activities*
2 *carried out by the Secretary with respect to homeless vet-*
3 *erans, including outreach regarding clinical issues and*
4 *other benefits administered under this title. The Secretary*
5 *shall conduct the evaluation in consultation with the Under*
6 *Secretary for Benefits, the Department of Veterans Affairs*
7 *central office official responsible for the administration of*
8 *the Readjustment Counseling Service, the Director of Home-*
9 *less Veterans Programs, and the Department of Veterans Af-*
10 *airs central office official responsible for the administra-*
11 *tion of the Mental Health Strategic Health Care Group.*

12 “(2) *Not later than December 31, 2005, the Secretary*
13 *shall submit to the committees referred to in paragraph (1)*
14 *an interim report on outreach activities carried out by the*
15 *Secretary with respect to homeless veterans. The report shall*
16 *include the following:*

17 “(A) *The Secretary’s outreach plan under sub-*
18 *section (a), including goals and time lines for imple-*
19 *mentation of the plan for particular facilities and*
20 *service networks.*

12 “(B) *The Secretary of Defense (or a representa-*

7 “(C) identify gaps in existing information sys-

9 the Department, and provide recommendations about

14 agencies addressing homeless populations;

4 *Section 8(o) of the United States Housing Act of 1937*
5 *(42 U.S.C. 1437f(o)) is amended by adding at the end the*
6 *following new paragraph:*

7 *“(19) RENTAL VOUCHERS FOR VETERANS AF-*
8 *FAIRS SUPPORTED HOUSING PROGRAM.—*

9 *“(A) SET ASIDE.—Subject to subparagraph*
10 *(C), the Secretary shall set aside, from amounts*
11 *made available for rental assistance under this*
12 *subsection, the amounts specified in subpara-*
13 *graph (B) for use only for providing such assist-*
14 *ance through a supported housing program ad-*
15 *ministered in conjunction with the Department*
16 *of Veterans Affairs. Such program shall provide*
17 *rental assistance on behalf of homeless veterans*
18 *who have chronic mental illnesses or chronic sub-*
19 *stance use disorders, shall require agreement of*
20 *the veteran to continued treatment for such men-*
21 *tal illness or substance use disorder as a condi-*
22 *tion of receipt of such rental assistance, and*
23 *shall ensure such treatment and appropriate case*
24 *management for each veteran receiving such*
25 *rental assistance.*

1 “(B) *AMOUNT.*—*The amount specified in*

3 “(i) *for fiscal year 2003, the amount*
4 *necessary to provide 500 vouchers for rental*
5 *assistance under this subsection;*

6 “(ii) *for fiscal year 2004, the amount*
7 *necessary to provide 1,000 vouchers for*
8 *rental assistance under this subsection;*

9 “(iii) *for fiscal year 2005, the amount*
10 *necessary to provide 1,500 vouchers for*
11 *rental assistance under this subsection; and*

12 “(iv) *for fiscal year 2006, the amount*
13 *necessary to provide 2,000 vouchers for*
14 *rental assistance under this subsection.*

15 “(C) *FUNDING THROUGH INCREMENTAL AS-*
16 *SISTANCE.*—*In any fiscal year, to the extent that*
17 *this paragraph requires the Secretary to set aside*
18 *rental assistance amounts for use under this*
19 *paragraph in an amount that exceeds the*
20 *amount set aside in the preceding fiscal year,*
21 *such requirement shall be effective only to such*
22 *extent or in such amounts as are or have been*
23 *provided in appropriation Acts for such fiscal*
