## A BILL

To amend the Small Business Act to require the Administrator to submit certain disagreements to the Director of the Office of Management and Budget for resolution,

and to establish a minimum period for the solicitation of offers for a bundled contract.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Small Business Oppor-  
5 tunity Enhancement Act of 2001”.

6 **SEC. 2. SUBMISSION OF CERTAIN DISAGREEMENTS TO THE**  
7                   **DIRECTOR OF THE OFFICE OF MANAGEMENT**  
8                   **AND BUDGET.**

9       Section 15(a) of the Small Business Act (15 U.S.C.  
10 644(a)) is amended by striking the sentence beginning  
11 “Whenever the Administrator and the contracting pro-  
12 curement agency fail to agree,” and inserting the fol-  
13 lowing: “Whenever the Administration and the contracting  
14 procurement agency fail to agree, the Administrator shall  
15 submit the matter to the Director of the Office of Manage-  
16 ment and Budget, who shall render his decision regarding  
17 the matter not later than 10 days after receiving the mat-  
18 ter. The Director may not delegate his duties under the  
19 preceding sentence except to a subordinate official within  
20 the Office of Management and Budget appointed by the  
21 President, by and with the advice and consent of the Sen-  
22 ate.”.

1 **SEC. 3. MINIMUM PERIOD FOR SOLICITATION OF OFFERS**  
2 **FOR A BUNDLED CONTRACT.**

3 Section 15(e) of the Small Business Act (15 U.S.C.  
4 644(e)) is amended by adding at the end the following new  
5 paragraph:

6 “(5) **MINIMUM SOLICITATION PERIOD.**—In the  
7 case of a solicitation of offers for a bundled contract  
8 that is issued by the head of an agency, small busi-  
9 ness concerns shall be allowed to submit offers for  
10 a period of not less than 60 days beginning on the  
11 date the solicitation is issued.”.
