A BILL

To amend title 38, United States Code, to restore certain education benefits of individuals being ordered to active duty as part of Operation Enduring Freedom.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Reservists Education
3 Protection Act of 2001”.

4 **SEC. 2. RESTORATION OF CERTAIN EDUCATION BENEFITS**
5 **OF INDIVIDUALS BEING ORDERED TO ACTIVE**
6 **DUTY AS PART OF OPERATION ENDURING**
7 **FREEDOM.**

8 (a) **IN GENERAL.**—Sections 3013(f)(2)(A),
9 3231(a)(5)(B)(i), and 3511(a)(2)(B)(i) of title 38, United
10 States Code, are each amended by striking “, in connec-
11 tion with the Persian Gulf War, to serve on active duty
12 under section 672 (a), (d), or (g), 673, 673b, or 688 of
13 title 10;” and inserting “to serve on active duty under sec-
14 tion 688, 12301(a), 12301(d), 12301(g), 12302, or 12304
15 of title 10;”.

16 (b) **CONFORMING AMENDMENTS.**—Sections
17 3013(f)(2)(B) and 3231(a)(5)(B)(ii) of such title are each
18 amended by striking “, in connection with such War,”.

19 (c) **EFFECTIVE DATE.**—The amendments made by
20 this section shall take effect on September 11, 2001.
