Mr. HOYER introduced the following bill; which was referred to the Committee on House Administration

A BILL

To establish the Capitol Telephone Exchange Board and to grant the Board the authority to establish employment policies for employees of the United States Capitol telephone exchange, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Capitol Telephone Ex-
5 change Administrative Reform Act”.

6 **SEC. 2. CAPITOL TELEPHONE EXCHANGE BOARD.**

7 (a) **ESTABLISHMENT.**—There is hereby established
8 the Capitol Telephone Exchange Board (hereafter in this

1 Act referred to as the “Board”), consisting of the Chief
2 Administrative Officer of the House of Representatives,
3 the Sergeant at Arms and Doorkeeper of the Senate, and
4 the Chief of the United States Capitol Police.

5 (b) DUTIES.—

6 (1) IN GENERAL.—The Board shall establish
7 policies governing the terms and conditions of em-
8 ployment for employees of the United States Capitol
9 telephone exchange, including policies governing—

10 (A) the duties and responsibilities of em-
11 ployees;

12 (B) the rates of pay for employees; and

13 (C) benefits for employees.

14 (2) UNIFIED PAYROLL ADMINISTRATION.—The
15 Board shall provide (by contract or otherwise) for
16 unified payroll administration by a single disbursing
17 authority for the employees of the United States
18 Capitol telephone exchange.

19 (c) REGULATIONS.—

20 (1) IN GENERAL.—With the prior approval of
21 the Committee on House Administration of the
22 House of Representatives and the Committee on
23 Rules and Administration of the Senate, the Board
24 shall promulgate such regulations as it considers
25 necessary to carry out its duties under this Act.

1 (2) NO REDUCTION IN RATE OF PAY FOR CUR-
2 RENT EMPLOYEES.—The rate of pay of any em-
3 ployee of the United States Capitol telephone ex-
4 change under the first salary regulation promulgated
5 by the Board may not be less than the employee's
6 rate of pay for the most recent pay period prior to
7 the promulgation of the regulation (unless the em-
8 ployee does not remain in the same position).

9 **SEC. 3. EFFECTIVE DATE.**

10 This Act shall apply with respect to fiscal year 2002
11 and each succeeding fiscal year.
