AN ACT

To provide for highway infrastructure investment at the guaranteed funding level contained in the Transportation Equity Act for the 21st Century.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Highway Funding Res-
- 3 toration Act".
- 4 SEC. 2. FEDERAL-AID HIGHWAY PROGRAM OBLIGATION
- 5 CEILING.
- 6 Section 1102 of the Transportation Equity Act for
- 7 the 21st Century (23 U.S.C. 104 note; 112 Stat. 115, 113
- 8 Stat. 1753) is amended by adding at the end the following:
- 9 "(k) Restoration of Obligation Limitation for
- 10 FISCAL YEAR 2003.—Notwithstanding any other provi-
- 11 sion of law, for fiscal year 2003, the obligations for Fed-
- 12 eral-aid highway and highway safety construction pro-
- 13 grams that are subject to the obligation limitation set
- 14 forth in subsection (a)(6)—
- 15 "(1) shall be not less than \$27,746,000,000;
- 16 and
- 17 "(2) shall be distributed in accordance with this
- 18 section.".
- 19 SEC. 3. RESTORATION OF OBLIGATION CEILING.
- Notwithstanding any other provision of law, the ad-
- 21 justment made pursuant to section 1102(h) of the Trans-
- 22 portation Equity Act for the 21st Century for fiscal year
- 23 2003 shall be deemed to be zero.
- 24 SEC. 4. ADJUSTMENTS TO GUARANTEE FUNDING LEVELS.
- Notwithstanding any other provision of law, all ad-
- 26 justments made pursuant to section 251(b)(1)(B) of the

- 1 Balanced Budget and Emergency Deficit Control Act of
- 2 1985 to the highway category and to section 8103(a)(5)
- 3 of the Transportation Equity Act for the 21st Century for
- 4 fiscal year 2003 shall be deemed to be zero. This section
- 5 shall apply immediately to all reports issued pursuant to
- 6 section 254 of the Balanced Budget and Emergency Def-
- 7 icit Control Act of 1985 for fiscal year 2003, including
- 8 the discretionary sequestration preview report.

9 SEC. 5. SENSE OF CONGRESS REGARDING REVENUE

- 10 ALIGNED BUDGET AUTHORITY.
- It is the sense of Congress that the revenue aligned
- 12 budget authority provision in section 251(b)(1)(B) of the
- 13 Balanced Budget and Emergency Deficit Control Act of
- 14 1985 should be amended in the future to more accurately
- 15 align highway spending with highway revenues while
- 16 maintaining predictability and stability in highway fund-
- 17 ing levels.
- 18 SEC. 6. AUTHORIZATION FOR HIGHWAY PROJECTS.
- 19 Notwithstanding any other provision of law, projects
- 20 and activities designated on pages 82 through 92 of House
- 21 Report 107–308 shall be eligible for fiscal year 2002 funds
- 22 made available for the program for which each project or
- 23 activity is so designated.
