AN ACT

To amend the National Trails System Act to update the feasibility and suitability studies of 4 national historic trails and provide for possible additions to such trails.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REVISION OF FEASIBILITY AND SUITABILITY**
2 **STUDIES OF EXISTING NATIONAL HISTORIC**
3 **TRAILS.**

4 The National Trails System Act is amended by in-
5 serting after section 5 (16 U.S.C. 1244) the following new
6 section:

7 **“SEC. 5A. REVISION OF FEASIBILITY AND SUITABILITY**
8 **STUDIES OF EXISTING TRAILS FOR POSSIBLE**
9 **TRAIL EXPANSION.**

10 **“(a) IN GENERAL.—**

11 **“(1) DEFINITIONS.—**In this section:

12 **“(A) ROUTE.—**The term ‘route’ includes a
13 trail segment commonly known as a cutoff.

14 **“(B) SHARED ROUTE.—**The term ‘shared
15 route’ means a route that was a segment of
16 more than one historic trail, including a route
17 shared with an existing national historic trail.

18 **“(2) STUDY REQUIREMENTS AND OBJEC-**
19 **TIVES.—**The study requirements and objectives spec-
20 ified in section 5(b) shall apply to a study required
21 by this section. The study shall also assess the effect
22 that designation of the studied route as a component
23 of an existing national scenic trail or national his-
24 toric trail may have on private property along the
25 proposed route.

1 “(3) COMPLETION AND SUBMISSION OF
2 STUDY.—A study listed in this section shall be com-
3 pleted and submitted to the Congress not later than
4 three complete fiscal years from the date of the en-
5 actment of this section, or from the date of the en-
6 actment of the addition of the study to this section,
7 whichever is later.

8 “(4) IMPLEMENTATION OF STUDY RESULTS.—
9 Upon completion of a study required by this section,
10 if the Secretary conducting the study determines
11 that a studied route is a feasible and suitable addi-
12 tion to the existing national scenic trail or national
13 historic trail that was the subject of the study, the
14 Secretary shall designate the route as a component
15 of that national scenic trail or national historic trail.
16 The Secretary shall publish notice of the designation
17 in the Federal Register.

18 “(b) OREGON NATIONAL HISTORIC TRAIL.—

19 “(1) STUDY REQUIRED.—The Secretary of the
20 Interior shall undertake a study of the routes of the
21 Oregon Trail listed in paragraph (2) and generally
22 depicted on the map entitled ‘Western Emigrant
23 Trails 1830/1870’ and dated 1991/1993, and of
24 such shared routes that the Secretary considers ap-
25 propriate, to determine the feasibility and suitability

1 of designation of one or more of the routes as com-
 2 ponents of the Oregon National Historic Trail.

3 “(2) COVERED ROUTES.—The routes to be
 4 studied under paragraph (1) are the following:

5 “(A) Whitman Mission route.

6 “(B) Upper Columbia River.

7 “(C) Cowlitz River route.

8 “(D) Meek cutoff.

9 “(E) Free Emigrant Road.

10 “(F) North Alternate Oregon Trail.

11 “(G) Goodale’s cutoff.

12 “(H) North Side alternate route.

13 “(I) Cutoff to Barlow Road.

14 “(J) Naches Pass Trail.

15 “(c) PONY EXPRESS NATIONAL HISTORIC TRAIL.—

16 The Secretary of the Interior shall undertake a study of
 17 the approximately 20-mile southern alternative route of
 18 the Pony Express Trail from Wathena, Kansas, to Troy,
 19 Kansas, and such shared routes that the Secretary con-
 20 sidered appropriate, to determine the feasibility and suit-
 21 ability of designation of one or more of the routes as com-
 22 ponents of the Pony Express National Historic Trail.

23 “(d) CALIFORNIA NATIONAL HISTORIC TRAIL.—

24 “(1) STUDY REQUIRED.—The Secretary of the
 25 Interior shall undertake a study of the Missouri Val-

1 ley, central, and western routes of the California
 2 Trail listed in paragraph (2) and generally depicted
 3 on the map entitled ‘Western Emigrant Trails 1830/
 4 1870’ and dated 1991/1993, and of such shared
 5 Missouri Valley, central, and western routes that the
 6 Secretary considers appropriate, to determine the
 7 feasibility and suitability of designation of one or
 8 more of the routes as components of the California
 9 National Historic Trail.

15 “(1) STUDY REQUIRED.—The Secretary of the
16 Interior shall undertake a study of the routes of the
17 Mormon Pioneer Trail listed in paragraph (2) and
18 generally depicted on the map entitled ‘Western Em-
19 igrant Trails 1830/1870’ and dated 1991/1993, and
20 of such shared routes that the Secretary considers
21 appropriate, to determine the feasibility and suit-
22 ability of designation of one or more of the routes
23 as components of the Mormon Pioneer National His-
24 toric Trail.

1 “(2) COVERED ROUTES.—The routes to be
2 studied under paragraph (1) are the following:

16 ROUTES.—

17 “(1) STUDY REQUIRED.—The Secretary of the
18 Interior shall undertake a study of the shared routes
19 of the California Trail and Oregon Trail listed in
20 paragraph (2) and generally depicted on the map en-
21 titled ‘Western Emigrant Trails 1830/1870’ and
22 dated 1991/1993, and of such other shared routes
23 that the Secretary considers appropriate, to deter-
24 mine the feasibility and suitability of designation of
25 one or more of the routes as shared components of

1 the California National Historic Trail and the Or-
 2 egon National Historic Trail.

3 “(2) COVERED ROUTES.—The routes to be
 4 studied under paragraph (1) are the following:

5 “(A) St. Joe Road.

6 “(B) Council Bluffs Road.

7 “(C) Sublette cutoff.

8 “(D) Applegate route.

9 “(E) Old Fort Kearny Road (Oxbow
 10 Trail).

11 “(F) Childs cutoff.

13 **SECTION 1. REVISION OF FEASIBILITY AND SUITABILITY**
 14 **STUDIES OF EXISTING NATIONAL HISTORIC**
 15 **TRAILS.**

16 *Section 5 of the National Trails System Act (16 U.S.C.*
 17 *1244) is amended by inserting the following new sub-*
 18 *section(g):*

19 “(g) *The Secretary shall revise the feasibility and suit-*
 20 *ability studies for certain national trails for consideration*
 21 *of possible additions to the trails.*

22 “(1) *IN GENERAL.—*

23 “(A) *DEFINITIONS.—In this subsection:*

24 “(i) *ROUTE.—The term ‘route’ includes*
 25 *a trail segment common known as a cutoff.*

1 “(ii) *SHARED ROUTE.*—*The term*
2 *‘shared’ route means a route that was a seg-*
3 *ment of more than one historic trail, in-*
4 *cluding a route shared with an existing na-*
5 *tional historic trail.*

6 “(B) *STUDY REQUIREMENTS AND OBJEC-*
7 *TIVES.*—*The study requirements and objectives*
8 *specified in subsection (b) shall apply to a study*
9 *required by this subsection.*

10 “(C) *COMPLETION AND SUBMISSION OF*
11 *STUDY.*—*A study listed in this subsection shall*
12 *be completed and submitted to the Congress not*
13 *later than three complete fiscal years from the*
14 *date of the enactment of this subsection, or from*
15 *the date of the enactment of the addition of the*
16 *study to this subsection, whichever is later.*

17 “(2) *OREGON NATIONAL HISTORIC TRAIL.*—

18 “(A) *STUDY REQUIRED.*—*The Secretary of*
19 *the Interior shall undertake a study of the routes*
20 *of the Oregon Trail listed in subparagraph (B)*
21 *and generally depicted on the map entitled*
22 *‘Western Emigrant Trails 1830/1870’ and dated*
23 *1991/1993, and of such other routes of the Or-*
24 *egon Trail that the Secretary considers appro-*
25 *priate, to determine the feasibility and suit-*

1 *ability of designation of one or more of the*
2 *routes as components of the Oregon National*
3 *Historic Trail.*

4 “(B) COVERED ROUTES.—*The routes to be*

22 *Pony Express Trail that the Secretary considers ap-*
23 *propriate, to determine the feasibility and suitability*
24 *of designation of one or more of the routes as compo-*
25 *nents of the Pony Express National Historic Trail.*

1 “(4) CALIFORNIA NATIONAL HISTORIC TRAIL.—

2 “(A) STUDY REQUIRED.—*The Secretary of*
3 *the Interior shall undertake a study of the Mis-*
4 *souri Valley, central, and western routes of the*
5 *California Trail listed in subparagraph (B) and*
6 *generally depicted on the map entitled ‘Western*
7 *Emigrant Trails 1830/1870’ and dated 1991/*
8 *1993, and of such other and shared Missouri*
9 *Valley, central, and western routes that the Sec-*
10 *retary considers appropriate, to determine the*
11 *feasibility and suitability of designation of one*
12 *or more of the routes as components of the Cali-*
13 *ifornia National Historic Trail.*

14 “(B) COVERED ROUTES.—*The routes to be*
