22	DIVORCED SPOUSE'S BENEFITS UPON OTHER
23	SPOUSE'S REMARRIAGE.
24	(a) WIFE'S INSURANCE BENEFITS.—Section
25	202(b)(5)(A) of the Social Security Act (42 U.S.C.

402(b)(5)(A)) is amended by adding at the end the following new sentence: "The criterion for entitlement under
clause (ii) shall be deemed met upon the remarriage of
the insured individual to someone other than the applicant
during the 2-year period referred to in such clause.".

6 (b) HUSBAND'S INSURANCE BENEFITS.—Section 7 202(c)(5)(A) of such Act (42 U.S.C. 402(c)(5)(A)) is 8 amended by adding at the end the following new sentence: 9 "The criterion for entitlement under clause (ii) shall be 10 deemed met upon the remarriage of the insured individual 11 to someone other than the applicant during the 2-year pe-12 riod referred to in such clause.".

13 (c) Conforming Amendment to Exemption of INSURED INDIVIDUAL'S DIVORCED SPOUSE FROM EARN-14 15 INGS TEST AS APPLIED TO THE INSURED INDIVIDUAL.— 16 Section 203(b)(2)(B)of such Act (42)U.S.C. 17 403(b)(2)(B) is amended by adding at the end the following new sentence: "The requirement under such clause 18 19 (ii) shall be deemed met upon the remarriage of the in-20sured individual to someone other than the individual re-21 ferred to in paragraph (1) during the 2-year period re-22 ferred to in such clause.".

23 (d) EFFECTIVE DATE.—The amendments made by
24 this section shall apply with respect to benefits for months
25 after November 2002.

1SEC. 4. MONTHS ENDING AFTER DECEASED INDIVIDUAL'S2DEATH DISREGARDED IN APPLYING EARLY3RETIREMENT RULES WITH RESPECT TO DE-4CEASED INDIVIDUAL FOR PURPOSES OF LIM-5ITATION ON WIDOW'S AND WIDOWER'S BENE-6FITS.

7 (a) WIDOW'S INSURANCE **BENEFITS.**—Section 202(e)(2)(D)(i) of the Social Security Act (42 U.S.C. 8 9 402(e)(2)(D)(i) is amended by inserting after "applicable," the following: "except that, in applying paragraph 10 11 (7) of subsection (q) for purposes of this clause, any month ending with or after the date of the death of such 12 13 deceased individual shall be deemed to be excluded under such paragraph (in addition to months otherwise excluded 14 15 under such paragraph),".

16 (b) WIDOWER'S INSURANCE BENEFITS.—Section 202(f)(3)(D)(i) of such Act (42 U.S.C. 402(f)(3)(D)(i)) 17 is amended by inserting after "applicable," the following: 18 19 "except that, in applying paragraph (7) of subsection (q) 20 for purposes of this clause, any month ending with or after 21 the date of the death of such deceased individual shall be deemed to be excluded under such paragraph (in addition 22 to months otherwise excluded under such paragraph),". 23

(c) EFFECTIVE DATE.—The amendments made by
 this section shall apply with respect to benefits for months
 after November 2002.
