## In the Senate of the United States,

November 13, 2002.

Resolved, That the bill from the House of Representatives (H.R. 4073) entitled "An Act to amend the Microenterprise for Self-Reliance Act of 2000 and the Foreign Assistance Act of 1961 to increase assistance for the poorest people in developing countries under microenterprise assistance programs under those Acts, and for other purposes.", do pass with the following

## **AMENDMENT:**

Strike out all after the enacting clause and insert:

- 3 (a) Purposes.—Section 103 of the Microenterprise for

18	(b) Definitions.—Section 104 of such Act is

20	(1) in paragraph (2), by striking "for micro-
21	entrepreneurs" and inserting "to microentrepreneurs
22	and their households"; and
23	(2) by adding at the end the following:
24	"(5) Very poor.—The term 'very poor' means
25	individuals—

1	"(A) living in the bottom 50 percent below
2	the poverty line established by the national gov-
3	ernment of the country in which those individ-
4	uals live; or
5	"(B) living on the equivalent of less than \$1
6	per day.".
7	SEC. 2. AMENDMENTS TO THE MICRO- AND SMALL ENTER-

11	(a) Findings and Policy.—Section 108(a)(2) of the
12	Foreign Assistance Act of 1961 (22 U.S.C. 2151f(a)(2)) is
13	amended by striking "the development of the enterprises of
14	the poor" and inserting "the access to financial services and
15	the development of microenterprises".
16	(b) Program.—Section 108(b) of such Act (22 U.S.C.
17	2151f(b)) is amended to read as follows:
18	"(b) Program.—To carry out the policy set forth in
19	subsection (a), the President is authorized to provide assist-
20	ance to increase the availability of financial services to
21	microenterprise households lacking full access to credit, in-
22	cluding through—
23	"(1) loans and guarantees to microfinance insti-
24	tutions for the purpose of expanding the availability

1	of savings and credit to poor and low-income house-
2	holds;
3	"(2) training programs for microfinance institu-
4	tions in order to enable them to better meet the finan-
5	cial services needs of their clients; and
6	"(3) training programs for clients in order to
7	enable them to make better use of credit, increase their
8	financial literacy, and to better manage their enter-
9	prises to improve their quality of life.".

19	(2) in paragraphs (1) and (2), by striking "cred-
20	it" each place it appears and inserting "financial
21	services".
22	(d) Additional Requirement.—Section 108(d) of
23	such Act (22 U.S.C. 2151f(d)) is amended by striking
24	"micro- and small enterprise programs" and inserting
25	"programs for microenterprise households".

1	(e) Availability of Funds.—Section 108(f)(1) of
2	such Act (22 U.S.C. 2151f(f)(1)) is amended by striking
3	"for each of fiscal years 2001 and 2002" and inserting "for
4	each of fiscal years 2001 through 2004".

19	(A) in clause (i), by striking "very small
20	loans" and inserting "financial services to poor
21	entrepreneurs"; and
22	(B) in clause (ii), by striking "micro-
23	finance" and inserting "microenterprise".

1	(c) Monitoring System.—Section 131(c) of such Act
2	(22 U.S.C. 2152a(c)) is amended by striking paragraph (4)
3	and inserting the following:
4	"(4) adopts the widespread use of proven and ef-
5	fective poverty assessment tools to successfully identify
6	the very poor and ensure that they receive needed
7	microenterprise loans, savings, and assistance.".
8	(d) Development and Application of Poverty
9	Measurement Methods.—Section 131 of such Act (22
10	U.S.C. 2152a) is amended—
11	(1) by redesignating subsections (d) and (e) as
12	subsections (e) and (f), respectively; and
13	(2) by inserting after subsection (c) the fol-
14	lowing:
15	"(d) Development and Certification of Poverty
16	Measurement Methods; Application of Methods.—
17	"(1) Development and certification.—(A)
18	The Administrator of the United States Agency for
19	International Development, in consultation with
20	microenterprise institutions and other appropriate or-
21	ganizations, shall develop no fewer than two low-cost
22	methods for partner institutions to use to assess the
23	poverty levels of their current or prospective clients.
24	The United States Agency for International Develop-

- ment shall develop poverty indicators that correlate
   with the circumstances of the very poor.
- "(B) The Administrator shall field-test the methods developed under subparagraph (A). As part of the testing, institutions and programs may use the methods on a voluntary basis to demonstrate their ability to reach the very poor.
- "(C) Not later than October 1, 2004, the Administrator shall, from among the low-cost poverty measurement methods developed under subparagraph (A),
  certify no fewer than two such methods as approved
  methods for measuring the poverty levels of current or
  prospective clients of microenterprise institutions for
  purposes of assistance under this section.
- "(2) APPLICATION.—The Administrator shall require that, with reasonable exceptions, all organizations applying for microenterprise assistance under this Act use one of the certified methods, beginning no later than October 1, 2005, to determine and report the poverty levels of current or prospective clients.".
- 21 (e) LEVEL OF ASSISTANCE.—Section 131(e) of such 22 Act, as redesignated by subsection (d), is amended by insert-23 ing "and \$175,000,000 for fiscal year 2003 and 24 \$200,000,000 for fiscal year 2004" after "fiscal years 2001

1	(f) Definitions.—Section 131(f) of such Act, as redes-
2	ignated by subsection (d), is amended by adding at the end
3	the following:
4	"(5) Very poor.—The term 'very poor' means

12	SEC. 4. REPORT TO CONGRESS.
13	(a) In General.—Not later than September 30, 2005,
14	the Administrator of the United States Agency for Inter-
15	national Development shall submit to Congress a report
16	that documents the process of developing and applying pov-
17	erty assessment procedures with its partners.
18	(b) Reports for Fiscal Year 2006 and Beyond.—
19	Beginning with fiscal year 2006, the Administrator of the
20	United States Agency for International Development shall
21	annually submit to Congress on a timely basis a report that
22	addresses the United States Agency for International Devel-
23	opment's compliance with the Microenterprise for Self-Reli-
24	ance Act of 2000 by documenting—

1	(1) the percentage of its resources that were allo-
2	cated to the very poor (as defined in paragraph (5,
3	of section 131(f) of the Foreign Assistance Act of 1967
4	(22 U.S.C. $2152a(f)(5)$ )) based on the data collected
5	from its partners using the certified methods; and
6	(2) the absolute number of the very poor reached
