1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Promoting Self-Reli-3 ance for the World's Poorest Act of 2002".

4 SEC. 2. REAUTHORIZATION OF MICROENTERPRISE ASSIST-5 ANCE PROGRAMS.

6 (a) MICRO- AND SMALL ENTERPRISE DEVELOPMENT
7 CREDITS.—Section 108(f)(1) of the Foreign Assistance
8 Act of 1961 (22 U.S.C. 2151f(f)(1)) is amended by insert9 ing "and \$2,000,000 for each of the fiscal years 2003
10 through 2006" after "\$1,500,000 for each of fiscal years
11 2001 and 2002".

(b) MICROENTERPRISE DEVELOPMENT GRANT ASSISTANCE.—Section 131(d) of the Foreign Assistance Act
of 1961 (22 U.S.C. 2152a(d)) is amended by inserting
"and \$200,000,000 for each of the fiscal years 2003
through 2006" after "\$155,000,000 for each of the fiscal
years 2001 and 2002".

20 (a) IN GENERAL.—Section 131(b) of the Foreign As21 sistance Act of 1961 (22 U.S.C. 2152a(b)) is amended—

22 (1) in paragraph (3) -

23 (A) in the matter preceding subparagraph
24 (A)—

25 (i) by striking "targeted to very poor26 entrepreneurs" in the first sentence and

5	(ii) by adding at the end of the first
6	sentence before the period the following:

8	than $\$1$ per day (as determined by the
9	World Bank)"; and
10	(B) in subparagraph (A)(i), by striking
11	"entrepreneurs" and inserting "clients"; and
12	(2) by adding at the end the following:
13	"(6) Poverty measurement methods.—(A)
14	The Administrator of the United States Agency for
15	International Development shall, in consultation
16	with appropriate microfinance and microenterprise
17	institutions, develop methods to measure the level of
18	poverty of clients of sustainable poverty-focused
19	microenterpise programs under paragraph (1).
20	"(B) In developing poverty measurement meth-
21	ods under subparagraph (A), the Administrator
22	shall—
23	"(i) utilize cost-efficient sampling methods
24	as opposed to full census methods, using cri-
25	teria that correlate with characteristics of either

4	try) or those individuals living on less than $\$1$
5	per day (as determined by the World Bank), in-

8	food, climate-appropriate clothing and shelter,
9	and clean water);
10	"(ii) utilize cost-efficient sampling methods
11	that are appropriate for application by micro-
12	finance and microenterprise institutions on an
13	annual basis; and
14	"(iii) give priority to methods already in
15	use by practitioner institutions that meet the
16	criteria in clauses (i) and (ii), including meas-
17	ures of loan size.
18	"(C) The Administrator—
19	"(i) shall implement interim poverty meas-
20	urement methods in accordance with this
21	paragraph—
22	"(I) with respect to not less than 25
23	sustainable poverty-focused programs by
24	September 30, 2002; and

1	"(II) with respect to not less than 40
2	sustainable poverty-focused programs by
3	September 30, 2003; and
4	"(ii) shall implement final poverty meas-
5	urement methods in accordance with this para-
6	graph not later than September 30, 2004.
7	"(D) In carrying out subparagraph (C)(i), the
8	Administrator shall ensure that the programs de-
9	scribed in such subparagraph are equitably distrib-
10	uted among the various countries and regions of the
11	world.
12	"(E) As of October 1, 2004, grant assistance to
13	a program or service under this subsection shall
14	qualify in whole or in part as targeted assistance to
15	the very poor under paragraph (3) if one of the ap-
16	proved final measurement methods verifies that at
17	least 50 percent of the clients of the program or
18	service are among the very poor as described in
19	paragraph (3).".
20	(b) REPORT.—Not later than July 1, 2004, the Ad-
21	ministrator of the United States Agency for International
22	Development shall submit to Congress a report that
23	contains—
24	(1)(A) a description of the interim poverty

6	(2) a description of the proposed final poverty
7	measurement methods to be implemented not later
8	than September 30, 2004, in accordance with section
9	131(b)(6)(C)(ii) of such Act.
