A BILL

- To amend title 18, United States Code, with respect to crimes involving the transportation of persons and sex tourism.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Sex Tourism Prohibi-
 - 5 tion Improvement Act of 2002".
 - 6 SEC. 2. SECTION 2423 AMENDMENTS.
 - 7 (a) In General.—Section 2423 of title 18, United
 - 8 States Code, is amended by striking subsection (b) and
 - 9 inserting the following:

- 1 "(b) Travel With Intent To Engage in Illicit
- 2 Sexual Conduct.—A person who travels in interstate
- 3 commerce or travels into the United States, or a United
- 4 States citizen or an alien admitted for permanent resi-
- 5 dence in the United States who travels in foreign com-
- 6 merce, for the purpose of engaging in any illicit sexual
- 7 conduct with another person shall be fined under this title
- 8 or imprisoned not more than 15 years, or both.
- 9 "(c) Engaging in Illicit Sexual Conduct in
- 10 Foreign Places.—Any United States citizen or alien ad-
- 11 mitted for permanent residence who travels in foreign
- 12 commerce, and engages in any illicit sexual conduct with
- 13 another person shall be fined under this title or imprisoned
- 14 not more than 15 years, or both.
- 15 "(d) Ancillary Offenses.—Whoever arranges, in-
- 16 duces, procures, or facilitates the travel of a person know-
- 17 ing that such a person is traveling in interstate commerce
- 18 or foreign commerce for the purpose of engaging in illicit
- 19 sexual conduct shall be fined under this title, imprisoned
- 20 not more than 15 years, or both.
- 21 "(e) Attempt and Conspiracy.—Whoever at-
- 22 tempts or conspires to violate subsection (a), (b), (c), or
- 23 (d) shall be punishable in the same manner as a completed
- 24 violation of that subsection.

- 1 "(f) Definition.—As used in this section, the term
- 2 'illicit sexual conduct' means a sexual act (as defined in
- 3 section 2246) with a person that would be in violation of
- 4 chapter 109A if the sexual act occurred in the special mar-
- 5 itime and territorial jurisdiction of the United States or
- 6 any commercial sex act (as defined in section 1591), with
- 7 a person who has not attained the age of 18 years.".
- 8 (b) Conforming Amendment.—Section 2423(a) of
- 9 title 18, United States Code, is amended by striking "or
- 10 attempts to do so".
