3 **SECTION 1. NAME OF DEPARTMENT OF VETERANS AFFAIRS**
 4 **MEDICAL CENTER, WICHITA, KANSAS.**

5 The Department of Veterans Affairs medical center
 6 in Wichita, Kansas, shall after the date of the enactment
 7 of this Act be known and designated as the “Robert J.
 8 Dole Department of Veterans Affairs Medical Center”.

9 Any reference to such medical center in any law, regula-
 10 tion, map, document, record, or other paper of the United
 11 States shall be considered to be a reference to the Robert
 12 J. Dole Department of Veterans Affairs Medical Center.

13 **SECTION 1. NAME OF DEPARTMENT OF VETERANS AFFAIRS**
 14 **MEDICAL AND REGIONAL OFFICE CENTER,**
 15 **WICHITA, KANSAS.**

16 *The Department of Veterans Affairs Medical and Re-*
 17 *gional Office Center in Wichita, Kansas, shall after the date*
 18 *of the enactment of this Act be known and designated as*
 19 *the “Robert J. Dole Department of Veterans Affairs Medical*

1 *and Regional Office Center”. Any reference to such medical*
2 *center in any law, regulation, map, document, record, or*
3 *other paper of the United States shall be considered to be*
4 *a reference to the Robert J. Dole Department of Veterans*
5 *Affairs Medical and Regional Office Center.*
