## AN ACT

To revise the boundary of the Allegheny Portage Railroad National Historic Site, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Allegheny Portage
- 5 Railroad National Historic Site Boundary Revision Act".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:
- 8 (1) Historic site.—The term "historic site"
- 9 means the Allegheny Portage Railroad National His-

3	(78 Stat. 752; 16 U.S.C. 461 note).					
4	(2) MAP.—The term "Map" means the map en-					
5	titled "Allegheny Portage Railroad National Historic					
6	Site, Blair and Cambria Counties, Pennsylvania'					
7	numbered NERO 423/80,014 and dated May 01.					
8	(3) Secretary.—The term "Secretary" means					
9	the Secretary of the Interior, acting through the Di-					
10	rector of the National Park Service.					
11	SEC. 3. REVISION OF HISTORIC SITE BOUNDARIES.					
12	(a) Lands Excluded From and Added to His-					
13	TORIC SITE.—The boundary of the historic site is hereby					
14	revised—					
15	(1) by deleting—					
16	(A) the approximately 3.09 acres depicted					
17	on the Map as tracts 105–21 and 105–15; and					
18	(B) the approximately 7.26 acres depicted					
19	on the Map as tract 102–42; and					
20	(2) by adding—					
21	(A) the approximately 42.42 acres depicted					
22	on the map as tract 101–09; and					
23	(B) the approximately 15 acres depicted on					
24	the map as tract 104–07.					
25	(b) Authorization for Acquisitions.—					

1	(1) Acquisition 1.—
2	(A) In general.—The Secretary is au-
3	thorized to acquire, from willing owners only,
4	the approximately 98 acres depicted on the Map
5	as tract 103–07 in exchange for the approxi-
6	mately 108 acres depicted on the Map as tracts
7	102–38 and 103–04.
8	(B) Equalization of values.—If the
9	values of the tracts to be exchanged under sub-
10	paragraph (A) are not equal, the difference may
11	be equalized by donation, payment using do-
12	nated or appropriated funds, or the conveyance
13	of additional land.
14	(2) Acquisition 2.—The Secretary is author-
15	ized to acquire by exchange or donation, from willing
16	owners only, the lands included within the boundary
17	of the tract described in subsection (a)(2)(B).
18	(c) Revision of Boundaries After Acquisi-
19	TIONS.—Upon completion of the exchange under sub-
20	section (b)(1), the boundaries of the historic site shall be
21	revised, as appropriate—
22	(1) by adding the land acquired by the United
23	States; and
24	(2) by deleting the land that is no longer owned

by the United States.

#### 1 SEC. 4. AVAILABILITY OF MAP.

- 2 A copy of the Map shall be on file and available for
- 3 inspection in the appropriate offices of the National Park
- 4 Service, Department of the Interior.
- 5 SEC. 5. ADMINISTRATION OF ACQUIRED LANDS.
- 6 Lands and interests in lands added to the historic
- 7 site under this Act shall be administered by the Secretary
- 8 as part of the historic site in accordance with applicable
- 9 laws and regulations.
