Mr. ENGEL introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To require licenses for the sale, purchase, and distribution of certain chemicals that are precursors to chemical weapons, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DEFINITIONS.**

4 For purposes of this Act:

5 (1) The term “chemical weapon precursor”
6 means a Schedule 1 chemical agent or a Schedule 2
7 chemical agent, as such terms are defined in section
8 3 of the Chemical Weapons Convention Implementa-
9 tion Act of 1998 (22 U.S.C. 6701).

1 (2) The term “licensee” means a person holding
2 a license under this Act.

3 (3) The term “qualified person” means a per-
4 son found by the Secretary to meet such qualifica-
5 tions as the Secretary may, by rule, prescribe to pro-
6 tect the public health and safety from the misuse of
7 chemical weapon precursors. No person who has
8 been convicted of a criminal offense under this Act
9 or under any similar or related provision of Federal
10 or State law shall be a qualified person for purposes
11 of this Act.

12 (4) The term “Secretary” means the Secretary
13 of Commerce.

14 **SEC. 2. LICENSE REQUIRED.**

15 After December 31, 2002, no person may purchase,
16 sell, or distribute in interstate commerce any chemical
17 weapon precursor unless such person is licensed under sec-
18 tion 3.

19 **SEC. 3. ISSUANCE OF LICENSES.**

20 (a) APPLICATION.—Any qualified person may submit
21 to the Secretary an application for a license to purchase,
22 sell, or distribute in interstate commerce a chemical weap-
23 on precursor.

24 (b) ISSUANCE.—Upon receiving an application con-
25 taining such information as the Secretary may require, the

1 Secretary is authorized to issue a license to such person
2 to purchase, sell, or distribute in interstate commerce a
3 chemical weapon precursor if the Secretary finds that such
4 person is a qualified person and if such person agrees to
5 comply with this Act and the regulations under this Act.

6 (c) TERM; REVOCATION.—A license under this sec-
7 tion shall remain in effect for such term as the Secretary
8 may prescribe, except that the Secretary may at any time
9 revoke such license if the Secretary determines that the
10 licensee has failed or refused to comply with this Act or
11 any regulation under this Act.

12 **SEC. 4. REQUIREMENTS FOR MAINTENANCE OF LICENSE.**

13 Each licensee shall comply with each of the following
14 requirements and such other requirements as the Sec-
15 retary may establish by rule to carry out the purposes of
16 this Act:

17 (1) The licensee shall report any suspicious pur-
18 chases of chemical weapon precursors.

19 (2) The licensee shall maintain and make avail-
20 able to the Secretary and to Federal, State, and
21 local law enforcement authorities records of the pur-
22 chase, sale, or distribution of chemical weapon pre-
23 cursors. Such records shall be in such form and shall
24 contain such information as the Secretary shall, by
25 rule, prescribe.

1 **SEC. 5. PENALTIES FOR VIOLATION.**

2 Any person who violates any provision of this Act or
3 any regulation under this Act shall be subject to a civil
4 penalty of not more than \$10,000 for a first offense and
5 not more than \$20,000 for a second or subsequent offense.
6 If such violation was intentional, such person shall be sub-
7 ject to a criminal penalty of up to 10 years in prison in
8 addition to such civil penalties.
