- 3 SECTION 1. AUTHORIZATION OF AUSTIN, TEXAS, WASTE-
- 4 WATER RECLAMATION AND REUSE PROJECT.
- 5 (a) AUTHORIZATION OF PROJECT.—The Reclamation
- 6 Wastewater and Groundwater Study and Facilities Act
- 7 (Public Law 102–575, title XVI; 43 U.S.C. 390h et seq.)
- 8 is amended by adding at the end the following:
- 9 "SEC. 1635. AUSTIN, TEXAS, WATER RECLAMATION AND
- 10 REUSE PROJECT.
- 11 "(a) AUTHORIZATION.—The Secretary, in coopera-
- 12 tion with the City of Austin Water and Wastewater Util-
- 13 ity, Texas, is authorized to participate in the planning (in-
- 14 cluding an appraisal and feasibility study), design, and
- 15 construction of, and land acquisition for, a project to re-
- 16 claim and reuse wastewater, including degraded ground-
- 17 waters, within and outside of the service area of the City
- 18 of Austin Water and Wastewater Utility, Texas.
- 19 "(b) Cost Share.—The Federal share of the cost
- 20 of the project authorized by this section shall not exceed
- 21 25 percent of the total cost of the project.
- 22 "(c) Limitation.—The Secretary shall not provide
- 23 funds for the operation and maintenance of the project
- 24 authorized by this section.".

- 1 (b) CLERICAL AMENDMENT.—The table of contents
- 2 in section 2 of Public Law 102–575 (106 Stat. 4600) is
- 3 amended by adding at the end of the items relating to
- 4 chapter XVI the following:

"Sec. 1635. Austin, Texas, Water Reclamation and Reuse Project.".
