A BILL

6 SEC. 2. FINDINGS.

- 7 Congress finds that—
- 8 (1) regional drought disasters in the United
- 9 States cause serious economic and environmental
- losses, yet there is no national policy to ensure an

1	integrated and coordinated Federal strategy to pre-
2	pare for, mitigate, or respond to such losses;
3	(2) State, tribal, and local governments have to
4	coordinate efforts with each Federal agency involved
5	in drought monitoring, planning, mitigation, and re-
6	sponse;
7	(3) effective drought monitoring—
8	(A) is a critical component of drought pre-
9	paredness and mitigation; and
10	(B) requires a comprehensive, integrated
11	national program that is capable of providing
12	reliable, accessible, and timely information to
13	persons involved in drought planning, mitiga-
14	tion, and response activities;
15	(4) the National Drought Policy Commission
16	was established in 1998 to provide advice and rec-
17	ommendations on the creation of an integrated, co-
18	ordinated Federal policy designed to prepare for and
19	respond to serious drought emergencies;
20	(5) according to the report issued by the Na-
21	tional Drought Policy Commission in May 2000, the
22	guiding principles of national drought policy should

be—

1	(A) to favor preparedness over insurance,
2	insurance over relief, and incentives over regu-
3	lation;
4	(B) to establish research priorities based
5	on the potential of the research to reduce
6	drought impacts;
7	(C) to coordinate the delivery of Federal
8	services through collaboration with State and
9	local governments and other non-Federal enti-
10	ties; and
11	(D) to improve collaboration among sci-
12	entists and managers; and
13	(6) the National Drought Council, in coordina-
14	tion with Federal agencies and State, tribal, and
15	local governments, should provide the necessary di-
16	rection, coordination, guidance, and assistance in de-
17	veloping a comprehensive drought preparedness sys-
18	tem.
19	SEC. 3. DEFINITIONS.
20	In this Act:
21	(1) COUNCIL.—The term "Council" means the
22	National Drought Council established by section
23	101(a).
24	(2) Critical Service Provider.—The term
25	"critical service provider" means an entity that pro-

1	vides power, water (including water provided by an
2	irrigation organization or facility), sewer services, or
3	wastewater treatment.
4	(3) Director.—The term "Director" means
5	the Director of the Federal Emergency Management
6	Agency.
7	(4) Director of the office.—The term "Di-
8	rector of the Office" means the Director of the Of-
9	fice appointed under section 112(a).
10	(5) Drought.—The term "drought" means a
11	major natural disaster that is caused by a deficiency
12	in precipitation—
13	(A) that may lead to a deficiency in sur-
14	face and subsurface water supplies (including
15	rivers, streams, wetlands, ground water, soil
16	moisture, reservoir supplies, lake levels, and
17	snow pack); and
18	(B) that causes or may cause—
19	(i) substantial economic or social im-
20	pacts; or
21	(ii) physical damage or injury to indi-
22	viduals, property, or the environment.
23	(6) Fund.—The term "Fund" means the
24	Drought Assistance Fund established by section
25	121(a).

- 1 (7) Indian tribe.—The term "Indian tribe"
 2 has the meaning given the term in section 4 of the
 3 Indian Self-Determination and Education Assistance
 4 Act (25 U.S.C. 450b).
- 5 (8) MITIGATION.—The term "mitigation"
 6 means a short- or long-term action, program, or pol7 icy that is implemented in advance of or during a
 8 drought to minimize any risks and impacts of
 9 drought.
 - (9) National Drought Monitoring Network.—The term "National Drought Monitoring Network" means a comprehensive network that collects and integrates information on the key indicators of drought, including stream flow, ground water levels, reservoir levels, soil moisture, snow pack, climate (including precipitation and temperature), and forecasts, in order to make usable, reliable, and timely assessments of drought, including the severity of drought.
 - (10) Neighboring country' means Canada and Mexico.
- 22 (11) Office.—The term "Office" means the 23 National Office of Drought Preparedness established 24 under section 111.

1	(12) Trigger.—The term "trigger" means the
2	thresholds or criteria that must be satisfied before
3	mitigation or emergency assistance may be provided
4	to an area—
5	(A) in which drought is emerging; or
6	(B) that is experiencing a drought.
7	SEC. 4. EFFECT OF ACT.
8	This Act does not affect—
9	(1) the authority of a State to allocate quan-
10	tities of water under the jurisdiction of the State; or
11	(2) any State water rights established as of the
12	date of enactment of this Act.
13	TITLE I—DROUGHT
14	PREPAREDNESS
15	Subtitle A—National Drought
16	Council
17	SEC. 101. MEMBERSHIP AND VOTING.
18	(a) In General.—There is established a council to
19	be known as the "National Drought Council".
20	(b) Membership.—
21	(1) Composition.—The Council shall be com-
22	posed of—
23	(A) the Director;
24	(B) the Secretary of the Interior;
25	(C) the Secretary of the Army;

1	(D) the Secretary of Agriculture;
2	(E) 4 members appointed by the Federal
3	co-chair appointed under subsection (f), in co-
4	ordination with the National Governors Associa-
5	tion, of whom—
6	(i) 1 member shall be the Governor of
7	a State from Federal Emergency Manage-
8	ment Agency Region I, II, or III;
9	(ii) 1 member shall be the Governor of
10	a State from Federal Emergency Manage-
11	ment Agency Region IV or VI;
12	(iii) 1 member shall be the Governor
13	of a State from Federal Emergency Man-
14	agement Agency Region V or VII; and
15	(iv) 1 member shall be the Governor
16	of a State from Federal Emergency Man-
17	agement Agency Region VIII, IX, or X;
18	(F) 1 member appointed by the Federal
19	co-chair, in coordination with the National As-
20	sociation of Counties;
21	(G) 1 member appointed by the Federal
22	co-chair, in coordination with the United States
23	Conference of Mayors;
24	(H) 1 member appointed by the Secretary
25	of the Interior, in coordination with Indian

1	tribes, to represent the interests of tribal gov-
2	ernments; and
3	(I) 1 member appointed by the Secretary
4	of Agriculture, in coordination with the Na-
5	tional Association of Conservation Districts, to
6	represent local soil and water conservation dis-
7	tricts.
8	(2) Date of appointment.—The appointment
9	of each member of the Council shall be made not
10	later than 120 days after the date of enactment of
11	this Act.
12	(c) Term; Vacancies.—
13	(1) Term.—A member of the Council shall be
14	appointed for a term of 2 years.
15	(2) VACANCIES.—A vacancy on the Council—
16	(A) shall not affect the powers of the
17	Council; and
18	(B) shall be filled in the same manner as
19	the original appointment was made.
20	(d) Meetings.—
21	(1) In General.—The Council shall meet at
22	the call of the co-chairs.
23	(2) Frequency.—The Council shall meet at
24	least semiannually.

1	(e) Quorum.—A majority of the members of the
2	Council shall constitute a quorum, but a lesser number
3	may hold hearings or conduct other business.
4	(f) Co-Chairs.—
5	(1) IN GENERAL.—There shall be a Federal co-
6	chair and non-Federal co-chair of the Council.
7	(2) Appointment.—
8	(A) FEDERAL CO-CHAIR.—The Director
9	shall be Federal co-chair.
10	(B) Non-federal co-chair.—The Coun-
11	cil members appointed under subparagraphs
12	(E) through (I) of subsection (b)(1) shall select
13	a non-Federal co-chair from among the mem-
14	bers appointed under those subparagraphs.
15	(g) DIRECTOR OF THE OFFICE.—
16	(1) In general.—The Director of the Office
17	shall serve as Director of the Council.
18	(2) Duties.—The Director of the Office shall
19	serve the interests of all members of the Council.
20	SEC. 102. DUTIES OF THE COUNCIL.
21	(a) In General.—The Council shall—
22	(1) not later than 1 year after the date of the
23	first meeting of the Council, develop a comprehen-
24	sive National Drought Policy Action Plan that—

1	(A)(i) delineates and integrates responsibil-
2	ities for activities relating to drought (including
3	drought preparedness, mitigation, research, risk
4	management, training, and emergency relief)
5	among Federal agencies; and
6	(ii) ensures that those activities are coordi-
7	nated with the activities of the States, local
8	governments, Indian tribes, and neighboring
9	countries;
10	(B) is consistent with—
11	(i) this Act and other applicable Fed-
12	eral laws; and
13	(ii) the laws and policies of the States
14	for water management;
15	(C) is integrated with drought manage-
16	ment programs of the States, Indian tribes,
17	local governments, and private entities; and
18	(D) avoids duplicating Federal, State, trib-
19	al, local, and private drought preparedness and
20	monitoring programs in existence on the date of
21	enactment of this Act;
22	(2) evaluate Federal drought-related programs
23	in existence on the date of enactment of this Act and
24	make recommendations to Congress and the Presi-
25	dent on means of eliminating—

1	(A) discrepancies between the goals of the
2	programs and actual service delivery;
3	(B) duplication among programs; and
4	(C) any other circumstances that interfere
5	with the effective operation of the programs;
6	(3) make recommendations to the President,
7	Congress, and appropriate Federal Agencies on—
8	(A) the establishment of common inter-
9	agency triggers for authorizing Federal drought
10	mitigation programs; and
11	(B) improving the consistency and fairness
12	of assistance among Federal drought relief pro-
13	grams;
14	(4) coordinate and prioritize specific activities
15	that will improve the National Drought Monitoring
16	Network by—
17	(A) taking into consideration the limited
18	resources for—
19	(i) drought monitoring, prediction,
20	and research activities; and
21	(ii) water supply forecasting; and
22	(B) providing for the development of an ef-
23	fective drought information delivery system
24	that—

1	(i) communicates drought conditions
2	and impacts to—
3	(I) decisionmakers at the Fed-
4	eral, regional, State, tribal, and local
5	levels of government;
6	(II) the private sector; and
7	(III) the public; and
8	(ii) includes near-real-time data, infor-
9	mation, and products developed at the
10	Federal, regional, State, tribal, and local
11	levels of government that reflect regional
12	and State differences in drought condi-
13	tions;
14	(5) encourage and facilitate the development of
15	drought preparedness plans under subtitle C, includ-
16	ing establishing the guidelines under sections 121(c)
17	and 122(a);
18	(6) based on a review of drought preparedness
19	plans, develop and make available to the public
20	drought planning models to reduce water resource
21	conflicts relating to water conservation and
22	droughts;
23	(7) develop and coordinate public awareness ac-
24	tivities to provide the public with access to under-

1	standable, and informative materials on drought,
2	including—
3	(A) explanations of the causes of drought,
4	the impacts of drought, and the damages from
5	drought;
6	(B) descriptions of the value and benefits
7	of land stewardship to reduce the impacts of
8	drought and to protect the environment;
9	(C) clear instructions for appropriate re-
10	sponses to drought, including water conserva-
11	tion, water reuse, and detection and elimination
12	of water leaks; and
13	(D) information on State and local laws
14	applicable to drought; and
15	(8) establish operating procedures for the Coun-
16	eil.
17	(b) Consultation.—In carrying out this section,
18	the Council shall consult with groups affected by drought
19	emergencies, including groups that represent—
20	(1) agricultural production, wildlife, and fishery
21	interests;
22	(2) forestry and fire management interests;
23	(3) the credit community;
24	(4) rural and urban water associations;
25	(5) environmental interests;

1	(6) engineering and construction interests;
2	(7) the portion of the science community that
3	is concerned with drought and climatology; and
4	(8) small businesses and other private entities.
5	(c) Reports to Congress.—
6	(1) Annual Report.—
7	(A) In general.—Not later than 1 year
8	after the date of the first meeting of the Coun-
9	cil, and annually thereafter, the Council shall
10	submit to Congress a report on the activities
11	carried out under this title.
12	(B) Inclusions.—
13	(i) In general.—The annual report
14	shall include a summary of drought pre-
15	paredness plans completed under sections
16	123 through 125.
17	(ii) Initial report.—The initial re-
18	port submitted under subparagraph (A)
19	shall include any recommendations of the
20	Council under paragraph (2) or (3) of sub-
21	section (a).
22	(2) Final Report.—Not later than 7 years
23	after the date of enactment of this Act, the Council
24	shall submit to Congress a report that
25	recommends—

1	(A) amendments to this Act; and
2	(B) whether the Council should continue.
3	SEC. 103. POWERS OF THE COUNCIL.
4	(a) Hearings.—The Council may hold hearings,
5	meet and act at any time and place, take any testimony
6	and receive any evidence that the Council considers advis-
7	able to carry out this title.
8	(b) Information From Federal Agencies.—
9	(1) In general.—The Council may obtain di-
10	rectly from any Federal agency any information that
11	the Council considers necessary to carry out this
12	title.
13	(2) Provision of Information.—
14	(A) In general.—Except as provided in
15	subparagraph (B), on request of the Federal co-
16	chair or non-Federal co-chair, the head of a
17	Federal agency may provide information to the
18	Council.
19	(B) LIMITATION.—The head of a Federal
20	agency shall not provide any information to the
21	Council that the Federal agency head deter-
22	mines the disclosure of which may cause harm
23	to national security interests.
24	(c) Postal Services.—The Council may use the
25	United States mail in the same manner and under the

- 1 same conditions as other agencies of the Federal Govern-
- 2 ment.
- 3 (d) Gifts.—The Council may accept, use, and dis-
- 4 pose of gifts or donations of services or property.
- 5 (e) Federal Facilities.—If the Council proposes
- 6 the use of a Federal facility for the purposes of carrying
- 7 out this title, the Council shall solicit and consider the
- 8 input of the Federal agency with jurisdiction over the fa-
- 9 cility.

10 SEC. 104. COUNCIL PERSONNEL MATTERS.

- (a) Compensation of Members.—
- 12 (1) Non-federal employees.—A member of
- the Council who is not an officer or employee of the
- 14 Federal Government shall serve without compensa-
- tion.
- 16 (2) Federal employees.—A member of the
- 17 Council who is an officer or employee of the United
- 18 States shall serve without compensation in addition
- to the compensation received for services of the
- 20 member as an officer or employee of the Federal
- Government.
- 22 (b) Travel Expenses.—A member of the Council
- 23 shall be allowed travel expenses at rates authorized for an
- 24 employee of an agency under subchapter I of chapter 57
- 25 of title 5, United States Code, while away from the home

1	or regular place of business of the member in the perform-
2	ance of the duties of the Council.
3	SEC. 105. AUTHORIZATION OF APPROPRIATIONS.
4	There is authorized to be appropriated to carry out
5	this title \$2,000,000 for each of fiscal years 2003 through
6	2010.
7	SEC. 106. TERMINATION OF COUNCIL.
8	The Council shall terminate 8 years after the date
9	of enactment of this Act.
10	Subtitle B—National Office of
11	Drought Preparedness
12	SEC. 111. ESTABLISHMENT.
13	The Director shall establish directly under the Direc-
14	tor an office to be known as the "National Office of
15	Drought Preparedness' to provide assistance to the Coun-
16	cil in carrying out this title.
17	SEC. 112. DIRECTOR OF THE OFFICE.
18	(a) Appointment.—
19	(1) In general.—The Director shall appoint a
20	Director of the Office under sections 3371 through
21	3375 of title 5, United States Code.
22	(2) QUALIFICATIONS.—The Director of the Of-
23	fice shall be a person who has experience in—
24	(A) public administration; and

1	(B) drought mitigation or drought man-
2	agement.
3	(b) Powers.—The Director of the Office may hire
4	such other additional personnel or contract for services
5	with other entities as necessary to carry out the duties
6	of the Office.
7	SEC. 113. DETAIL OF GOVERNMENT EMPLOYEES.
8	(a) In General.—An employee of the Federal Gov-
9	ernment may be detailed to the Office without reimburse-
10	ment, unless the Federal co-chair, on the recommendation
11	of the Director of the Office, determines that reimburse-
12	ment is appropriate.
13	(b) Civil Service Status.—The detail of an em-
14	ployee shall be without interruption or loss of civil service
15	status or privilege.
16	Subtitle C—Drought Preparedness
17	Plans
18	SEC. 121. DROUGHT ASSISTANCE FUND.
19	(a) Establishment.—There is established within
20	the Federal Emergency Management Agency a fund to be
21	known as the "Drought Assistance Fund".
22	(b) Purpose.—The Fund shall be used to pay the
23	costs of—
24	(1) providing technical and financial assistance
25	(including grants and cooperative assistance) to

- States, Indian tribes, local governments, and critical service providers for the development and implementation of drought preparedness plans under sections 123 through 125;
 - (2) providing to States, Indian tribes, local governments, and critical service providers the Federal share, as determined by the Federal co-chair, in consultation with the other members of the Council, of the cost of mitigating the overall risk and impacts of droughts;
 - (3) assisting States, Indian tribes, local governments, and critical service providers in the development of mitigation measures to address environmental, economic, and human health and safety issues relating to drought;
 - (4) expanding the technology transfer of drought and water conservation strategies and innovative water supply techniques;
 - (5) developing post-drought evaluations and recommendations; and
 - (6) supplementing, if necessary, the costs of implementing actions under section 102(a)(4).
- (c) Guidelines.—
- 24 (1) IN GENERAL.—The Federal co-chair of the 25 Council shall, in consultation with other members of

1 the Council, promulgate guidelines implementing 2 this section. (2) REQUIREMENTS.—The guidelines shall— 3 (A) ensure the distribution of amounts from the Fund within a reasonable period of 6 time; 7 (B) take into consideration regional dif-8 ferences; and 9 (C) prohibit the use of amounts from the 10 Fund for Federal salaries that are not directly 11 related to the provision of drought assistance. 12 (d) AUTHORIZATION OF APPROPRIATIONS.—There are authorized to be appropriated to the Fund such sums as are necessary to carry out the purposes described in 14 15 subsection (b). SEC. 122. DROUGHT PREPAREDNESS PLANS. 17 (a) IN GENERAL.—The Director, in consultation with the Council, shall publish guidelines for administering a 18 19 national program to provide technical and financial assist-20 ance to States, Indian tribes, local governments, and crit-21 ical service providers for the development, maintenance, 22 and implementation of drought preparedness plans. 23 (b) REQUIREMENTS.—To build on the experience and avoid duplication of efforts of Federal, State, local, tribal,

and regional drought plans in existence on the date of en-

actment of this Act, the guidelines may recognize and in-2 corporate those plans. 3 SEC. 123. FEDERAL PLANS. 4 (a) IN GENERAL.—The Director, the Secretary of Agriculture, the Secretary of the Interior, the Secretary of the Army, and other appropriate Federal agency heads 6 7 shall develop and implement Federal drought prepared-8 ness plans for agencies under the jurisdiction of the appropriate Federal agency head. 10 (b) REQUIREMENTS.—The Federal plans— 11 (1) shall be integrated with each other; 12 (2) may be included as components of other 13 Federal planning requirements; 14 (3) shall be integrated with drought prepared-15 ness plans of State, tribal, and local governments 16 that are affected by Federal projects and programs; 17 and 18 (4) shall be completed not later than 2 years 19 after the date of enactment of this Act. 20 SEC. 124. STATE AND TRIBAL PLANS. 21 States and Indian tribes may develop and implement 22 State and tribal drought preparedness plans that— 23 (1) address monitoring of resource conditions 24 that are related to drought;

1	(2) identify areas that are at a high risk for
2	drought;
3	(3) describes mitigation strategies to address
4	and reduce the vulnerability of an area to drought;
5	and
6	(4) are integrated with State, tribal, and local
7	water plans in existence on the date of enactment of
8	this Act.
9	SEC. 125. REGIONAL AND LOCAL PLANS.
10	Local governments and regional water providers may
11	develop and implement drought preparedness plans that—
12	(1) address monitoring of resource conditions
13	that are related to drought;
14	(2) identify areas that are at a high risk for
15	drought;
16	(3) describe mitigation strategies to address
17	and reduce the vulnerability of an area to drought;
18	and
19	(4) are integrated with corresponding State
20	plans.
21	SEC. 126. PLAN ELEMENTS.
22	The drought preparedness plans developed under sec-
23	tions 123 through 125—
24	(1) shall be consistent with Federal and State
25	laws, contracts, and policies;

1	(2) shall allow each State to continue to man-
2	age water and wildlife in the State;
3	(3) shall address the health, safety, and eco-
4	nomic interests of those persons directly affected by
5	drought;
6	(4) may include—
7	(A) provisions for water management
8	strategies to be used during various drought or
9	water shortage thresholds, consistent with State
10	water law;
11	(B) provisions to address key issues relat-
12	ing to drought (including public health, safety,
13	economic factors, and environmental issues such
14	as water quality, water quantity, protection of
15	threatened and endangered species, and fire
16	management);
17	(C) provisions that allow for public partici-
18	pation in the development, adoption, and imple-
19	mentation of drought plans;
20	(D) provisions for periodic drought exer-
21	cises, revisions, and updates;
22	(E) a hydrologic characterization study to
23	determine how water is being used during times
24	of normal water supply availability to anticipate
25	the types of drought mitigation actions that

1	would most effectively improve water manage-
2	ment during a drought;
3	(F) drought triggers;
4	(G) specific implementation actions for
5	droughts;
6	(H) a water shortage allocation plan, con-
7	sistent with State water law; and
8	(I) comprehensive insurance and financial
9	strategies to manage the risks and financial im-
10	pacts of droughts; and
11	(5) shall take into consideration—
12	(A) the financial impact of the plan on the
13	ability of the utilities to ensure rate stability
14	and revenue stream; and
15	(B) economic impacts from water short-
16	ages.
17	TITLE II—WILDFIRE
18	SUPPRESSION
19	SEC. 201. GRANTS FOR PREPOSITIONING WILDFIRE SUP-
20	PRESSION RESOURCES.
21	Title II of the Robert T. Stafford Disaster Relief and
22	Emergency Assistance Act (42 U.S.C. 5131 et seq.) is
23	amended by adding at the end the following:

1	"SEC. 205. GRANTS FOR PREPOSITIONING WILDFIRE SUP-
2	PRESSION RESOURCES.
3	"(a) Findings and Purpose.—
4	"(1) FINDINGS.—Congress finds that—
5	"(A) droughts increase the risk of cata-
6	strophic wildfires that—
7	"(i) drastically alter and otherwise ad-
8	versely affect the landscape for commu-
9	nities and the environment;

1 "(D) it is more cost-effective to prevent 2 wildfires by prepositioning wildfire fighting re-3 sources to catch flare-ups than to commit mil-4 lions of dollars to respond to large uncontrollable fires; and 6 "(E) it is in the best interest of the United 7 States to invest in catastrophic wildfire preven-8 tion and mitigation by easing the financial bur-9 den of prepositioning wildfire suppression re-10 sources. 11 "(2) Purpose.—The purpose of this section is 12 encourage the mitigation and prevention of 13 wildfires by providing financial assistance to States 14 for prepositioning of wildfire suppression resources. 15 "(b) AUTHORIZATION.—The Director of the Federal Emergency Management Agency (referred to in this sec-16 tion as the 'Director') may reimburse a State for the cost of prepositioning wildfire suppression resources on potential multiple and large fire complexes when the Director 19 determines, in accordance with national and regional se-20 21 verity indices of the Forest Service, that a wildfire event 22 poses a threat to life and property in the area.
