## A BILL

To amend title 38, United States Code, to provide an increase in the maximum annual rates of pension payable to surviving spouses of veterans of a period of war, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Widows of Wartime
- 5 Veterans Assistance Act".

1	SEC. 2. INCREASE IN MAXIMUM ANNUAL RATES OF PEN-
2	SION FOR SURVIVING SPOUSES OF VETERANS
3	OF A PERIOD OF WAR.
4	(a) Increase.—Section 1541 of title 38, United
5	States Code, is amended—
6	(1) in subsection (a), by striking "as increased"
7	and inserting "as increased under subsection (f),
8	and as further increased";
9	(2) by redesignating subsections (f), (g), and
10	(h) as subsections (g), (h), and (i), respectively; and
11	(3) by inserting after subsection (e) the fol-
12	lowing new subsection (f):
13	"(f)(1) Effective for months after November of the
14	year of the enactment of this subsection, the annual rate
15	of pension payable to a surviving spouse under a provison
16	referred to in paragraph (2) shall be increased for any
17	year by the amount equal to the difference between—
18	"(A) the current poverty line (as that term is
19	defined in section 673(2) of the Community Services
20	Block Grant Act (42 U.S.C. 9902(2)) for that year
21	for a one-person family unit in the 48 contiguous
22	States and the District of Columbia; and
23	"(B) the annual rate of pension in effect under
24	subsection (b) in November of that year.

1 "(A) Subsection (b). 2 "(B) The first sentence of subsection (c). 3 "(C) Subsection (d)(1). "(D) The first sentence of subsection (d)(2). 4 "(E) The first sentence of subsection (e)(1).". 5 6 (b) DISREGARD OF INCREASED AMOUNT FOR PUR-POSES OF MEDICAID ELIGIBILITY.—Section 1902(r)(1) of 8 the Social Security Act (42 U.S.C. 1396a(r)(1)) is amend-9 ed by adding at the end the following new subparagraph: 10 "(C) In determining for purposes of this title the in-11 come of a surviving spouse of a veteran who receives a 12 monthly pension under section 1541 of title 38, United
