A BILL

To amend the Wild and Scenic Rivers Act to ensure congressional involvement in the process by which rivers that are designated as wild, scenic, or recreational rivers by an act of the legislature of the State or States through which they flow may be included in the national wild and scenic rivers system, and for other purposes.

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Wild and Scenic Rivers
5 Congressional Involvement Act of 2002”.

1 **SEC. 2. PROCESS FOR INCLUSION OF STATE DESIGNATED**
2 **WILD, SCENIC, AND RECREATIONAL RIVERS**
3 **IN NATIONAL WILD AND SCENIC RIVERS SYS-**
4 **TEM.**

5 (a) CONGRESSIONAL ROLE.—Section 2(a) of the
6 Wild and Scenic Rivers Act (16 U.S.C. 1273(a)) is
7 amended—

8 (1) in clause (ii) of the first sentence, by strik-
9 ing “that are found by the Secretary of the Interior”
10 and all that follows through “Virginia State line.”
11 and inserting “and that are authorized for inclusion
12 in the national wild and scenic rivers system by Act
13 of Congress following the submission by the Gov-
14 ernor of the State or the Governors of the States
15 concerned (or a person or persons duly appointed by
16 such Governor or Governors) of an application to the
17 Secretary of the Interior.”;

18 (2) in the second sentence, by inserting “and
19 submit to Congress a report regarding whether the
20 State designated rivers specified in the application
21 meet the criteria for inclusion in the national wild
22 and scenic rivers system” after “Register”; and

23 (3) in the third sentence, by striking “des-
24 ignated under clause (ii)” and inserting “authorized
25 for inclusion in the national wild and scenic rivers
26 system by Act of Congress under clause (ii)”.

1 (b) TECHNICAL CORRECTION.—Such section is
2 amended in the fourth sentence by striking “Act of 1965”
3 and inserting “Fund Act of 1965 (16 U.S.C. 4601–4 et
4 seq.)”.
