3 **SECTION 1. INCREASE IN AGE LIMIT FOR CHILD TAX CRED-**

4 **IT.**

5 (a) IN GENERAL.—Subparagraph (B) of section
6 24(c)(1) of the Internal Revenue Code of 1986 (defining
7 qualifying child) is amended by striking “age of 17” and
8 inserting “age of 19”.

1 (b) EFFECTIVE DATE.—The amendment made by
2 subsection (a) shall apply to taxable years beginning after
3 December 31, 2002.
