## A BILL

To amend the Harmonized Tariff Schedule of the United States to modify temporarily certain rates of duty, to make other technical amendments to the trade laws, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Miscellaneous Trade

5 and Technical Corrections Act of 2002”.

17 this Act, and shall apply to any drawback claim filed on  
18 or after that date and to any drawback entry filed before  
19 that date if the liquidation of the entry is not final on  
20 that date.

21 **Subtitle C—Effective Date**

22 **SEC. 1701. EFFECTIVE DATE.**

23 Except as otherwise provided in this title, the amend-  
24 ments made by this title shall apply with respect to goods  
25 entered, or withdrawn from warehouse, for consumption,

1 on or after the 15th day after the date of the enactment

17           CEDURES FOR IMPORTED WINE.—
