## A BILL

To reauthorize the program of block grants to States for temporary assistance for needy families for 2 years.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REFERENCES.**

4 Except as otherwise expressly provided, wherever in  
5 this Act an amendment or repeal is expressed in terms  
6 of an amendment to, or repeal of, a section or other provi-  
7 sion, the amendment or repeal shall be considered to be  
8 made to a section or other provision of the Social Security  
9 Act.

1 **SEC. 2. FAMILY ASSISTANCE GRANTS.**

2 Subparagraphs (A) and (E) of section 403(a)(1) (42  
3 U.S.C. 603(a)(1)) are each amended by striking “and  
4 2002” and inserting “2002, 2003, and 2004”.

5 **SEC. 3. BONUS TO REWARD DECREASE IN ILLEGITIMACY**  
6 **RATIO.**

7 Section 403(a)(2) (42 U.S.C. 603(a)(2)) is amend-  
8 ed—

9 (1) in subparagraph (C)(ii), by striking “and  
10 2002” and inserting “2002, 2003, and 2004”; and

11 (2) in subparagraph (D), by striking “2002”  
12 and inserting “2004”.

13 **SEC. 4. SUPPLEMENTAL GRANTS FOR POPULATION IN-**  
14 **CREASES IN CERTAIN STATES.**

15 Section 403(a)(3)(H) (42 U.S.C. 603(a)(3)(H)) is  
16 amended—

17 (1) in the subparagraph heading, by striking  
18 “OF GRANTS FOR FISCAL YEAR 2002”;

19 (2) in clause (i), by striking “fiscal year 2002”  
20 and inserting “each of fiscal years 2002, 2003, and  
21 2004”;

22 (3) in clause (ii), by striking “2002” and in-  
23 serting “2004”; and

24 (4) in clause (iii), by striking “fiscal year  
25 2002” and inserting “each of fiscal years 2002,  
26 2003, and 2004”.

1 **SEC. 5. BONUS TO REWARD HIGH PERFORMANCE STATES.**

2 Section 403(a)(4) (42 U.S.C. 603(a)(4)) is amend-  
3 ed—

4 (1) in subparagraph (D)(ii)(I), by striking  
5 “\$200,000,000” and inserting “ $\frac{1}{6}$  of  
6 \$1,000,000,000”;

7 (2) in subparagraph (E)(i), by striking “and  
8 2003” and inserting “2003, and 2004”; and

9 (3) in subparagraph (F), by striking “2003”  
10 and inserting “2004”.

11 **SEC. 6. CONTINGENCY FUND.**

12 Section 403(b) (42 U.S.C. 603(b)) is amended—

13 (1) in paragraph (2), by striking “and 2002”  
14 and inserting “2002, 2003, and 2004”; and

15 (2) in paragraph (3)(C)(ii), by striking “2002”  
16 and inserting “2004”.

17 **SEC. 7. MAINTENANCE OF EFFORT REQUIREMENT.**

18 Section 409(a)(7) (42 U.S.C. 609(a)(7)) is amend-  
19 ed—

20 (1) in subparagraph (A), by striking “or 2003”  
21 and inserting “2003, or 2004”; and

22 (2) in subparagraph (B)(ii), by striking “2002”  
23 and inserting “2003”.

24 **SEC. 8. GRANTS TO INDIAN TRIBES.**

25 Paragraphs (1)(A) and (2)(A) of section 412(a) (42  
26 U.S.C. 612(a)(1)(A) and (2)(A)) are each amended by

1 striking “and 2002” and inserting “2002, 2003, and  
2 2004”.

3 **SEC. 9. MATCHING GRANTS FOR THE TERRITORIES.**

4 Section 1108(b)(2) (42 U.S.C. 1308(b)(2)) is amend-  
5 ed by striking “2002” and inserting “2004”.

6 **SEC. 10. MANDATORY CHILD CARE FUNDING.**

7 Section 418(a)(3)(F) (42 U.S.C. 618(a)(3)(F)) is  
8 amended by striking “fiscal year 2002” and inserting  
9 “each of fiscal years 2002 through 2004”.
