- 3 SEC. 101. SHORT TITLE.
- 4 This title may be cited as the "Education Sciences
- 5 Reform Act of 2002".
- 6 SEC. 102. DEFINITIONS.
- 7 In this title:
- 8 (1) IN GENERAL.—The terms "elementary
- 9 school", "secondary school", "local educational agen-
- 10 cy", and "State educational agency" have the mean-
- ings given those terms in section 9101 of the Ele-
- mentary and Secondary Education Act of 1965 (20)
- 13 U.S.C. 7801) and the terms "freely associated
- states" and "outlying area" have the meanings given
- those terms in section 1121(c) of such Act (20)
- 16 U.S.C. 6331(c)).

1	(2) APPLIED RESEARCH.—The term "applied
2	research" means research—
3	(A) to gain knowledge or understanding
4	necessary for determining the means by which
5	a recognized and specific need may be met; and
6	(B) that is specifically directed to the ad-
7	vancement of practice in the field of education.
8	(3) Basic research.—The term "basic re-
9	search" means research—
10	(A) to gain fundamental knowledge or un-
11	derstanding of phenomena and observable facts,
12	without specific application toward processes or
13	products; and
14	(B) for the advancement of knowledge in
15	the field of education.
16	(4) Board.—The term "Board" means the Na-
17	tional Board for Education Sciences established
18	under section 116.
19	(5) Bureau.—The term "Bureau" means the
20	Bureau of Indian Affairs.
21	(6) Comprehensive center.—The term
22	"comprehensive center" means an entity established
23	under section 203 of the Educational Technical As-
24	sistance Act of 2002.

- 1 (7) DEPARTMENT.—The term "Department"
 2 means the Department of Education.
 - (8) Development.—The term "development" means the systematic use of knowledge or understanding gained from the findings of scientifically valid research and the shaping of that knowledge or understanding into products or processes that can be applied and evaluated and may prove useful in areas such as the preparation of materials and new methods of instruction and practices in teaching, that lead to the improvement of the academic skills of students, and that are replicable in different educational settings.
 - (9) DIRECTOR.—The term "Director" means the Director of the Institute of Education Sciences.
 - (10) DISSEMINATION.—The term "dissemination" means the communication and transfer of the results of scientifically valid research, statistics, and evaluations, in forms that are understandable, easily accessible, and usable, or adaptable for use in, the improvement of educational practice by teachers, administrators, librarians, other practitioners, researchers, parents, policymakers, and the public, through technical assistance, publications, electronic transfer, and other means.

- 1 (11)EARLY CHILDHOOD EDUCATOR.—The 2 term "early childhood educator" means a person 3 providing, or employed by a provider of, nonresiden-4 tial child care services (including center-based, fam-5 ily-based, and in-home child care services) that is le-6 gally operating under State law, and that complies 7 with applicable State and local requirements for the 8 provision of child care services to children at any age 9 from birth through the age at which a child may 10 start kindergarten in that State.
 - (12) FIELD-INITIATED RESEARCH.—The term "field-initiated research" means basic research or applied research in which specific questions and methods of study are generated by investigators (including teachers and other practitioners) and that conforms to standards of scientifically valid research.
 - (13) HISTORICALLY BLACK COLLEGE OR UNI-VERSITY.—The term "historically Black college or university" means a part B institution as defined in section 322 of the Higher Education Act of 1965 (20 U.S.C. 1061).
 - (14) Institute.—The term "Institute" means the Institute of Education Sciences established under section 111.

1	(15) Institution of higher education.—
2	The term "institution of higher education" has the
3	meaning given that term in section 101(a) of the
4	Higher Education Act of 1965 (20 U.S.C. 1001(a)).
5	(16) National research and development
6	CENTER.—The term "national research and develop-
7	ment center" means a research and development
8	center supported under section 133(c).
9	(17) Provider of Early Childhood Serv-
10	ICES.—The term "provider of early childhood serv-
11	ices" means a public or private entity that serves
12	young children, including—
13	(A) child care providers;
14	(B) Head Start agencies operating Head
15	Start programs, and entities carrying out Early
16	Head Start programs, under the Head Start
17	Act (42 U.S.C. 9831 et seq.);
18	(C) preschools;
19	(D) kindergartens; and
20	(E) libraries.
21	(18) Scientifically based research
22	STANDARDS.—(A) The term "scientifically based re-
23	search standards' means research standards that—
24	(i) apply rigorous, systematic, and objec-
25	tive methodology to obtain reliable and valid

1	knowledge relevant to education activities and
2	programs; and
3	(ii) present findings and make claims that
4	are appropriate to and supported by the meth-
5	ods that have been employed.
6	(B) The term includes, appropriate to the re-
7	search being conducted—
8	(i) employing systematic, empirical meth-
9	ods that draw on observation or experiment;
10	(ii) involving data analyses that are ade-
11	quate to support the general findings;
12	(iii) relying on measurements or observa-
13	tional methods that provide reliable data;
14	(iv) making claims of causal relationships
15	only in random assignment experiments or
16	other designs (to the extent such designs sub-
17	stantially eliminate plausible competing expla-
18	nations for the obtained results);
19	(v) ensuring that studies and methods are
20	presented in sufficient detail and clarity to
21	allow for replication or, at a minimum, to offer
22	the opportunity to build systematically on the
23	findings of the research;
24	(vi) obtaining acceptance by a peer-re-
25	viewed journal or approval by a panel of inde-

1	pendent experts through a comparably rigorous,
2	objective, and scientific review; and
3	(vii) using research designs and methods
4	appropriate to the research question posed.
5	(19) Scientifically valid education eval-
6	UATION.—The term "scientifically valid education
7	evaluation" means an evaluation that—
8	(A) adheres to the highest possible stand-
9	ards of quality with respect to research design
10	and statistical analysis;
11	(B) provides an adequate description of the
12	programs evaluated and, to the extent possible,
13	examines the relationship between program im-
14	plementation and program impacts;
15	(C) provides an analysis of the results
16	achieved by the program with respect to its pro-
17	jected effects;
18	(D) employs experimental designs using
19	random assignment, when feasible, and other
20	research methodologies that allow for the
21	strongest possible causal inferences when ran-
22	dom assignment is not feasible; and
23	(E) may study program implementation
24	through a combination of scientifically valid and
25	reliable methods.

1	(20) Scientifically valid research.—The
2	term "scientifically valid research" includes applied
3	research, basic research, and field-initiated research
4	in which the rationale, design, and interpretation are
5	soundly developed in accordance with scientifically
6	based research standards.
7	(21) Secretary.—The term "Secretary"
8	means the Secretary of Education.
9	(22) State.—The term "State" includes (ex-
10	cept as provided in section 158) each of the 50
11	States, the District of Columbia, the Commonwealth
12	of Puerto Rico, the freely associated states, and the
13	outlying areas.
14	(23) TECHNICAL ASSISTANCE.—The term
15	"technical assistance" means—
16	(A) assistance in identifying, selecting, or
17	designing solutions based on research, including
18	professional development and high-quality train-
19	ing to implement solutions leading to—
20	(i) improved educational and other
21	practices and classroom instruction based
22	on scientifically valid research; and
23	(ii) improved planning, design, and
24	administration of programs;

1	(B) assistance in interpreting, analyzing,
2	and utilizing statistics and evaluations; and
3	(C) other assistance necessary to encour-
4	age the improvement of teaching and learning
5	through the applications of techniques sup-
6	ported by scientifically valid research.
7	PART A—THE INSTITUTE OF EDUCATION
8	SCIENCES
9	SEC. 111. ESTABLISHMENT.
10	(a) Establishment.—There shall be in the Depart-
11	ment the Institute of Education Sciences, to be adminis-
12	tered by a Director (as described in section 114) and, to
13	the extent set forth in section 116, a board of directors.
14	(b) Mission.—
15	(1) In general.—The mission of the Institute
16	is to provide national leadership in expanding funda-
17	mental knowledge and understanding of education
18	from early childhood through postsecondary study,
19	in order to provide parents, educators, students, re-
20	searchers, policymakers, and the general public with
21	reliable information about—
22	(A) the condition and progress of edu-
23	cation in the United States, including early
24	childhood education;

1	(B) educational practices that support
2	learning and improve academic achievement and
3	access to educational opportunities for all stu-
4	dents; and
5	(C) the effectiveness of Federal and other
6	education programs.
7	(2) Carrying out mission.—In carrying out
8	the mission described in paragraph (1), the Institute
9	shall compile statistics, develop products, and con-
10	duct research, evaluations, and wide dissemination
11	activities in areas of demonstrated national need (in-
12	cluding in technology areas) that are supported by
13	Federal funds appropriated to the Institute and en-
14	sure that such activities—
15	(A) conform to high standards of quality,
16	integrity, and accuracy; and
17	(B) are objective, secular, neutral, and
18	nonideological and are free of partisan political
19	influence and racial, cultural, gender, or re-
20	gional bias.
21	(c) Organization.—The Institute shall consist of
22	the following:
23	(1) The Office of the Director (as described in
24	section 114).

1	(2) The National Board for Education Sciences
2	(as described in section 116).
3	(3) The National Education Centers, which
4	include—
5	(A) the National Center for Education Re-
6	search (as described in part B);
7	(B) the National Center for Education
8	Statistics (as described in part C); and
9	(C) the National Center for Education
10	Evaluation and Regional Assistance (as de-
11	scribed in part D).
12	SEC. 112. FUNCTIONS.
13	From funds appropriated under section 194, the In-
14	stitute, directly or through grants, contracts, or coopera-
15	tive agreements, shall—
16	(1) conduct and support scientifically valid re-
17	search activities, including basic research and ap-
18	plied research, statistics activities, scientifically valid
19	education evaluation, development, and wide dissemi-
20	nation;
21	(2) widely disseminate the findings and results
22	of scientifically valid research in education;
23	(3) promote the use, development, and applica-
24	tion of knowledge gained from scientifically valid re-
25	search activities;

- (4) strengthen the national capacity to conduct,
 develop, and widely disseminate scientifically valid
 research in education;
- 4 (5) promote the coordination, development, and 5 dissemination of scientifically valid research in edu-6 cation within the Department and the Federal Gov-7 ernment; and
- 8 (6) promote the use and application of research
 9 and development to improve practice in the class10 room.

11 SEC. 113. DELEGATION.

- 12 (a) Delegation of Authority.—Notwithstanding
- 13 section 412 of the Department of Education Organization
- 14 Act (20 U.S.C. 3472), the Secretary shall delegate to the
- 15 Director all functions for carrying out this title (other
- 16 than administrative and support functions), except that—
- 17 (1) nothing in this title or in the National As-
- sessment of Educational Progress Authorization Act
- 19 (except section 302(e)(1)(J) of such Act) shall be
- 20 construed to alter or diminish the role, responsibil-
- 21 ities, or authority of the National Assessment Gov-
- erning Board with respect to the National Assess-
- 23 ment of Educational Progress (including with re-
- spect to the methodologies of the National Assess-
- 25 ment of Educational Progress described in section

1	302(e)(1)(E)) from those authorized by the National
2	Education Statistics Act of 1994 (20 U.S.C. 9001 et
3	seq.) on the day before the date of enactment of this
4	Act;
5	(2) members of the National Assessment Gov-
6	erning Board shall continue to be appointed by the
7	Secretary;
8	(3) section 302(f)(1) of the National Assess-
9	ment of Educational Progress Authorization Act
10	shall apply to the National Assessment Governing
11	Board in the exercise of its responsibilities under
12	this Act;
13	(4) sections 115 and 116 shall not apply to the
14	National Assessment of Educational Progress; and
15	(5) sections 115 and 116 shall not apply to the
16	National Assessment Governing Board.
17	(b) Other Activities.—The Secretary may assign
18	the Institute responsibility for administering other activi-
19	ties, if those activities are consistent with—
20	(1) the Institute's priorities, as approved by the
21	National Board for Education Sciences under sec-
22	tion 116, and the Institute's mission, as described in
23	section 111(b); or
24	(2) the Institute's mission, but only if those ac-
25	tivities do not divert the Institute from its priorities.

SEC. 114. OFFICE OF THE DIRECTOR.

- 2 (a) Appointment.—Except as provided in sub-
- 3 section (b)(2), the President, by and with the advice and
- 4 consent of the Senate, shall appoint the Director of the
- 5 Institute.
- 6 (b) TERM.—
- 7 (1) In general.—The Director shall serve for
- 8 a term of 6 years, beginning on the date of appoint-
- 9 ment of the Director.
- 10 (2) FIRST DIRECTOR.—The President, without
- the advice and consent of the Senate, may appoint
- the Assistant Secretary for the Office of Educational
- Research and Improvement (as such office existed
- on the day before the date of enactment of this Act)
- to serve as the first Director of the Institute.
- 16 (3) Subsequent directors.—The Board may
- make recommendations to the President with respect
- to the appointment of a Director under subsection
- 19 (a), other than a Director appointed under para-
- 20 graph (2).
- 21 (c) PAY.—The Director shall receive the rate of basic
- 22 pay for level II of the Executive Schedule.
- 23 (d) QUALIFICATIONS.—The Director shall be selected
- 24 from individuals who are highly qualified authorities in the
- 25 fields of scientifically valid research, statistics, or evalua-
- 26 tion in education, as well as management within such

1	areas, and have a demonstrated capacity for sustained
2	productivity and leadership in these areas.
3	(e) Administration.—The Director shall—
4	(1) administer, oversee, and coordinate the ac-
5	tivities carried out under the Institute, including the
6	activities of the National Education Centers; and
7	(2) coordinate and approve budgets and oper-
8	ating plans for each of the National Education Cen-
9	ters for submission to the Secretary.
10	(f) Duties.—The duties of the Director shall include
11	the following:
12	(1) To propose to the Board priorities for the
13	Institute, in accordance with section 115(a).
14	(2) To ensure the methodology applied in con-
15	ducting research, development, evaluation, and sta-
16	tistical analysis is consistent with the standards for
17	such activities under this title.
18	(3) To coordinate education research and re-
19	lated activities carried out by the Institute with such
20	research and activities carried out by other agencies
21	within the Department and the Federal Government.
22	(4) To advise the Secretary on research, evalua-
23	tion, and statistics activities relevant to the activities
24	of the Department.

- 1 (5) To establish necessary procedures for tech-2 nical and scientific peer review of the activities of 3 the Institute, consistent with section 116(b)(3).
 - (6) To ensure that all participants in research conducted or supported by the Institute are afforded their privacy rights and other relevant protections as research subjects, in accordance with section 183 of this title, section 552a of title 5, United States Code, and sections 444 and 445 of the General Education Provisions Act (20 U.S.C. 1232g, 1232h).
 - (7) To ensure that activities conducted or supported by the Institute are objective, secular, neutral, and nonideological and are free of partial political influence and racial, cultural, gender, or regional bias.
 - (8) To undertake initiatives and programs to increase the participation of researchers and institutions that have been historically underutilized in Federal education research activities of the Institute, including historically Black colleges or universities or other institutions of higher education with large numbers of minority students.
 - (9) To coordinate with the Secretary to promote and provide for the coordination of research and development activities and technical assistance activi-

- ties between the Institute and comprehensive centers.
- (10) To solicit and consider the recommendations of education stakeholders, in order to ensure that there is broad and regular public and professional input from the educational field in the planning and carrying out of the Institute's activities.
- 8 (11) To coordinate the wide dissemination of 9 information on scientifically valid research.
- 10 (12) To carry out and support other activities 11 consistent with the priorities and mission of the In-12 stitute.
- 13 (g) Expert Guidance and Assistance.—The Director may establish technical and scientific peer-review 14 15 groups and scientific program advisory committees for research and evaluations that the Director determines are 16 17 necessary to carry out the requirements of this title. The Director shall appoint such personnel, except that officers 18 19 and employees of the United States shall comprise no 20 more than ½ of the members of any such group or com-21 mittee and shall not receive additional compensation for their service as members of such a group or committee. 23 The Director shall ensure that reviewers are highly qualified and capable to appraise education research and devel-

opment projects. The Federal Advisory Committee Act (5

- 1 U.S.C. App.) shall not apply to a peer-review group or
- 2 an advisory committee established under this subsection.
- 3 (h) Review.—The Director may, when requested by
- 4 other officers of the Department, and shall, when directed
- 5 by the Secretary, review the products and publications of
- 6 other offices of the Department to certify that evidence-
- 7 based claims about those products and publications are
- 8 scientifically valid.

9 SEC. 115. PRIORITIES.

- 10 (a) Proposal.—The Director shall propose to the
- 11 Board priorities for the Institute (taking into consider-
- 12 ation long-term research and development on core issues
- 13 conducted through the national research and development
- 14 centers). The Director shall identify topics that may re-
- 15 quire long-term research and topics that are focused on
- 16 understanding and solving particular education problems
- 17 and issues, including those associated with the goals and
- 18 requirements established in the Elementary and Sec-
- 19 ondary Education Act of 1965 (20 U.S.C. 6301 et seq.)
- 20 and the Higher Education Act of 1965 (20 U.S.C. 1001
- 21 et seq.), such as—
- 22 (1) closing the achievement gap between high-
- performing and low-performing children, especially
- 24 achievement gaps between minority and nonminority

children and between disadvantaged children and 1 2 such children's more advantaged peers; and 3 (2) ensuring— (A) that all children have the ability to obtain a high-quality education (from early child-6 hood through postsecondary education) and 7 reach, at a minimum, proficiency on challenging 8 State academic achievement standards and 9 academic assessments, particularly in 10 mathematics, science, and reading or language 11 arts; 12 (B) access to, and opportunities for, post-13 secondary education; and 14 (C) the efficacy, impact on academic 15 achievement, and cost-effectiveness of tech-16 nology use within the Nation's schools. 17 (b) APPROVAL.—The Board shall approve or disapprove the priorities for the Institute proposed by the Di-18 rector, including any necessary revision of those priorities. 19 The Board shall transmit any priorities so approved to 20 21 the appropriate congressional committees. 22 (c) Consistency.—The Board shall ensure that pri-23 orities of the Institute and the National Education Centers are consistent with the mission of the Institute. 25 (d) Public Availability and Comment.—

- 1 Priorities.—Before submitting to 2 Board proposed priorities for the Institute, the Di-3 rector shall make such priorities available to the public for comment for not less than 60 days (in-5 cluding by means of the Internet and through pub-6 lishing such priorities in the Federal Register). The 7 Director shall provide to the Board a copy of each 8 such comment submitted. 9 (2) Plan.—Upon approval of such priorities, 10 the Director shall make the Institute's plan for ad-11 dressing such priorities available for public comment 12 in the same manner as under paragraph (1). SEC. 116. NATIONAL BOARD FOR EDUCATION SCIENCES. 13 (a) Establishment.—The Institute shall have a 14 15 board of directors, which shall be known as the National Board for Education Sciences. 16
- 17 (b) Duties.—The duties of the Board shall be the 18 following:
- 19 (1) To advise and consult with the Director on 20 the policies of the Institute.
- 21 (2) To consider and approve priorities proposed 22 by the Director under section 115 to guide the work 23 of the Institute.

1	(3) To review and approve procedures for tech-
2	nical and scientific peer review of the activities of
3	the Institute.
4	(4) To advise the Director on the establishment
5	of activities to be supported by the Institute, includ-
6	ing the general areas of research to be carried out
7	by the National Center for Education Research.
8	(5) To present to the Director such rec-
9	ommendations as it may find appropriate for—
10	(A) the strengthening of education re-
11	search; and
12	(B) the funding of the Institute.
13	(6) To advise the Director on the funding of
14	applications for grants, contracts, and cooperative
15	agreements for research, after the completion of peer
16	review.
17	(7) To review and regularly evaluate the work
18	of the Institute, to ensure that scientifically valid re-
19	search, development, evaluation, and statistical anal-
20	ysis are consistent with the standards for such ac-
21	tivities under this title.
22	(8) To advise the Director on ensuring that ac-
23	tivities conducted or supported by the Institute are

objective, secular, neutral, and nonideological and

- are free of partisan political influence and racial,
 cultural, gender, or regional bias.
- (9) To solicit advice and information from those in the educational field, particularly practitioners and researchers, to recommend to the Director topics that require long-term, sustained, systematic, programmatic, and integrated research efforts, including knowledge utilization and wide dissemination of research, consistent with the priorities and mission of the Institute.
 - (10) To advise the Director on opportunities for the participation in, and the advancement of, women, minorities, and persons with disabilities in education research, statistics, and evaluation activities of the Institute.
 - (11) To recommend to the Director ways to enhance strategic partnerships and collaborative efforts among other Federal and State research agencies.
 - (12) To recommend to the Director individuals to serve as Commissioners of the National Education Centers.

23 (1) VOTING MEMBERS.—The Board shall have 24 15 voting members appointed by the President, by 25 and with the advice and consent of the Senate.

1	(2) Advice.—The President shall solicit advice
2	regarding individuals to serve on the Board from the
3	National Academy of Sciences, the National Science

3	SEC. 203. COMPREHENSIVE CENTERS.
4	(a) Authorization.—
5	(1) In general.—Subject to paragraph (2),
6	beginning in fiscal year 2004, the Secretary is au-
7	thorized to award not less than 20 grants to local
8	entities, or consortia of such entities, with dem-
9	onstrated expertise in providing technical assistance
10	and professional development in reading, mathe-
11	matics, science, and technology, especially to low-
12	performing schools and districts, to establish com-
13	prehensive centers.
14	(2) Regions.—In awarding grants under para-
15	graph (1), the Secretary—
16	(A) shall ensure that not less than 1 com-
17	prehensive center is established in each of the
18	10 geographic regions served by the regional
19	educational laboratories established under sec-
20	tion 941(h) of the Educational Research, Devel-
21	opment, Dissemination, and Improvement Act
22	of 1994 (as such provision existed on the day
23	before the date of enactment of this Act); and
24	(B) after meeting the requirements of sub-
25	paragraph (A), shall consider, in awarding the

remainder of the grants, the school-age population, proportion of economically disadvantaged students, the increased cost burdens of service delivery in areas of sparse population, and the number of schools identified for school improvement (as described in section 1116(b) of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 6316(b)) in the population served by the local entity or consortium of such entities.

(b) ELIGIBLE APPLICANTS.—

(1) In General.—Grants under this section may be made with research organizations, institutions, agencies, institutions of higher education, or partnerships among such entities, or individuals, with the demonstrated ability or capacity to carry out the activities described in subsection (f), including regional entities that carried out activities under the Educational Research, Development, Dissemination, and Improvement Act of 1994 (as such Act existed on the day before the date of enactment of this Act) and title XIII of the Elementary and Secondary Education Act of 1965 (as such title existed on the day before the date of enactment of the No Child Left Behind Act of 2001 (Public Law 107–110)).

- (2) Outreach.—In conducting competitions for grants under this section, the Secretary shall actively encourage potential applicants to compete for such awards by making widely available information and technical assistance relating to the competition.
 - (3) Objectives and indicators.—Before awarding a grant under this section, the Secretary shall design specific objectives and measurable indicators, using the results of the assessment conducted under section 206, to be used to assess the particular programs or initiatives, and ongoing progress and performance, of the regional entities, in order to ensure that the educational needs of the region are being met and that the latest and best research and proven practices are being carried out as part of school improvement efforts.

(c) APPLICATION.—

- (1) Submission.—Each local entity, or consortium of such entities, seeking a grant under this section shall submit an application at such time, in such manner, and containing such additional information as the Secretary may reasonably require.
- (2) PLAN.—Each application submitted under paragraph (1) shall contain a 5-year plan for carrying out the activities described in this section in

- 1 a manner that addresses the priorities established
- 2 under section 207 and addresses the needs of all
- 3 States (and to the extent practicable, of local edu-
- 4 cational agencies) within the region to be served by
- 5 the comprehensive center, on an ongoing basis.
- 6 (d) Allocation.—Each comprehensive center estab-
- 7 lished under this section shall allocate such center's re-
- 8 sources to and within each State in a manner which re-
- 9 flects the need for assistance, taking into account such
- 10 factors as the proportion of economically disadvantaged
- 11 students, the increased cost burden of service delivery in
- 12 areas of sparse populations, and any special initiatives
- 13 being undertaken by State, intermediate, local educational
- 14 agencies, or Bureau-funded schools, as appropriate, which
- 15 may require special assistance from the center.
- 16 (e) Scope of Work.—Each comprehensive center
- 17 established under this section shall work with State edu-
- 18 cational agencies, local educational agencies, regional edu-
- 19 cational agencies, and schools in the region where such
- 20 center is located on school improvement activities that
- 21 take into account factors such as the proportion of eco-
- 22 nomically disadvantaged students in the region, and give
- 23 priority to—
- 24 (1) schools in the region with high percentages
- or numbers of students from low-income families, as

1	determined under section 1113(a)(5) of the Elemen-
2	tary and Secondary Education Act of 1965 (20
3	U.S.C. 6313(a)(5)), including such schools in rural
4	and urban areas, and schools receiving assistance

12	agencies in rural and urban areas; and
13	(3) schools in the region that have been identi-
14	fied for school improvement under section 1116(b)
15	of the Elementary and Secondary Education Act of

17	(f) ACTIVITIES.—
18	(1) In general.—A comprehensive center es-
19	tablished under this section shall support dissemina-
20	tion and technical assistance activities by—
21	(A) providing training, professional devel-
22	opment, and technical assistance regarding, at
23	a minimum—
24	(i) the administration and implemen-
25	tation of programs under the Elementary

1	and Secondary Education Act of 1965 (20
2	U.S.C. 6301 et seq.);
3	(ii) the use of scientifically valid
4	teaching methods and assessment tools for
5	use by teachers and administrators in, at
6	a minimum—

12	(III) education technology; and
13	(iii) the facilitation of communication
14	between education experts, school officials,
15	teachers, parents, and librarians, as appro-
16	priate; and
17	(B) disseminating and providing informa-
18	tion, reports, and publications that are usable
19	for improving academic achievement, closing
20	achievement gaps, and encouraging and sus-
21	taining school improvement (as described in
22	section 1116(b) of the Elementary and Sec-
23	ondary Education Act of 1965 (20 U.S.C.
24	6316(b))), to schools, educators, parents, and

1	policymakers within the region in which the
2	center is located; and
3	(C) developing teacher and school leader
4	inservice and preservice training models that il-
5	lustrate best practices in the use of technology
6	in different content areas.
7	(2) Coordination and collaboration.—
8	Each comprehensive center established under this
9	section shall coordinate its activities, collaborate
10	and regularly exchange information with the regional
11	educational laboratory in the region in which the
12	center is located, the National Center for Education
13	Evaluation and Regional Assistance, the Office of
14	the Secretary, the State service agency, and other
15	technical assistance providers in the region.
16	(g) Comprehensive Center Advisory Board.—
17	(1) ESTABLISHMENT.—Each comprehensive
18	center established under this section shall have an
19	advisory board that shall support the priorities of
20	such center.
21	(2) Duties.—Each advisory board established
22	under paragraph (1) shall advise the comprehensive
23	center—
24	(A) concerning the activities described in
25	subsection (d);

1	(B) on strategies for monitoring and ad-
2	dressing the educational needs of the region, on
3	an ongoing basis;
4	(C) on maintaining a high standard of
5	quality in the performance of the center's ac-
6	tivities; and
7	(D) on carrying out the center's duties in
8	a manner that promotes progress toward im-
9	proving student academic achievement.
10	(3) Composition.—
11	(A) IN GENERAL.—Each advisory board
12	shall be composed of—
