## 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "California Missions" 3 Preservation Act of 2002". SEC. 2. FINDINGS. 4 5 Congress finds the following: (1) The California missions represent some of 6 7 our Nation's oldest historical treasures. 8 (2) The first of the California missions was 9 founded in 1769, and eventually a chain of 21 mis-10 sions and various sub-missions extended along the 11 coast of California on El Camino Real. 12 (3) The California missions contribute greatly 13 to the rich historical, cultural, and architectural her-14 itage of California and the American West. 15 (4) The knowledge and cultural influence of na-16 tive California Indians made a lasting contribution 17 to the early settlement of Califonia and the develop-18 ment of the California's missions. 19 (5) More than 5,300,000 people visit the Cali-20 fornia missions annually, and the historical impor-21 tance of the California missions extends worldwide 22 as they have become a frequent destination for for-23 eign visitors to the United States. 24 (6) The history of the California missions is an 25 important educational component in California 26 schools, and the study of the California missions is

part of the Statewide fourth grade curricula on Cali fornia history.

3 (7) Restoration and repair of the California 4 missions, and the preservation of the Spanish colonial and mission-era artworks and artifacts of the 5 6 California missions, for the public enjoyment will en-7 sure that future generations also have the benefit of 8 experiencing and appreciating these great symbols of 9 the spirit of exploration and discovery in the Amer-10 ican West. 11 SEC. 3. SUPPORT FOR THE RESTORATION AND PRESERVA-12 TION OF THE CALIFORNIA MISSIONS. 13 (a) DEFINITIONS.—In this section: 14 (1) CALIFORNIA MISSIONS.—The term "California missions" means the following historic Span-15 16 ish missions located in the State of California and 17 designated as California Registered Historical Land-18 marks: 19  $(\mathbf{A})$ Mission La Purisima Concepcion, 20 Lompoc. 21 (B) Mission La Soledad, Soledad. 22 (C) Mission San Antonio de Padua, Jolon. 23 (D) Mission San Buenaventura, Ventura. 24 (E) Mission San Carlos Borromeo del Rio 25 Carmelo, Carmel.

7	(2) California missions foundation.—The
8	term "California Missions Foundation" means the
9	charitable corporation established in the State of
10	California in 1998 to fund the restoration and repair
11	of the California missions and the preservation of
12	the Spanish colonial and mission-era artworks and
13	artifacts of the California missions. The Foundation
14	is exempt from State franchise and income tax and
15	is organized and operated exclusively for charitable
16	purposes under section $501(c)(3)$ of the Internal
17	Revenue Code of 1986.
18	(3) Secretary.—The term "Secretary" means
19	the Secretary of the Interior.
20	(b) GRANTS AUTHORIZED.—The Secretary of the In-
21	terior may make grants to the California Missions Foun-

(b) GRANTS AUTHORIZED.—The Secretary of the Interior may make grants to the California Missions Foundation to support the efforts of the California Missions
Foundation to restore and repair the California missions
and to preserve the artworks and artifacts associated with
the California missions. As provided in section 101(e)(4)

of the National Historic Preservation Act (16 U.S.C.
 470a(e)(4)), the Secretary shall ensure that the purpose
 of a grant under this section is secular, does not promote
 religion, and seeks to protect those qualities that are his torically significant.

6 (c) APPLICATION.—In order to receive a grant under
7 this section for the preservation of the California missions,
8 the California Missions Foundation shall submit to the
9 Secretary an application that includes—

10 (1) a status report on the condition of the in11 frastructure and artifacts for each of the California
12 missions; and

(2) a comprehensive program for restoration,
repair, and preservation of such infrastructure and
artifacts, including prioritized preservation efforts to
be conducted over a 5-year period and the estimated
costs of such preservation efforts.

(d) MATCHING FUND REQUIREMENT.—The Secretary shall require the California Missions Foundation to
match grant funds provided under this section.

(e) REPORT.—As a condition of a grant under this
section, the California Missions Foundation shall submit
to the Secretary an annual report on the status of the
preservation efforts undertaken using grant funds pro-

vided under this section. The Secretary shall submit a
 copy of each report to Congress.

3 (f) AUTHORIZATION OF APPROPRIATIONS.—There is authorized to be appropriated to the Secretary a total of 4 5 \$10,000,000 during the five-fiscal year period beginning October 1, 2003, to make grants under this section. Funds 6 7 appropriated pursuant to the authorization of appropriations in this section shall be in addition to any funds made 8 available for preservation efforts in the State of California 9 under the National Historic Preservation Act. 10
