A BILL

To protect children from foods that pose a significant choking hazard.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Food Choking Preven-
- 5 tion Act of 2002".
- 6 SEC. 2. OFFICE OF CHOKING HAZARD EVALUATION.
- 7 (a) In General.—An Office of Choking Hazard
- 8 Evaluation (referred to in this Act as the "Office") shall
- 9 be established by the Food and Drug Administration in

- 1 collaboration with the Consumer Product Safety Commis-
- 2 sion.
- 3 (b) WARNING LABELS.—The Office shall have the
- 4 authority to require warning labels on food products pri-
- 5 marily consumed by children that pose a demonstrably
- 6 high choking risk to children.
- 7 (c) Recall Authority.—The Office shall have
- 8 mandatory recall authority of food products that the Of-
- 9 fice determines pose a significant and unacceptable chok-
- 10 ing hazard to the general public.
- 11 SEC. 3. INTERAGENCY TASK FORCE.
- 12 (a) Choking Hazard Evaluation Task Force.—
- 13 A Choking Hazard Evaluation Task Force (referred to in
- 14 this Act as the "Task Force") shall be established jointly
- 15 by the Food and Drug Administration and the Consumer
- 16 Product Safety Commission. The staff of the Task Force
- 17 shall be designated jointly by such agencies.
- 18 (b) Duties.—
- 19 (1) IN GENERAL.—The Task Force shall be re-
- sponsible for establishing criteria for determining
- 21 whether a food product poses a significant and unac-
- ceptable choking hazard.
- 23 (2) Age-specific criteria.—In carrying out
- paragraph (1), the Task Force shall establish age-
- differentiated criteria for choking hazards.

- 1 (3) Public comment.—There shall be a 90-
- 2 day public comment period after the criteria under
- 3 paragraph (1) are announced by the Task Force.

4 SEC. 4. DATABASE OF COMPLAINTS.

- 5 The Food and Drug Administration shall establish a
- 6 national database of unusual food choking incidents. The
- 7 Food and Drug Administration shall provide for an ade-
- 8 quate reporting system throughout its field offices, which
- 9 members of the health care profession and the general
- 10 public can readily access to report new incidents.

11 SEC. 5. REPORTS TO CONGRESS.

- 12 The Food and Drug Administration shall regularly
- 13 submit reports to the Committee on Health, Education,
- 14 Labor, and Pensions of the Senate and the Committee on
- 15 Energy and Commerce of the House of Representatives
- 16 regarding the implementation of this Act.
