7 The Secretary of the Interior and the Secretary of
8 Agriculture may use funds appropriated for wildland fire

10 lated Agencies Appropriations Act, 2001 (Public Law
11 106–291; 114 Stat. 922), to reimburse the United States
12 Fish and Wildlife Service and the National Marine Fish-
13 eries Service for the costs of carrying out their responsibil-

15 U.S.C. 1531 et seq.) to consult and conference, as re-
