Mr. HORN (for himself, Mr. BURTON of Indiana, Mr. BALLENGER, and Mr. MICA) introduced the following bill; which was referred to the Committee on Government Reform

A BILL

To establish an Office of Management in the Executive Office of the President, and to redesignate the Office of Management and Budget as the Office of the Federal Budget.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION. 1. ESTABLISHMENT OF OFFICE OF MANAGE-**
4 **MENT.**

5 (a) ESTABLISHMENT.—There is hereby established in
6 the Executive Office of the President the Office of Man-
7 agement, the purpose of which shall be to improve Federal
8 management and organization and to promote efficiency

1 and effectiveness in the operation of the Federal Govern-
2 ment.

3 (b) DIRECTOR; DEPUTY DIRECTOR.—(1) There shall
4 be at the head of the Office of Management a Director,
5 who shall be appointed by the President by and with the
6 advice and consent of the Senate. The Director shall be
7 compensated at the annual rate of basic pay for Executive
8 level I as provided in section 5312 of title 5, United States
9 Code.

10 (2) There shall be a Deputy Director of the Office
11 of Management, who shall be appointed by the President
12 by and with the advice and consent of the Senate. The
13 Deputy Director shall be compensated at the annual rate
14 of basic pay for Executive level II as provided in section
15 5313 of title 5, United States Code.

16 (c) TRANSFER OF AUTHORITY AND FUNCTIONS.—(1)
17 The following offices in the Office of Management and
18 Budget are abolished, and the functions and authorities
19 of the heads of such offices are hereby transferred to the
20 Director of the Office of Management:

21 (1) The Office of Federal Procurement Policy.

22 (2) The Office of Information and Regulatory
23 Affairs.

24 (3) The Office of Federal Financial Manage-
25 ment.

1 (4) The Office of the Deputy Director for Man-
2 agement.

3 (5) The Office of the Chief Financial Officer.

4 **SEC. 2. REDESIGNATION OF OFFICE OF MANAGEMENT AND**
5 **BUDGET.**

6 The Office of Management and Budget is hereby re-
7 designated as the Office of the Federal Budget. Any au-
8 thorities of, and functions performed by, the Director and
9 other officers and appointees of the Office of Management
10 and Budget before the date of the enactment of this Act
11 and not transferred under section 1 shall remain the au-
12 thorities and functions of the Director as the head of the
13 Office of the Federal Budget and such other officers and
14 appointees as appropriate.

15 **SEC. 3. CONFORMING AMENDMENTS TO OTHER LAWS.**

16 Not later than 90 days after the date of the enact-
17 ment of this Act, the President shall submit to Congress
18 recommendations for any conforming amendments nec-
19 essary to carry out the purposes of this Act.
