- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Strengthening Science
- 3 at the Environmental Protection Agency Act".
- 4 SEC. 2. DEFINITIONS.
- 5 For purposes of this Act—
- 6 (1) the term "Administrator" means the Ad-
- 7 ministrator of the Agency;
- 8 (2) the term "Agency" means the Environ-
- 9 mental Protection Agency;
- 10 (3) the term "Deputy" means the Deputy Ad-
- 11 ministrator for Science and Technology appointed
- under section 4; and
- 13 (4) the term "research" means research, devel-
- opment, and demonstration.
- 15 SEC. 3. RESEARCH MISSION OF AGENCY.
- 16 Conducting, sponsoring, and evaluating environ-
- 17 mental science and technology research shall be a central
- 18 mission of the Agency. The results of such research shall
- 19 be used to help initiate, formulate, and carry out the
- 20 Agency's agenda, and the Agency shall seek to increase
- 21 the public's understanding of environmental science and
- 22 technology by making those research results available to
- 23 the public.
- 24 **SEC. 4. DEPUTY.**
- 25 (a) APPOINTMENT.—The President shall appoint, by
- 26 and with the advice and consent of the Senate, a Deputy

Administrator for Science and Technology, who shall co-2 ordinate and oversee the science and technology activities 3 of the Agency and ensure that Agency decisions are in-4 formed by the results of appropriate and relevant re-5 search. 6 (b) RESPONSIBILITIES.—The Deputy shall— 7 (1) provide advice to the Administrator regard-8 ing science and technology issues and their relation-9 ship to Agency policies, procedures, and decisions; 10 (2) participate in developing the Agency's stra-11 tegic plans and policies and review the science and 12 technology aspects of those plans and policies; 13 (3) coordinate the acquisition and compilation 14 of relevant science and technology information avail-15 able from academic sources, government agencies, 16 and the private sector; 17 (4) develop and oversee guidelines for the dis-18 semination of research results conducted, sponsored, 19 or cited by the Agency to the public, including his-

- 1 (c) QUALIFICATIONS.—An individual appointed
- 2 under subsection (a) shall be a person who has an out-

- 6 (d) Consultation.—Before appointing an indi-
- 7 vidual under subsection (a), the President shall consult
- 8 with the National Academy of Sciences, the National

- 11 (e) Compensation.—The Deputy shall be com-
- 12 pensated at the rate provided for level III of the Executive
- 13 Schedule pursuant to section 5314 of title 5, United
- 14 States Code.
- 15 (f) Conforming Amendment.—Section 5314 of
- 16 title 5, United States Code, is amended by adding at the
- 17 end the following:
- 18 "Deputy Administrator for Science and Tech-
- 19 nology of the Environmental Protection Agency.".
- 20 SEC. 5. ASSISTANT ADMINISTRATOR FOR RESEARCH AND
- 21 **DEVELOPMENT.**
- (a) TITLE AND TERM.—There shall be an Assistant
- 23 Administrator for Research and Development of the Agen-
- 24 cy, who shall also have the title of Chief Scientist of the
- 25 Agency. Appointments to such position made after the

- 1 date of the enactment of this Act shall be for a term of
- 2 5 years unless sooner removed by the President.
- 3 (b) QUALIFICATIONS.—An individual appointed
- 4 under subsection (a) shall be a person who has an out-
- 5 standing science and technology background, including re-
- 6 search accomplishments, scientific reputation, and experi-
- 7 ence in leading a research and development organization.
