## A BILL

To provide for the establishment of the position of Deputy

Administrator for Science and Technology of the Environmental Protection Agency, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Strengthening Science*  
 5 *at the Environmental Protection Agency Act”.*

6 **SEC. 2. DEFINITIONS.**

7 *For purposes of this Act—*

8 *(1) the term “Administrator” means the Admin-*  
 9 *istrator of the Agency;*

10 *(2) the term “Agency” means the Environmental*  
 11 *Protection Agency;*

12 *(3) the term “Deputy” means the Deputy Ad-*  
 13 *ministrator for Science and Technology appointed*  
 14 *under section 4; and*

15 *(4) the term “research” means research, develop-*  
 16 *ment, and demonstration.*

17 **SEC. 3. RESEARCH MISSION OF AGENCY.**

18 *Conducting, sponsoring, and evaluating environ-*  
 19 *mental science and technology research shall be a central*  
 20 *mission of the Agency. The results of such research shall*  
 21 *be used to help initiate, formulate, and carry out the Agen-*  
 22 *cy’s agenda, and the Agency shall seek to increase the*  
 23 *public’s understanding of environmental science and tech-*

1 nology by making those research results available to the  
2 public.

3 **SEC. 4. DEPUTY.**

4 (a) *APPOINTMENT.*—The President shall appoint, by  
5 and with the advice and consent of the Senate, a Deputy  
6 Administrator for Science and Technology, who shall co-  
7 ordinate and oversee the science and technology activities  
8 of the Agency and ensure that Agency decisions are in-  
9 formed by the results of appropriate and relevant research.

10 (b) *RESPONSIBILITIES.*—The Deputy shall—

11 (1) provide advice to the Administrator regard-  
12 ing science and technology issues and their relation-  
13 ship to Agency policies, procedures, and decisions;

14 (2) participate in developing the Agency's stra-  
15 tegic plans and policies and review the science and  
16 technology aspects of those plans and policies;

17 (3) coordinate the acquisition and compilation of  
18 relevant science and technology information available  
19 from academic sources, government agencies, and the  
20 private sector;

21 (4) develop and oversee guidelines for the dis-  
22 semination of research results conducted, sponsored,  
23 or cited by the Agency to the public, including his-  
24 torically black colleges and universities, Hispanic-

1       *serving institutions, minority communities, and rural*  
2       *communities; and*

3               *(5) develop and oversee guidelines for peer review*  
4       *of science and technology research.*

5       *(c) QUALIFICATIONS.—An individual appointed under*  
6       *subsection (a) shall be a person who has an outstanding*  
7       *science and technology background, including research ac-*  
8       *complishments, scientific reputation, and public policy ex-*  
9       *perience.*

10       *(d) CONSULTATION.—Before appointing an individual*  
11       *under subsection (a), the President shall consult with the*  
12       *National Academy of Sciences, the National Academy of*  
13       *Engineering, the Science Advisory Board of the Agency,*  
14       *and other appropriate scientific organizations.*

15       *(e) COMPENSATION.—The Deputy shall be com-*  
16       *pensated at the rate provided for level III of the Executive*  
17       *Schedule pursuant to section 5314 of title 5, United States*  
18       *Code.*

19       *(f) CONFORMING AMENDMENT.—Section 5314 of title*  
20       *5, United States Code, is amended by adding at the end*  
21       *the following:*

22               *“Deputy Administrator for Science and Tech-*  
23       *nology of the Environmental Protection Agency.”.*

1 **SEC. 5. ASSISTANT ADMINISTRATOR FOR RESEARCH AND**  
2 **DEVELOPMENT.**

3       (a) *TITLE AND TERM.*—*There shall be an Assistant*  
4 *Administrator for Research and Development of the Agency,*  
5 *who shall also have the title of Chief Scientist of the Agency.*  
6 *Appointments to such position made after the date of the*  
7 *enactment of this Act shall be for a term of 5 years unless*  
8 *sooner removed by the President.*

9       (b) *QUALIFICATIONS.*—*An individual appointed under*  
10 *subsection (a) shall be a person who has an outstanding*  
11 *science and technology background, including research ac-*  
12 *complishments, scientific reputation, and experience in*  
13 *leading a research and development organization.*
